



DETAILS:

On August 28, 1975, efforts to locate and interview FOX at 5920 Osage Avenue, Hiladelphia, Pa., were met with negative results.

On September 4, 1975, Special Clerk 67 reviewed the records of the Miladelphia Board of Education regarding AARON FOX. These records revealed that FOX was the son of ROBERT and GLADYS FOX of 5920 Osage Avenue, Miladelphia, ra. FOX's date of birth is listed as August 18, 1944, and he last attended West Miladelphia High School in 1959. FOX was not listed as having graduated from high school in the Miladelphia area.

Un September 15, 1975, a review of the birth records of the Hiladelphia Bureau of Vital Statistics was made in order to verify the date of birth of AARON HRESTON FUX.

An employee of that agency advised they had no record of FOX being an eligible registered voter for the addresses of 5920 Osage Avenue, 5807 Market Street, or 5217 Whitby Street, Philadelphia, Pa.

On January 30, 1976, efforts to locate and interview FUX at 5920 Osage Avenue, Philadelphia, Pa., were negative.
