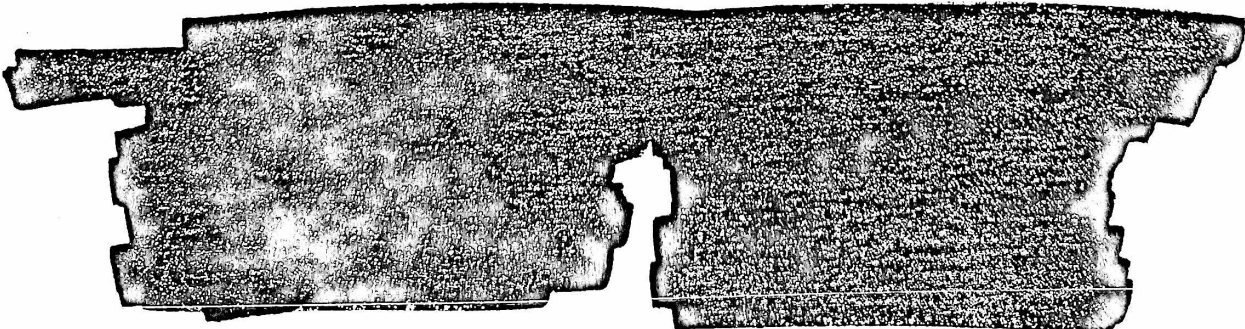
On April 23, 1975, and May 15, 1975, efforts to locate and interview AARON FOX at 5920 Osage Street, were negative.



DETAILS:

On August 28, 1975, efforts to locate and interview FOX at 5920 Osage Avenue, Philadelphia, Pa., were met with negative results.  *Refer to another Government agency*

 On September 4, 1975, Special Clerk  b7c reviewed the records of the Philadelphia Board of Education regarding AARON FOX. These records revealed that FOX was the son of ROBERT and GLADYS FOX of 5920 Osage Avenue, Philadelphia, Pa. FOX's date of birth is listed as August 18, 1944, and he last attended West Philadelphia High School in 1959. FOX was not listed as having graduated from high school in the Philadelphia area.

On September 15, 1975, a review of the birth records of the Philadelphia Bureau of Vital Statistics was made in order to verify the date of birth of AARON PRESTON FOX.

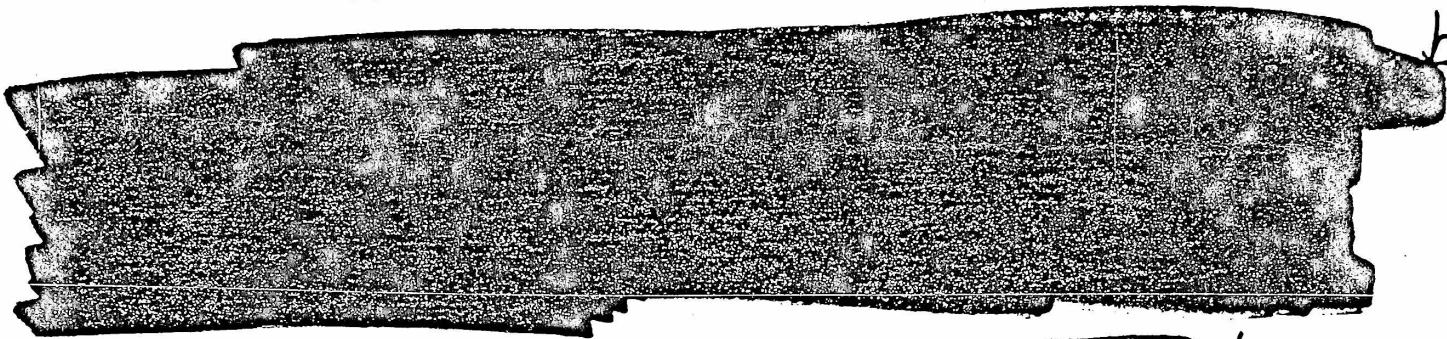

On November 24, 1975, Special Clerk [redacted] b7c [redacted], caused the records of the Philadelphia Bureau of Voters Registration to be searched regarding AARON PRESTON FOX, date of birth August 18, 1944, with negative results. An employee of that agency advised they had no record of FOX being an eligible registered voter for the addresses of 5920 Osage Avenue, 5807 Market Street, or 5217 Whitby Street, Philadelphia, Pa.

On January 30, 1976, efforts to locate and interview FOX at 5920 Osage Avenue, Philadelphia, Pa., were negative.
