Dear Mr. Miller:

Pursuant to the authorities set forth in House Resolution 503 and the rules of the House of Representatives, the Select Committee to Investigate the January 6th Attack on the United States Capitol ("Select Committee") hereby transmits a subpoena that compels you to produce the documents set forth in the accompanying schedule by November 23, 2021, and to appear for a deposition on December 10, 2021.

The Select Committee is investigating the facts, circumstances, and causes of the January 6th attack and issues relating to the peaceful transfer of power, in order to identify and evaluate lessons learned and to recommend to the House and its relevant committees corrective laws, policies, procedures, rules, or regulations.

The Select Committee's investigation and public accounts have revealed credible evidence of your involvement in the events within the scope of the Select Committee's inquiry. In your position as a senior advisor to former President Trump's 2020 re-election campaign, you regularly spread the claim that the November 2020 had been tainted by widespread fraud. Even before the election, you publicly claimed that Democrats would "steal" the election, a message that individuals who attacked the U.S. Capitol echoed on January 6 in an attempt to interfere with the peaceful and orderly transfer of power. After the election, you reportedly coordinated with Mr. Trump and Rudolph Giuliani to hold public press events to claim that the election was rigged. Additionally, according to public reports, you participated in a meeting on January 5, 2021, at the Willard Hotel in Washington, D.C., in which Mr. Giuliani, Stephen Bannon, and others met to discuss overturning the results of the November 2020 election by, among other things, pressuring Vice President Pence to not certify the electoral college results.
