SPO Gray, PFC Dalton and I were dispatched to the Publix Supermarket 482 East Altamonte Dr in reference to an attempted Carjacking, attempted strong arm robbery by sudden snatching, attempted grand theft auto. Upon arrival in the area we were advised by the witness [REDACTED] that an elderly female later identified as Eunice E Hopkins was screaming and yelling at a large white male holding the driver side door handle in the parking lot. [REDACTED] said he started walking toward Hopkins car and the large white male started to walk away acting like he was talking on a cellular telephone. Hopkins crying hysterically told [REDACTED] that the male was trying to take her purse and car keys. Hopkins was very distraught, emotionally upset and placed in fear of her life by the subject using his physical size and intimidation to make her relinquish her purse and vehicle.

Hopkins did not want to stay in the area and left in her Silver BMW rearing Florida tag 479-AGH to her residence. SPO Gray made contact with the witness [REDACTED] and he said the subject was a white male approximately 30 years old muscular build about 6'02 220lbs wearing blue tank top khaki shorts and brown hat. He was last seen leaving the parking lot of Publix supermarket.

MPO Foley was in the parking lot of the Altamonte Springs Mall 451 East Altamonte Dr near the Elephant Bar restaurant actively looking for the subject at large when he noticed a large white male matching the physical and clothing description of the person. I immediately responded to MPO Foley's location and started to walk towards the subject. The subject suddenly started to walk fast inside the mall. I stopped him just inside of the front doors and he said to me in an excited utterance "You got the wrong guy". He appeared nervous and was sweating profusely. I placed my handcuffs on him and told him he is detained for the moment upon further investigation of a crime that just occurred.

I made the identification of the subject through D.A.V.I.D as Mark Andrew Jones W/M [REDACTED]. An inquiry through FCIC/ NCIC revealed Jones is on probation for DUI. I read Jones his Miranda warning in which he signed the card and waived. I asked him why was he was in the Publix supermarket parking lot, He denied being at the Publix parking lot.

SPO Gray made contact with the witness [REDACTED] to conduct a show up of a suspect; he was able to positively identify the subject as the person attempting to take Hopkins vehicle and purse. [REDACTED] provided a sworn statement. PFC Dalton made contact with victim Hopkins to conduct a show up; she was able to positively identify the subject attempting to take her vehicle and purse.

I believe there is probable cause to charge Jones with one count of Attempted Car Jacking per State Statue 812.133, Robbery by sudden snatching per State Statue 812.131, and Attempted grand theft auto per State Statue 812.014. Jones was placed under arrest and advised of his charges, he was handcuffed double locked and checked for proper fit. He was transported to the Seminole County Jail for process.

Statements made by defendant prior to, during, and after arrest as related to each charge:

Upon contact with Jones he said " You got the wrong guy". Miranda warnings were read and waived. He denied being at the Publix Supermarket.
