### Select Committee to Investigate the January 6th Attack on the United States Capitol

November 9, 2021

Dear Mr. Luna:

Pursuant to the authorities set forth in House Resolution 503 and the rules of the House of Representatives, the Select Committee to Investigate the January 6th Attack on the United States Capitol (“Select Committee”) hereby transmits a subpoena that compels you to produce the documents set forth in the accompanying schedule by November 23, 2021, and to appear for a deposition on December 6, 2021.

The Select Committee is investigating the facts, circumstances, and causes of the January 6th attack and issues relating to the peaceful transfer of power, in order to identify and evaluate lessons learned and to recommend to the House and its relevant committees corrective laws, policies, procedures, rules, or regulations. The inquiry includes examination of how various individuals and entities coordinated their activities leading up to the events of January 6, 2021.

The investigation and public accounts have revealed credible evidence of your involvement in the events within the scope of the Select Committee’s inquiry. As former President’s Trump personal assistant (and commonly referred to as his “body man”), your job reportedly was “to accompany the President throughout the day and night, putting [you] in close proximity to Trump.”<sup>1</sup> In that regard, you would have been in regular contact with White House officials, including former President Trump, during many meetings and events relevant to the Select Committee’s inquiry. For example, you were reportedly in the Oval Office the morning of January 6, 2021, when former President Trump was on a phone call to Vice President Pence pressuring him not to certify the results of the 2020 presidential election.<sup>2</sup>
