Appeal of USACE Delay/Failure to Produce After Positive Determination.

Clarification, and Perfection of FOIA Requests

Dear Mr. Howard & Mr. Wittaker:

I am writing on behalf of FOIA Requester ECC International LLC ("ECCI") to Mr. Howard as FOIA Officer for CENAU and USACE, and to Mr. Wittaker as USACE FOIA Liaison, to demand overdue production by USACE to the FOIA requests submitted by Requester on January 30, 2019. Alternatively. Requestor seeks formal communication from USACE regarding the progress of USACE's response preparation and a schedule for such production. In ten months, no production has been made by USACE. In the last five months, no communication has been received from USACE, despite properly and timely perfection of the Requests, and repeated requests by Requester for status to no avail. Requester asks that USACE's inaction and non-communication be deemed a constructive denial of the positively determined and perfected Requests, and that this letter be deemed an appeal of that constructive denial, to exhaust all administrative remedies of Requester.

## FOIA Request History to Date

The ECCI FOIA Requests were submitted to USACE on January 30, 2019 (Attachment #1-9). In follow up to lack of response by USACE, USACE represented that CENAU "did not receive" the initial FOIA requests submitted by email, although all other recipients copied received the email (see two other recipient's acknowledgement emails in Attachment #10-12). Following the resubmission delay (see Attachment #13-16), clarification of the requests with USACE was successfully completed in March 2019. Requestor agreed to remove the limitation on costs of

research which USACE could charge during the Clarification and Perfection Conference call. (see correspondence in Attachments #17-75).

Since clarification and perfection was completed in March 2019 nine months ago, USACE has never asserted any privilege, security restriction, agency objection, management issue, administrative difficulty, need for redaction work, or any other legal or practical impediment to production of the requested documents. USACE has also not reported any confidential business information or proprietary objection by any third party that would prevent or delay USACE's required production of documents. USACE has no excuse for this delay.

During clarification, we discussed and acknowledged USACE's intent to notify third parties Jacobs Engineering, DCS, and Critical CxE to determine any confidential business or proprietary information objections those third parties may have to production. We discussed and acknowledged that the notification process would likely extend the process by as much as ninety days. I requested to be informed regarding this third party notification process and its progress, but have received no communication as to whether this has occurred, or whether the process impacted USACE's production.

In July 2019, four months after clarification and after we reasonably expected the third party notification process to be completed, I contacted Brett Howard, USACE FOIA Officer and USACE Agency Counsel, by email, and noted that no production had been made, and no impediment or delay had been reported by USACE that would prevent or delay production. I requested a meeting while I was in Wiesbaden for two weeks to discuss USACE's progress and anticipated production. I received no reply to my three biweekly requests during July 2019 (see Attachments #76-79). In response to my monthly "Fourth Request" for status on August 9, 2019, Mr. Howard finally responded that same day:

"Mr. Laurie,

I am receiving your letters. Have been tied up on other matters. Will return to your request today. Sorry for the delay,

Brett"

(see Attachments #80-92)

No further response has been received from USACE since August 9, 2019. Nine weeks later, on October 18, 2019, I sent a "Fifth Request" (see Attachments #93-95). No further communication has been received from USACE and no production has been made by USACE to date.

#### USACE Breaches of 5 U.S.C. §552

USACE has failed and refused to respond to written communications requesting production or alternatively communication of the status of work toward production regarding the perfected Requests. USACE has breached its duty to produce pursuant to the Freedom of Information Act, 5 U.S.C. §552, by failing to timely respond to the initial request within twenty days and by its subsequent unreasonable failure to comply with the mandatory production of the perfected Requests within the required ten days, having failed to assert any unusual circumstances. Requester has never waived its right to assert breach from the initial breach by USACE and has six years from February 19, 2019 to bring suit in the District Court.

Importantly, USACE has never asserted any legal or administrative basis for delay or non-production of documents. Specifically, no issue exists regarding any statutorily allowable exemption from production, which are: 1) national security information, 2) internal personnel rules and practices, 3) information exempt under other statutes, 4) confidential business information, 5) privileged intra- or inter-agency communications, 6) personal privacy, 7) law enforcement information, 8) financial institutions information, 9) geological information, or 10) a Glomar existence response.

The sole possible assertion of a delay by USACE to date has been that the CENAU FOIA Officer stated on August 9, 2019 that he had been "tied up on other matters", and promised a "return to your request today", August 9, 2019 (see Attachment

#83-87). Although this response is months late, it is consistent with §552, which prohibits any response with more than a ten day extension absent "unusual circumstances":

"No such notice shall specify a date that would result in an extension for more than ten working days..." §552(6)(B)(i) FOIA

No "unusual circumstances", as defined by the FOIA exist, nor have any unusual circumstances been asserted or timely noticed to Requester by USACE in the August 9, 2019 response or since (see Attachment #83-87). In any event, the four months elapsed since August 9, 2019 is a breach of the ten day maximum extension deadline in (6)(B)(i) absent Requestor's receipt of notice of "unusual circumstances".

USACE's FOIA web page (<a href="https://www.usace.army.mil/FOIA">https://www.usace.army.mil/FOIA</a>) does identify work load exceptions to the time line for production. Specifically, under "Procedures, Rules and Regulations Pertinent to Processing FOIA Requests/Response Time" the policy is stated:

"Under the FOIA statute, Corps of Engineer FOIA Offices are to respond to a FOIA request within twenty business days. This time period does not begin until the request is perfected, as discussed in the DoD and Army FOIA Regulations. Additionally, subject to the new time limits in the OPEN Government Act of 2007, the time period will not begin until actually received by the FOIA Office that maintains the documents sought. [Paragraph One]

Some FOIA Offices receive hundreds of requests each year. Many of these requests require a detailed review of hundreds or even thousands of pages of documents. Although the Corps of Engineers makes every effort to respond to FOIA requests as quickly as possible, in some cases it simply cannot do so within the specified time period. This may be due either to the size of the request, the location of the documents or to the fact that the Office has a backlog of previously received requests that are awaiting processing. [Paragraph Two]"

All of the requirements in Paragraph One for perfection and receipt by the custodial office were completed in March 2019, nine months ago, as detailed above. Paragraph Two provides for an extended timeline for production if 1) voluminous request, 2) location of documents, and/or 3) backlog of requests, but it still states that policy is production "as quickly as possible". To date, Requestor has only received the August 9, 2019 email, as sole notice of any extenuating factors that might be applicable, and no production to date.

Please also note that Requester purposefully made six distinct FOIA requests, instead of one large single FOIA request (see Attachments #2-9). USACE disagreed with six separate requests, and, after discussion (see Attachments #17-33), refused to treat the six requests individually, and logged all of the requests as a single FOIA request file. Requester's purpose in separate requests was knowledge that some groups of documents were readily available in the custody of the Contracting Officer for the Project in a single office in Germany and could be easily produced without delay, while other documents concerning third parties would require notice and would likely be produced later after a notice process. USACE's choice to make this a single file has unduly delayed production of documents that could have been produced months ago.

Requester ECCI has complied with all statutory requirements pursuant to the Freedom of Information Act, 5 U.S.C. §552, for entitlement to production of documents by USACE in response to its FOIA requests. USACE initially breached its duty to respond to the January 30, 2019 requests within the twenty (20) days required by 5 U.S.C. §552(6)(A)(ii), as acknowledged in writing by the Agency, conferring jurisdiction for Requester to file suit in District Court. However, since that breach, Requester has actively worked with USACE, achieved bilateral clarification and agreement to the validity of the Requests, and has never received a denial of the Requests from USACE to date. Pursuant to the Administrative Procedures Act, in the absence of receipt of a denial, and a failure to produce documents has occurred after an unreasonable period of time, all administrative remedies have been exhausted by Requester, thereby again conferring jurisdiction on Requester to file suit in the District Court for a second time.

## USACE Breach of Duty of Good Faith and Fair Dealing and Duty of Due Diligence

As of this date, no evidence of any good faith efforts at compliance has been demonstrated by USACE, much less the required due diligence for the perfected Requests required by FOIA. Requester is a commercial requestor. Requester has committed to an open-ended invoice from USACE for compliance with the Requests. Requestor is entitled, at a minimum, to some reasonable report of the costs incurred to date on Requestor's behalf by USACE in the nine months since perfection. Requestor is a bonded and audited USG Contractor and has duties to timely and accurately report regarding significant financial undertakings such as this significant financial commitment to USACE's failure to timely produce the documents or even report on the progress of due diligence materially impairs the value of the unlimited cost agreement for ECCI. When ECCI perfected the Requests by making the financial undertaking, USACE also undertook an implied duty of good faith and due diligence. USACE has now breached that duty to Requestor, and breached the implied duty of good faith and fair dealing.

# Documents Requested Readily Available to USACE

Requester notes that the Contracting Officer for USACE and his staff for the Project, who are the custodians of the documents requested, have been actively engaging in review of many of the requested documents in close out of the Project, based on the substance and text of REA denials and a draft CPARS submission recently received by Requester from USACE. This illustrates that many of the documents not produced are readily available for production in the hands of the custodians.

Separate from the FOIA requests, agency USACE is a contracting party with Requestor with regard to the Project. USACE is aware that Requestor seeks the documents by FOIA Requests for investigation and timely preparation of Requests for Equitable Adjustments (REAs) for the Project. USACE is aware and benefits from the delay and continued non-compliance that impairs Requestor's efforts at REA preparation and causes continuing financial harm to Requestor by delaying and denying access to the document production. Anticipated REAs against USACE were actively identified and discussed during the Clarification and Perfection conference in March 2019.

# Appeal of Constructive Denial by USACE

In the spirit of cooperation and so as to exhaust all administrative remedies pursuant to 5 U.S.C. §552(6)(c)(i), Requester again hereby demands, within ten days, production of documents, or in the alternative, that USACE provide written notice and explanation of any "exceptional circumstances", agency "due diligence" efforts to date, any agency assertion of "exemption" or "unusual circumstances" for compliance, any "response time extenuating circumstances" and identification of any administrative remedy which Requester has failed to exhaust by this letter pursuant to the APA, or else consider this letter an appeal under the APA of a constructive denial of timely perfected requests made to USACE after a positive determination. Requester ECCI reserves and does not waive the jurisdiction conferred by the two prior incidents of USACE breach of the FOIA without denial. ECCI is entitled to bring a cause of action in District Court without administrative appeal where no denial was ever issued by USACE which would require appeal pursuant to the APA.

I am Corporate Counsel for ECC International LLC ("ECCI"). As directed by the FOIA procedures for this agency, these are Freedom of Information Act ("FOIA") requests made on behalf of ECCI under the Freedom of Information Act, 5 U.S.C. §552. ECCI hereby requests a copy of each of the following documents regarding the Consolidated Intelligence Center (CIC) Project currently under construction by USACE Europe Division, CENAU, at USAG Clay Kaserne, Wiesbaden, Germany, Contract No. W912GB-13-C-0003. All of the documents requested are expected to be in the custody of the Contracting Officer for the Project, LTC USARMY CENAU Christian H. #### FOUO Designation

Please note that Contract No. W912GB-13-C-0003 is <u>not</u> a classified contract and project, but is a "For Official Use Only" (FOUO) designated contract. I am in receipt of your Freedom of Information Act (FOIA) request. I want to emphasize that it is the policy of the Department of the Army to strictly comply with the FOIA. In so doing, the Department provides the public with a maximum amount of accurate and timely information concerning its activities consistent always with the legitimate public and private interests of the American people.

In review of this FOIA request we have identified certain requests that do not meet the minimum requirements of the FOIA. Although virtually all of these communications are presumptively privileged, the locating, review and redaction where necessary is expected to be exceptionally labor-intensive.

Lastly, your request implies that there are 6 FOIA requests. Please note, our office views this request as a single FOIA to which we have assigned its internal case number identified as FOIA 2019-002. Please be advised that I will keep your request in a pending status for the next 10 days. However, if I do not hear back from you about this request for clarification during that time, I will close the file and take no further action.

If any of the six requests are not simple, and are deemed complex or require perfection by the requester, and can be expected to delay compliance with the whole, please advise and consider each numbered request a separate FOIA request, and respond to each numbered request separately for administrative purposes, so as to avoid any delay in response and production for the simple requests. This is a reasonable interpretation of ECCI's requests, given the express distinction of the six requests in our intial FOIA Request letter dated January 30, 2019.
