I did confirm we have no control on the margins because they are pre-set, and you are correct in that it's the space from the contest box to the edge of the black boxes. After talking with David he believes we can get the ballot to the way you would like in terms of column consistency by doing a four-column ballot and span every contest two columns; that way RCV doesn't get affected in terms of numbers of ranks allowed. More to come soon!

Thank you for following up with us on those concerns. The information makes sense, but I do have two follow up questions.

- What I'm hearing is that the way the RCV contests are formatted, they take up 2/3 of the ballot space column because of the length of some of the matrices. Do you mean that due to the length of some of the RCV matrices, the entirety of the ballot itself must be three-column? I believe for us, our concern with the two-column had more to do with the other contests such as the Federal, US Representative, State candidates, School Boards, and BART rather than the RCV contests.
- 2. This is unfortunate, but makes sense. But to clarify, there is no control over the margin from a contest box to the edge of the black boxes/scanning guides?

Also, I realize that I forgot to attach Cat's mock-up of what we were hoping the ballot to look like and have

Our team is still reviewing, but I may be able to provide some clarity on item #1 and #2 below.

- Regarding columns, a two column ballot in 5.10-A can only work if you have up to 5 choices in RCV, if it goes beyond that it will need to be 3 columns, which accommodates 9 ranked grid. This is why there needs to be 3 columns for your RCV contests.
- 2. Our programming team has no control over the left or right margins, otherwise they'd definitely be even. The way the system works is that we can control margins inside the contest box, but not directly outside between the timing marks (this probably brings flashbacks of the oval not being centered in RCV, John). Alyssa plans to put in a request with engineering to potentially address this in a future version.

I know this isn't the best news from a formatting perspective, but I did want to pass along this information to explain a bit more behind the scenes. I hope this was helpful! I'll pass along any additional information and provide updates on progress as soon as it's available.

Please find the Ballot Change Log attached. Our comments from this round begin at #28. I have highlighted items in the Outcome column from earlier items that need some follow-up. Please let me know if you have any questions regarding our feedback.

From the Change Log, I wanted to highlight a few pieces for your team:

- 1. The ballot layout needs to be consistent throughout all languages. We are hoping to have a two-column ballot rather than a 3-column ballot in the hopes of making it more consistent throughout all languages.
- 2. Additionally, we're hoping that having a two-column ballot may address the feasibility of having a .35 inch margin on the ballot. If it is still not feasible, please make sure that all margins are even.
- 3. Chinese character point-size font is consistently smaller than the English. Please ensure they are the same point-size.
- 4. There are some issues with alignment throughout the ballot. The places where this is found are with the Chinese and English Instructions to Voters not lining up, the header boxes for Party-Nominated and Voter-Nominated Offices, the headers for the school contests, and the boxes for the school contests being of different heights when they should be the same.

This is all in the Change Log, but I just wanted to bring these parts to forefront.

Additionally, we had a few requests for either you or your team:

- Is it possible in the next round to receive the ballot templates for the measures as well? We are needing to finalize the ballot templates by next Friday, August 7th, so being able to begin the process for this piece as well would be great.
- 2. In our next meeting, can we go over a bit of the process of how your team prepares the templates, how the software/system works? I think, we're hoping for a bit of a better understanding of how the system functions so we can be more informed about our process.
- 3. We are meeting with you soon, but since we are beginning to get to the time where deadlines are fast approaching, we would feel more comfortable meeting more frequently. Last cycle, it seems you met daily. That would be ideal for us to do again if you are able to provide short check-ins daily.

We were curious about the fact that there are instructions that are a part of the BOS matrix and in past elections, we have not had instructions within the matrix. And again, we just want to reiterate that the Master Spreadsheet should be used step-by step and it follows the order of the ballot so it can be used to go down in order of each contest. Hi Travis,

I wanted to follow up on the ballot templates that were sent and the ones you highlighted for us to review. We have found some large and concerning errors in the templates and we do not feel comfortable proceeding with proofing the templates until these can be fixed.

The main concern here is that we are finding that there are large errors that show up inconsistently throughout the different precinct and ballot types. We do not feel that we can be confident in knowing that these errors will not be inconsistently showing up on other ballots that we will not be able to proof due to the sheer volume. We want to make sure that the Ballot Master Spreadsheet is being used to create these templates. There

seems to be phantom data in these templates from the March 3rd election that should not be there and missing instructions for the general election that should be included that are in the Ballot Master and not in the templates.

A brief overview of our concerns regarding the templates are as follows:

- The date March 3rd, 2020 comes up inconsistently on the ballot in the English text of all language ballots.
- Instructions such as "Write-in candidates are not permitted at the general election for a voter-nominated office," are in the Instructions to Voters section of the Master Spreadsheet but missing from the template.
 - Additionally, the ballot templates seem to be using the March 3rd text for the Party Nominated Offices information provided below the Instructions to Voters.
- On the topic of write-in candidates not being permitted for voter nominated offices, I may have misunderstood earlier and given you the wrong instructions in regard to the write-in candidate information. I apologize and it is as follows below:
 - Senator District 11, CD 12 & 14, and AD 17 & 19 do not have write-ins.
- Additionally, there should be no extra column in the BOS RCV for a ranked choice for the write-in candidate. For example, if there are 4 candidates, there should only be an RCV up to 4 even though there is a fifth row for a write-in.
 - This does not apply to District 9 as there is only one candidate and so, there will be an RCV of 3 and two write-ins.

I have attached a change log that documents more of the issues we came across. I also added a column to specify the precincts of the ballots in which the issues were found. This circles back to the worry that these issues may be in other ballots due to the inconsistency of the issues cropping up. I was also not able to go through all of the ballots that were provided back to me.

I have also attached two PDFs, a Spanish and Chinese version of Precinct 1101. The Spanish PDF has the most markups that apply to all ballots, but the Chinese ballot also has a few and more that are specific to the language concerns of that ballot. If you would like more examples of issues we're seeing, please let me know.

If you are able, we would appreciate that the changes be implemented and a new batch of templates be created. I realize that these are a lot of big changes. If you are able to provide us with a timeline of when these issues might be able to be implemented, that would be great.
