Hi Travis.

I have attached our comments from this round of proofing. Things are looking pretty good! I just want to highlight a few things:

- 1. It seems that for the Chinese and Filipino ballot, on Prop 14, there were incorrect translations, so please make sure the translations match the excel spreadsheet for this one.
- 2. I had copied and pasted the English and the Spanish text for state measures from PDFs. I thought I had caught all the typos for this, but I didn't, so there are a few in the change log that will need to be updated. I have also updated the English and Spanish for this in the measures spreadsheet and is also attached to this email.
- 3. Additionally, we're hoping to shorten the width of the Yes or No target boxes on the measures to save space. Also, the wrapping seems to be very loose in some places and if you are able, we are okay with tight wrapping. I have attached a markup example where the smaller target boxes line up with timing marks (I hope) that also has the tighter wrapping we'd be hoping for. I think it could potentially save a lot of space and maybe bring us back down to a 17" card?
- 4. I added breaks in the Chinese state measure text. It was pretty random, but I hope it's helpful.
