Hi Tisa,

Thank you for the feedback. Although it is not ideal, I will say that the issues noted are somewhat expected for voice synthesis, as they often require a lot of adjustments – as have the other languages, historically.

I'm of the mindset that if we go through with the recording process we might as well record everything, including the contests and short pieces and you will likely get a cleaner end product at the expense of more days spent waiting. Although the voice synthesis route will not be as sonically pleasing to the ears as a live recording, the advantage to using a synthesis is greater flexibility in generating the files and getting the project ready. We do not have to schedule recording and then wait for audio files to come back to us.

Right now, my concern with audio recording is that the vendor is having some difficulties procuring a voice recorder which could push our timeline back, and we are already on a very tight turnaround time. I'll keep you updated when I receive news/updates from Language Link on the status of a voice talent.

Hi Travis,

Thank you for passing these along. The feedback from our team is that pieces such as titles like President and Vice President could be used, but there is quite a bit of worry about using voice synthesis for such large chunks of audio with the propositions and voter instructions.

The issues that were noted were that the mispronunciations were quite significant in the proposition text, there were significant (2 second) pauses in between words such as San and Francisco, and breaks in the word ballot. It also seems that all numbers were read in English, such a 5% and 10, though things such as million were read out in Filipino. Maybe, these numbers need to be written out in order to be read correctly.

The general consensus is that we could use voice synthesis for short pieces such as "President and Vice President" and "Fifth choice," but that it probably should not be used for the rest.

Please let me know if you have any thoughts on this.

Good Morning All,

As we are proceeding with your programming we are getting close to the time where we have historically recorded Filipino audio for insertion into the project. I am currently working with the vendor we usually use, Language Link, to procure voice recording talent.

At this time there is no firm date of recording since we don't have the final script and we don't know when they'll have someone available to record, although I know they are searching. However, to assuage any fears I wanted to let you all know that in 5.10A we <u>DO</u> have the ability to synthesize Filipino audio just like we do for other languages. Historically this has not been an option which is why we always recorded audio, but with 5.10A the Filipino audio process has been standardized. If you'd prefer to go the voice synthesis route instead of a live recording, the process could actually end up taking less time. I've attached some sample files for you to review so you can get a rough idea how this would function.

Please let me know your thoughts, thank you.
