For additional clarification on the issue:

Our translator from DFM (that grabs the files from DFM and creates our EDT spreadsheet) made the ballot designations automatically; using predefined translations that we used back in the BPS times, we bring those in as a textual unit into EDT (and then into EED), by merging those translations with the party translation.

We were incorrectly under the impression that those came from DFM. On the pre-DFM template, we had those as textual units manually created for the template. The issue was corrected by manually grabbing the preferential text and the party from the master document. It took us a while and some detective work, but we figured it all out.

This item will be added to the post-November conversations of streamlining exports-imports. Apologies for the confusion.

I realized I forgot to ask two questions this morning that I was hoping to get answers to:

- 1. Why are the margins around the choice boxes for most local measures (with the exception of A, F, J, L and RR) so much larger than that of the state measures? Is there any way that we can adjust this so that text is able to wrap to the furthest possible margin and formatting remains consistent throughout the measures?
- 2. Is there an explanation for why the Chinese text for "Party Preference:" changed from what was in the template and the Ballot Master Spreadsheet to "party affiliation"? I'm curious because I know we're trying to create a template for future elections and in the template, we had the correct translation, but it was changed when names were put in. I want to make sure that this isn't something that will need to be addressed every cycle.
