The team would prefer not to move forward separately QAing regular and EDU, as this could get messy – we will submit all at the same time when we get official sign off on EDU.

Additionally, the title issue on the EDU ballot could take some time and finesse to implement, as altering the title actually makes the ballot larger than 18 inches. The team is playing around with it but it may not be a quick turnaround if we want to keep the 18inch card for EDU.

At this point it is not guaranteed we'd be able to pass through QA tonight, even if we finalize in the next couple of hours. I'll keep you updated!

My concern is that in the CAEC 1307.F (2), it states: If a candidate fails to provide a designation that complies with subdivision (a) or (b) within the three-day period specified in paragraph (1), a designation shall not appear after the candidate's name.

And further down in 13107.3. (c), it states: In the event that a candidate fails to file a ballot designation worksheet in accordance with subdivision (a), no designation shall appear under the candidate's name on the ballot.

To me, the "shall not appear" reads that there should be no text for a ballot designation and in putting "No ballot designation," it would in fact be a ballot designation. John, if you have any thoughts on this with the code, please let me know!
