Please find the updated spreadsheet attached. All edits in this version are blue due to the edits that were kept staying in red.

We do have a question about contest\_title\_and\_propostion folder: it seems that the recordings in the folder are strange/off. In English, none of the fixes are applied and still reads numbers incorrectly in the measures. In Filipino, these audio files are read in Filipino but with the English voice, which makes it hard to undertand. Same goes for Spanish. Everything in the contest\_propositon for audio with measures is updated with the corrections and good (though some a few corrections are still needed).

So, the question is, will the contest\_title\_and\_proposition audio be used or is it just the contest\_proposition audio that will be used? Should we not be proofing this file of audio? If we shouldn't be, many of my comments for English can be ignored. I tried to make this apparent with titling those changes with "contest\_title\_and\_propostion folder:"

I have also noticed that the top header says "San Francisco 2020 General" rather than consolidated general election, is this something that we need to be addressing? I believe you said the top boxes don't need to be proofed, but I want to check and make sure that this is the case. Here is a screenshot for reference:

Hi Travis,

I have compiled the changes that are needed for this round of audio. Going through them, I realize there are a lot. I have discussed with the team the goals of making sure that the changes that we are making are only fundamental to structure and understanding the audio. I have made it clear that if it is awkward, we should leave it. In the reviews, I have checked with the team that the requests that are being requested are because it would otherwise not be understandable and the consensus has been, that yes, everything that is being requested is necessary.

I want to let you know that with Filipino audio there were a lot of issues. The main issue being that much of the audio that was in all caps, would be read letter by letter. After playing around a bit with google translate, we found that if it was put in title case, it would be read correctly. So, all of the names that were changed to lower case font were done because otherwise, it will not be read correctly. This is the case for measures as well. Also with the measures, our team needed to spell many words incorrectly for the Filipino to be read/pronounced correctly. For the Filipino measures, I would highly recommend just copying and pasting the entirety of the measures text.

Additionally, for both Mandarin and Cantonese, contest\_title\_and\_proposition; electoral-group; election; party. Are these supposed to be English only?

Please let me know if there is a better way to document/request changes.

- Due to the time it takes to implement corrections, please be as thorough as possible as we are aiming to only have one or two rounds of preliminary audio review. If this means taking longer to provide us with feedback, that is totally fine!
- Voice synthesis is a neat tool, but obviously far from perfect. Changing numbers and other small things, such as adding commas, takes a lot of manual work if there are *a lot* of requests our advice when reviewing would be only note things that are really big and structural. I.E., if it is generally understandable and makes sense, we advise leaving it in the interest of time. A good rule of thumb: *could the voter understand this even if it doesn't sound perfect and/or sounds a little awkward?* 
  - How you define what is okay to leave and what needs to be fixed is up to you, but if there are a lot minor
    manual fixes this process will take much longer.

The team implemented some of the feedback provided earlier where needed, but please remember this is still a work in progress – the key is how it will sound. Thanks!




