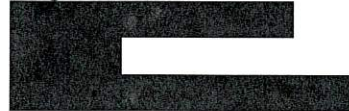

Select Committee to Investigate the January 6th Attack on the United States Capitol

Dear Mr. Stone:

Pursuant to the authorities set forth in House Resolution 503 and the rules of the House of Representatives, the Select Committee to Investigate the January 6th Attack on the United States Capitol (“Select Committee”) hereby transmits a subpoena that compels you to produce the documents set forth in the accompanying schedule by December 6, 2021, and to appear for a deposition on December 17, 2021.

The Select Committee is investigating the facts, circumstances, and causes of the January 6th attack and issues relating to the peaceful transfer of power, in order to identify and evaluate lessons learned and to recommend to the House and its relevant committees corrective laws, policies, procedures, rules, or regulations. The inquiry includes examination of how various individuals and entities coordinated their activities leading up to the events of January 6, 2021.

The investigation and public reports have revealed credible evidence of your involvement in the events within the scope of the Select Committee’s inquiry. According to documents provided to the Select Committee, press reports, and statements by you, you were in Washington, D.C., on January 5 and 6, 2021, to attend and speak at rallies in support of then-President Trump and his allegations of election fraud. Specifically, you reportedly spoke on January 5th at rallies at the U.S. Supreme Court (held by a group affiliated with the Three Percenters) and Freedom Plaza (held by the Eighty Percent Coalition), and were originally scheduled to speak at the January 6, 2021 rally at the Ellipse (held by Women for America First).¹ Before traveling to Washington, you promoted your upcoming appearance at a January 6th Stop the Steal event and solicited donations from

supporters to pay for security by directing them to stopthesteal.org.² While in Washington, you reportedly used members of the Oath Keepers as personal security guards, several of whom were reportedly involved in the attack on the Capitol and at least one of whom has been indicted.³ You have stated that you were invited “to lead a march to the Capitol” from the Ellipse rally on January 6th, but did not end up doing so or going to the Ellipse rally or the Capitol the day.⁴

Accordingly, the Select Committee seeks documents and a deposition regarding these and other matters that are within the scope of the Select Committee’s inquiry. A copy of the rules governing Select Committee depositions, and document production definitions and instructions are attached.
