Bail Request: At first appearance, the court set bail at \$5,000. Pursuant to CrR 2.2(b)(2)(ii), the State requests bail remain in the amount of \$5,000 due to the likelihood the defendant will commit a violent offense against the victim.

Currently Charged Offense: As the certification and police reports describe, the victim is in the process of divorcing the defendant, and the defendant has told her that if he could not have her, then no one could. The defendant physically held the victim down on their bed for one to two minutes, and she was unable to move. The defendant only released her when she told him that she would agree to marriage counseling. The victim immediately left the house and went to the neighbors to call 911. The victim is afraid of the defendant because he has "blind rage" and has been acting strangely for the past two weeks. He has not been working or showering, and he has been talking about government conspiracies. The victim reported the defendant strangled her approximately six years ago.

Criminal history: None known.

Individual Order History (IOH): No known prior orders.

Officer Hensing contacted at her neighbor's house located at a written statement.

stated on 07-31-19 at approximately seven in the evening, she arrived home and went inside her residence she shares with her husband of twenty five years, Michael Protzman. They are currently in the process of getting divorced and Michael told her that if he couldn't have her, no one could. For the past two weeks, Michael has been acting differently, not showering or working and believing in government conspiracies. He physically held her down on the bed, using both of his hands to physically restrain her, using one of his legs to brace hers, rendering her unable to move. Michael held her in this position for approximately two to three minutes until she told him that she would agree to marriage counseling so he would let her up. When she attempted to walk down the hallway, he physically grabbed her, preventing her from leaving. She was eventually able to get out of the house and walked barefoot to her neighbor's house where she called 911. Stated she is scared of Michael because he has "blind rage" and she believes he may hit her. Michael has assaulted her in the past; strangling her approximately six years ago.

Officers observed Michael exiting the residence, walking southbound on the sidewalk. Officer Hensing approached Michael, telling him that he wanted to speak to him. Michael told Officer Hensing that he didn't have any authority over him and continued to walk down the sidewalk. Officer Hensing told Michael that he was under arrest, having to physically grab him by the arm to stop him from walking away. He immediately resisted, attempting to physically overpower the officers. After a brief struggle, he was taken into custody. Officer Hensing advised Michael of his Miranda rights from his department issued Miranda card.

told Officer Hensing that there was a .22 caliber rifle inside the home but she did not want police to remove it.
