UPON ARRIVAL AT THE LOCATION AT 1201 HRS, I MET WITH THE COMPLAINANT STANDING OUTSIDE OF HIS BLACK FORD F250 IN THE PARKING LOT OF BEST BUY.

DANIEL STATED THAT SOMEONE STOLE HIS LAPTOP AND TWO PASSPORTS FROM THE BACKSEAT OF HIS BLACK FORD F250 TRUCK. DANIEL STATED THAT SOMEONE HAD PUNCHED THE LOCK ON HIS DRIVERSIDE DOOR. DANIEL STATED THAT HE KEPT HIS 2 YEARS AND 10 YEARS PASSPORTS INSIDE THE LAPTOP BAG JUST IN CASE HE NEEDS TO TRAVEL OVERSEA FOR A JOB. DANIEL STATED THAT THE LAPTOP BAG WAS PLACED ON THE FLOOR, BEHIND THE DRIVERSIDE. DANIEL STATED THAT HE CAME OUT OF BEST BUY AND SAW HIS TRUCK LIGHTS WERE BLINKING.
