We do! Here's what we got from the survey that closed on Friday. The survey went out to everyone OEO is funding with COVID-related ESP ("ESP-CV") and CRF ("CRF-ESP") dollars operating this calendar year. This means that our universe for the survey was limited to organizations who may be facing funding cliffs for program operations that we are currently supporting -- not everyone who might want funding.

We got responses from 72 organizations, which we consider to be a pretty robust response especially considering that it was only open for two and a half days. Of those who responded, 29 indicated that they are facing funding cliffs that will require them to discontinue program operations that they would otherwise sustain. We got this on a monthly breakdown and by activity, as presented in the table below. The total for the rest of the State Fiscal Year is \$3.7 million.

I'm sure this is not 100% perfect information, but suspect that if it misses anything, it does not include some programs or costs that it might otherwise also need support. That is, I would suspect it is a conservative estimate, if anything.

Since funds are still being used by providers, we have not required them to submit a report or data at this time. Typically we wait until after the funding period, and once the funds are fully expended, to solicit that information. We have information on what providers proposed to do during the period Jan-June (numbers they intended to serve, services they planned to deliver) and can provide that if it would be helpful. The CRF and ESP funding we had would have supported some of that proposed work, but not all of it.

Regarding the amount of funds spent. We have obligated all of the funds (agencies have received it all), but do not have a real-time accounting of where spending is at as the spending is happening daily. To get that information, we would have to reach out to the individual entities and ask for an accounting of their spending to-date. This could be done, however, there are over 100 providers to connect with, so it would take some time. If this information is needed, we can set a plan to do this. Let me know what would be helpful.

In January, after awarding out all remaining CRF and ESP funding that we had, we identified a gap of \$5.6million. This gap was based on:

• A line by line, provider by provider, analysis of each request received from providers for the period Jan-June 2021 (solicited in November 2020)

- We considered what, of the Jan-June requests, had been covered by ESP and CRF funding we allocated out in Jan, as well as what, of the Jan-June requests, had been covered by Federal Emergency Solutions Grant (ESG) funding we awarded out in January.
- We considered the timeline providers put in their requests, as some had determined on their own that they would end projects earlier than June 30.

From that analysis we determined a gap of \$5.6 million. This analysis was done in January, and was based on requests providers submitted in November 2020, so we cannot know for certain if the exact same needs are present. That said, we are confident that \$1 million would be the minimum needed to cover the gap.

Since funds are still being used by providers, we have not required them to submit a report or data at this time. Typically we wait until after the funding period, and once the funds are fully expended, to solicit that information. We have information on what providers proposed to do during the period Jan-June (numbers they intended to serve, services they planned to deliver) and can provide that if it would be helpful. The CRF and ESP funding we had would have supported some of that proposed work, but not all of it.

Regarding the amount of funds spent. We have obligated all of the funds (agencies have received it all), but do not have a real-time accounting of where spending is at as the spending is happening daily. To get that information, we would have to reach out to the individual entities and ask for an accounting of their spending to-date. This could be done, however, there are over 100 providers to connect with, so it would take some time. If this information is needed, we can set a plan to do this. Let me know what would be helpful.

Awesome!

Looping in Katelyn from the OEO team since Andrea is away this week.

The \$3.7 million for ESP-funded settings does not include isolation spaces. Carolyn Ham estimated that the isolation space funds needed to sustain all of the spaces operating now would be \$1.5 million through the end of the fiscal year.

Since I'm guessing the combo of those two amounts is more than we can get, how about we simply max out the request (whatever that underspent amount would be) and in the CRF justification, name both isolation space and ESP activities as eligible for the funds, so we can apportion and adapt over time based on demand.

In addition, we could estimate how much time the requested amount would cover, but make the eligible period all the way through the end of the fiscal year to encourage or at least allow providers to stretch the dollars.

Happy to take a stab at writing that up -- would just need to know what the total dollar figure we should target would be.

Katelyn, anything to add for OEO?

My only other question would be: do we think that CRF requests will move, or will they end up stalled until after session?

We do! Here's what we got from the survey that closed on Friday. The survey went out to everyone OEO is funding with COVID-related ESP ("ESP-CV") and CRF ("CRF-ESP") dollars operating this calendar year. This means that our universe for the survey was limited to organizations who may be facing funding cliffs for program operations that we are currently supporting -- not everyone who might want funding.

We got responses from 72 organizations, which we consider to be a pretty robust response especially considering that it was only open for two and a half days. Of those who responded, 29 indicated that they are facing funding cliffs that will require them to discontinue program operations that they would otherwise sustain. We got this on a monthly breakdown and by activity, as presented in the table below. The total for the rest of the State Fiscal Year is \$3.7 million.

I'm sure this is not 100% perfect information, but suspect that if it misses anything, it does not include some programs or costs that it might otherwise also need support. That is, I would

suspect it is a conservative estimate, if anything.

I hope this information is helpful. Please let us know if there's anything else we can do on our end!
