7 [REDACTED] who works as campus security for Embry-Riddle University, advised the following:

9 On December 09, 2021, at 12:34 AM, W1, who is known to this detective was informed by W2, also known to this Detective that his friend, John
10 Hagins was making statements concerning shooting up the school. After gathering all the necessary information, W1 contacted law enforcement to
11 report the incident.
12 Officers made contact with W2 who stated the following:

14 W2 and Hagins use to be roommates on campus last year at Embry-Riddle. During that time, W2 and Hagins became friends and began hanging out
15 with each other. W2 stated that Hagins was making good grades and nothing abnormal stuck out to him. W2 advised that Hagins was accused of



16 sexual assault on a female at an Embry-Riddle party last year. During that investigation, Hagins's grades began slipping to the point of him failing and
17 he all of a sudden stopped flying. W2 advised last week while driving to Orlando to watch some flights, Hagins began talking excessively about
18 purchasing a gun and the gun being able to fold so it could fit inside of his backpack to take to the school and "shoot it up". W2 advised that they
19 became more concerned about Hagins when he recently sold his truck, which he seemed to have ambitions about fixing up. The money from the
20 truck was used to purchase the gun that Hagins talked about. W2 advised that last night, Hagins showed him a black Kel-Tech gun and advised that
21 it was a sub200 that he had just purchased off Facebook Market Place. Hagins was also in possession of approximately 800 rounds of ammunition.
22 Upon showing the gun to W2, Hagins made the statement "I finished my back to school shopping." Hagins advised that he would purchase a silencer
23 so he would be able to shoot inside the school library. At approximately 11:00 PM Hagins advised W2 that he was loading his bag for tomorrow
24 (12/09/2021). Hagins then sent W2 a snap chat of his bag filled with ammo and the gun. At that point, W2 called security to make them aware of
25 what was going on. W2 stated that Hagins has his locations service on and as of 300 AM and also at 0900 AM, he as showing in the area of his
26 apartment, 110 Acklins Cir. #304. Officers checked the parking lot in front of Hagins building #110 and found a brown Ford F150 bearing FI tag of
27 [REDACTED], which is registered to [REDACTED] ([REDACTED])
28
29 Embry Riddle University confirmed that a parking ticket was issued to that same truck on campus yesterday (December 8, 2021). W2 stated Hagins
30 lives at 110 Acklins Cir #304, which was confirmed by ERU security, who provided his school profile card.
31
32 At this time it is believed Hagins has intentions to act on his threats today because today is the last day of classes.
33
34 Detectives conducted surveillance on Hagins apartment.
35
36 At approximately 945 AM Hagins was observed leaving his apartment, carrying a brown backpack with two magazines in the outside web pockets.
37 Upon contact with Hagins, the backpack was unzipped at the top and you could see the firearm sticking out of the top of the backpack. Hagins was
38 detained and the firearm was recovered and secured for officer safety by Det Trudell.
39
40 Hagins constitutional rights were read to him by Det. Trudell. At that time Hagins agreed to speak with detectives back at the police station (DBPD).
41
42 Detective Quinones and Detective Vahey conducted the interview with John A Hagins, at 129 Valor Blvd .
43
44 Hagins was read the Miranda warning via a department form to which Hagins signed and waived.
45 Hagins provided a statement advising he left his apartment to go to the top gun shooting range and shoot a gun he just purchased last night with a
46 friend, W3. Hagins stated the firearm he purchased was a "Kel-tec" and he purchased the firearm with approximately 400 9mm rounds, last night
47 from a male on Facebook market place. Hagins stated he traveled to Dunnellon Florida to met the seller of the firearm.
48 Hagins confirmed to detectives he recently sold a pick-up truck he worked on as well as a refund he received from school to fund his purchase of the
49 firearm. Hagins stated he did make comments to his former roommate at Embry Riddle about "shooting up" the school and made references to the
50 mass shooting that occurred at Columbine High School in 1999.
51
52 Hagins confirmed that he made these comments both in person and via Snapchat messenger.
53
54 Hagins completed a sworn written statement and provided a sworn verbal statements to detectives.

58 The backpack with the firearm and ammunition were also collected and tagged into DBPD property/evidence.

60 The written statement and the video of the interview was also tagged into property/evidence.


