## One Hundred Seventeenth Congress

### Select Committee to Investigate the January 6th Attack on the United States Capitol

December 9, 2021

Dear Mr. Martin:

Pursuant to the authorities set forth in House Resolution 503 and the rules of the House of Representatives, the Select Committee to Investigate the January 6th Attack on the United States Capitol (“Select Committee”) hereby transmits a subpoena that compels you to produce the documents set forth in the accompanying Schedule by December 23, 2021, and to appear for a deposition on January 5, 2022.

The Select Committee is investigating the facts, circumstances, and causes of the January 6th attack and issues relating to the peaceful transfer of power, in order to identify and evaluate lessons learned and to recommend to the House and its relevant committees corrective laws, policies, procedures, rules, or regulations. The inquiry includes examination of how various individuals and entities coordinated their activities leading up to the events of January 6, 2021.

The Select Committee’s investigation and public reports have revealed credible evidence of your involvement in and knowledge of the events within the scope of the Select Committee’s inquiry. According to documents on file with the Select Committee, press reports, and your public statements, you were an organizer, both individually and through your organization, the Phyllis Schlafly Eagles, of the Stop the Steal (“STS”) movement, which held a series of rallies held after the November 2020 election in support of then-President Trump and his allegations of election fraud.<sup>1</sup>

In particular, according to documents provided to the Select Committee, a purported organization called “One Nation Under God” submitted a permit application on or about December 21, 2020, to the United States Capitol Police (“USCP”) for a rally to be held on the U.S. Capitol Grounds in Washington, D.C., on January 6, 2021, concerning “the election fraud in the swing states.”<sup>2</sup> The contact information on the documents submitted to the USCP corresponded with individuals involved in STS, including Ali Alexander (also known as “Ali Abdul Razaq Akbar” and “Ali Abdul Akbar”).<sup>3</sup> STS advertised the Capitol rally event on at least two of its websites (stopthesteal.us and wildprotest.com) and on these same websites sought donations to offset expenses for January 6th.<sup>4</sup> According to documents provided to the Select Committee, you were involved in the logistical planning for the STS “Wild Protest” event and paid costs associated with vendors hired for that event.<sup>5</sup>

After the January 6th attack on the U.S. Capitol, Mr. Alexander released a statement acknowledging that STS had obtained the permit for the protest under the name “One Nation Under God.”<sup>6</sup> Mr. Alexander explained that it was the intention of STS to direct attendees of an earlier rally held on the Ellipse in Washington, D.C. on January 6th “sponsored” by STS to march to Lot 8 on the U.S. Capitol Grounds, which is the location for which the USCP granted the permit for the “One Nation Under God” rally.<sup>7</sup> Yet the permit application estimated the event would have only 50 attendees.<sup>8</sup>

According to press reports, in the weeks before the January 6th attack, Mr. Alexander made repeated reference during STS-sponsored events to the possible use of violence to achieve the organization’s goals and claimed to have been in communication with the White House and Members of Congress regarding events planned to coincide with the certification of the 2020

Electoral College results.<sup>9</sup> Indeed, Mr. Alexander reportedly spoke at a rally on January 5, 2021, held at Freedom Plaza in Washington, D.C., and led the crowd in a chant of “victory, or death.”<sup>10</sup>

Accordingly, the Select Committee seeks documents and a deposition regarding these and other matters that are within the scope of the Select Committee’s inquiry.
