This may be the way our family was identified, as the Policia would of had to of been told to apprehend me, when I crossed into Tijuana, MX and took my ID between the date ranges of May, 27, 1999 and June, 30, 1999. Occurring within 30 days of President Bush announcing his candidacy on June, 12, 1999. Followed by Iris Moser paying for the ticket to San Francisco, CA. approximately July, 01, 1999 then departing to Bonn, Germany shortly after Federal Agents were parked in front of 800 Groveton Ave, Glendora, CA 91740, USA.

Leading to my Orders being changed from Whiteman, AFB, MO to Edwards AFB, CA July, 31, 2001 prior to the September 11th Attacks and prior to Ronald R Blanco aka Ismael Zambada Garcia being listed on 28 Jan 2003.

On September, 01, 2016 Myself and ex-wife met Ronald R Blanco AKA Ismael Zambada Garcia in Las Vegas, NV after inviting us to live with him at Phoenix, AZ at 2538 n 55th st Phoenix AZ 85008.

On January, 19, 2017 Joaquin L Guzman was extradited to The United States of America and it was suggested that I moved to Puerto Penasco, MX.

Between the specific dates of January, 4, 2019 and April, 1, 2019 while looking at the FBI's Top 10. Ronald R Blanco's photograph was listed as Ismael Zambada Garcia. Upon reporting him, he was removed following my accounts being locked out and rights taken away. Shortly after, Ronald R Blanco was relocated within Federally financed witness protection.
