

The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/16/2021 AT APPROX. 2231 Hrs. the victim accidentally cut off the suspect's vehicle while in traffic on Florida Av N. The suspect became enraged and followed the victim to the intersection of Florida Av N and Henderson Av E. At the intersection the suspect cut in front of the victim's vehicle and stopped in front of her at the red light. While stopped for the red light the suspect exited his vehicle and approached the victim's vehicle and yelled at her, "what the fuck are you doing? You stupid bitch! You cut me off!" The victim heard the statement clearly because her window was rolled down. The suspect then reached into the victim's open driver's side window and punched her in the face with a closed fist.

The victim suffered redness, soreness and bruising to the left side of her jaw. The victim is 16 years of age and has a very youthful appearance.

The victim was able to get a good look at the suspect's vehicle because it is very distinct (White/Black convertible Porsche 911 with "911" boldly printed on the driver's side door.) After an investigation the vehicle and registered owner were identified. The victim viewed a photo pack that included the registered owner. The victim quickly and definitively selected the suspect as the person that punched her in the face.

Based on the investigation the suspect unlawfully entered into the victim's occupied conveyance and committed a battery upon her.

The suspect was identified via his Florida driver's license photo.

This incident occurred in Hillsborough County within the City of Tampa.
