



2) Investment idea - Situation in global markets

- the legal framework for the therapeutic use of cannabis products has existed in Germany since 2017 and just recently the government proceeded to legalize
- cannabis relevant regulatory authorities in Germany:
- · Federal Institute for Drugs and Medical Devices (BfArM),
- to which the Federal Opium Agency and the Cannabis Agency subordinate
- the use of medical cannabis is regulated, the anticipated development means that the demand exceeds the available supply
- In Germany, due to the granted permits, <u>from Q4-20 onwards</u>, <u>an in-house</u>

 <u>production of only around 2.6 tons of medical cannabis per year will be created</u>
 own restriction for export promotion of the licensed and certified agricultural and industrial products from the developed and emerging countries
- via Germany, which is the largest EU market / certification and approval pioneer, the products can be also delivered to other EU countries
- · new major markets of Great Britain, India and China are being worked on
- the global market for medical cannabis is expected to reach a value of USD 200 billion by 2028 (equivalent to approximately 57,000t at a price of USD 3,500/kg)
- ECI mbH, the joint venture partner of CPharm AFGHAN Company, is currently negotiating export and sales agreements for 2022 for 50 tons (worth US \$ 175 million) of dried female cannabis flowers from licensed, certified greenhouse/indoor cultivation of medical cannabis for the markets of Germany, EU, Switzerland, Great Britain, as well as contracts for medical THC from licensed, certified field cultivation for the USA market (as of 15.02.2021, the USA market price of 1 litre of THC is US \$ 40,000) Contract value depends on the licence and quotation of the Afghan Ministery of Internal Afairs for the "Field cultivation / Contract Farming"



Research and development

So far, only 6% of studies on cannabis have analysed its medicinal properties. This number is increasing now as countries relax their stance on cannabis. This has led to a new wave of research focusing on the use of cannabis, the methods of use, improvements in the processing and sale of seeds.



2) Investment idea - Situation in global markets (continued) Global agricultural market - the future

A currently estimated, mainly illegal global market of USD 300 billion is moving into the regulated and taxable realm. So far, this market consists mainly of dry flowers and does not take into account the developing market for a wide variety of consumer goods.

Consumption rates will rise as new consumers emerge from sales of new value-added cannabis products and growing retail and e-commerce sales. It is expected that the introduction of cannabis as an ingredient in other products will result in a global market capitalization of USD 2 trillion in about a decade. (1)

3) Development potential of cannabidiol (CBD)

CBD is the abbreviation for cannabidiol, one of many ingredients of the hemp plant. In contrast to the hemp component THC (abbreviation for tetra-hydrocannabinol), CBD has no intoxicating (psychoactive) effect.

Cannabidiol is a non-psychoactive cannabinoid derived from cannabis. CBD has a relaxing, anti-inflammatory, anti-anxiety and anti-nausea effects. For example, CBD is not subject to the German Narcotics Act (BtMG) and is therefore completely legal.

The hemp plant is grown in open fields, the plant components, especially the flowers, are extracted after harvest in a complex process in which a CBD paste is produced, which is mixed with hemp oil in a next step to create a consumer product with different strengths of CBD. Other intoxicating components of the hemp plant are reduced or eliminated in the process to comply with the existing laws on narcotics.

The harvest usually takes place between August and November, the normal growth cycle allows one harvest per year.

Environmental parameters that can be controlled in the field include water supply, soil conditions and nutrient availability: the water supply through irrigation and drainage, the soil properties and nutrient availability through tillage, crop rotation and fertilization.

Compliance with these environmental parameters requires considerable effort, especially when allocating new cultivation areas, to the scope and intensity of the soil examinations and the water used in fields from which suitable plants are to be harvested



4) Investment Idea - Situation in the Islamic Emirate of Afghanistan (continued)

- The Islamic Emirate of Afghanistan has the Medical Cannabis Law Nr. 1284 since 2017 for production, processing, transport and export of pharmaceutical cannabis. The former Government had to implement the actual INCB, Vienna status from 12.2020 to upgrade the current law. They ignored it driven by excessive corruption, to adapt the new status and to issue the medical cannabis licence to the Pharmacy Industry. We applied offically for the Afghan Medical Cannabis Licence already in 2020.
- Initial discussions at the Federal Institute for Drugs and Medical Devices (BfArM) have indicated that the Islamic
 Republic of Afghanistan can be classified as an acceptable supplier of medical cannabis for Germany and the EU
 (among other things, all countries from which Germany or the EU import cannabis must comply with Articles 23 and 28
 of the 1961 International Single Convention on Narcotic Drugs).
- The objective is to build an ecological, sustainable value chain in agriculture and pharmaceutical industry in the Islamic Emirate of Afghanistan to provide a highly profitable and significant income alternative to the current No. 1 and 2 of the Afghan economy, mining and illegal poppy and cannabis industries for the international drug market. Due to the geographical location of Afghanistan, a 4 times larger medical cannabis harvest can be brought in per m² than, for example, in Morocco, the largest cannabis growing area in the world. The current cultivation areas for poppy seeds can also be switched to high-yield areas for medical cannabis production.
- The plan is to expand an extraction plant equipped with leading world-class technology and mobile units, following the special security situation on site, optimizing the most common products to be obtained from the hemp plant, CBD and THC, to be able to produce flexibly and in the highest quality. In a later phase of the project implementation, it is possible to extend the value chain to include pharmaceutical end products.
- Our reference project is located in Lesotho, it started with obtaining a license in 12/2018, in Q4- 2019 the greenhouse was completed and cannabis was planted indoor for the first time, in 2020, 4 crops were sold to Israel, Canada and USA (unaffected by COVID-19).

Use of cannabis plants from field cultivation

Suppliers for the hemp plants are local cooperatives & large farmers from almost half of the Afghan provinces who are already growing this plant on their fields. The respective cooperative & large farmer concludes a long- term supply contract with the CPharm AFGHAN Company; this supply contract ensures the cooperatives & large farmers a long-term, secure and legal income.

- The delivered hemp plants are checked for quality in a central processing centre. The relevant active ingredients (especially THC and CBD) are extracted from the accepted plants and mixed into finished products with exact proportions of the active ingredients.
- The products are subject to the highest requirements, as more and more quality assurance is required globally, also for CBD to be used as a food supplement with a CE certificate ("Marketability") see Appendix 4 "Quality requirements for CBD".
- To ensure a high-quality input, the CPharm AFGHAN Company sets standards for soil quality and supplies the cooperatives / large farmers with selected seeds and defines procedures regarding the treatment of the plants, their irrigation and fertilization.
- ECI mbH, the joint venture partner, is currently switching the world's largest cannabis field
 cultivation area of 200,000 hectares of illegal cannabis for the drug market into a high-yield,
 sustainable, licensed and certified cannabis field cultivation for medical THC & novel food CBD
 production by the order of the Moroccan king, see Appendix 5 "State treaty for Morocco complete
 legal package on Medical Cannabis including development of the state infrastructure & licensed
 and certified "field cultivation/contract farming" of medical cannabis".
- These clear structures ensure the use of further development programs from Donor countries to switching agriculture from illegal drug cultivation to medical THC & novel food CBD production which will start in <u>Balkh province</u>.

5) Security concept

An advantage is that the cultivation, processing and pharmaceutical production are carried out 100% indoor. We have the technology to produce medical grade cannabis without external lighting. This is done **anonymously** and **in closed buildings that are not visible from the outside.**

To immidiately start, Hairatan is the right place for the laboratory and high tech factory, where german specialists and technicians can easily travel and accommodate. The Islamic Emirate of Afghanistan can build a modern economic hub in which we, together with the relevant ministries of the Islamic Emirate of Afghanistan, will establish the safest location in the world for the production, processing and transport of medical cannabis.





Managing Director was in Afghanistan in Nov 2020, after applying for medical cannabis license, we checked the illegal drugs Cannabis fields in Pandshir Vally where former Government had full control! Hairatan is a secured economic zone in Balkh province with good infrastructure that can potentially be an economically convinient location to start this operation.


The specifics of the security concept in field cultivation are due to the existing larger outdoor areas. Required:

- Sophisticated area monitoring by using different sensors
- Reduction of false alarms
- Software for risk analysis and optimization of response times

The security concept combines fully automatic monitoring and problem detection solutions with technical possibilities for deescalation, deterrence and deployment of security forces and with the involvement of the Ministry of the Interior, for these facilities to become the safest fields in the country.

The concepts and technical solutions are available, the Entwicklungsgesellschaft CPharm International mbH can draw on experience, know-how and external suppliers for security technology.






Industry comparison by yield

Approval processes of the exporting country with the UN & the 30 importing countries



The import and export of cannabis products with a high THC content is subject to strict national and international regulations as a narcotic, which are monitored by the institutions set up for this purpose in the respective state.

Export country



In order to be authorised to export to the EU, Switzerland, UK and the USA, the exporting state Islamic Emirate of Afghanistan has to fulfill a number of requirements, which have to be confirmed by the competent authority of the respective importing state in the form of a positive decision. To this end, the competent Ministry of the Interior in the Islamic Emirate of Afghanistan must submit a corresponding application to the respective authorities in the 30 states. The essential guideline for the approval process is the United Nations is 1961 "Single Agreement on Narcotic Drugs" and prior accession to it. In particular, the question of whether the cultivation of cannabis plants in the country is completely under state control is examined.



Every producer from the exporting country Afghanistan who wants to export products as medical cannabis to the 30 importing countries can only apply for this in the respective importing countries after the Islamic Emirate of Afghanistan is listed there as an exporting country. Only then can a producer in the Islamic Emirate of Afghanistan, with a valid Afghan Medical Cannabis license and EU-GMP certification, register in the respective importing country and subsequently have their respective products listed there in a further procedure.

Dutch cannabis policies set the precedent

Over the past half century. The Netherlands has been the European frontrunner in terms of cannabis policies, allowing coffee-shops to establish in the mid-70s and licensing companies to grow cannabis for therapeutic purposes since 2003, a decade before anyone else in Europe. Even if it is still a criminal offence to sell cannabis, coffee-shops and small-scale possession are largely tolerated.

In early 2018, the Dutch Parliament passed legislation to allow between five and ten licensed growers to supply local adult-use programmes, which will take place in ten municipalities of the country. In July 2020, the government started receiving applications, which has attracted attention from North American LPs, who are keen to take a foothold in the European recreational market.

The Dutch government predicts that the programme will require 56 tonnes of cannabis per year to supply the experiment, which only involves 80 of the estimated 570 coffee-shops in the country. Projections are likely on the high-end, but this level of demand is five times more than the current legal supply of medical cannabis across the whole of Europe, and almost 100 times the demand of the Dutch medical scheme
