1. INTRODUCTION

a. General

The purpose of this report is to provide an overview of ENFM IRINI Capacity Building & Training (CB&T) provided to Libyan Coast Guard and Navy (LCG&N) through the monitoring mechanism performed along three strands: information collection, remote monitoring and meetings with Libyan authorities. The aim of CB&T is to improve the LCG&N capability in law enforcement tasks at sea, in particular to prevent human smuggling and trafficking and in Self-Managing Safety of Life at Sea (SOLAS) / Law Enforcement (LEF) events in the Libyan Search and Rescue (SAR) area of responsibility.

Since 2016, during Operation SOPHIA, EUNAVFOR MED carried out capacity building and training activities in favour of the LCG&N. That effort demonstrated its effectiveness to deliver and enhance LCG&N capabilities to take ownership of their functions, ultimately improving the maritime security within the Libyan SAR area of responsibility. The LCG&N proved to be a key responsive actor, who reacted very promptly to the provision of training starting delivering effects to influence the Smuggling Business Model (by its enhanced presence at sea), and to take on full responsibility of Libyan SAR.

Operation ENFM IRINI intends to support the development of the LCG&N by providing capacity building and training to allow them the establishment of a Safe and Secure Environment (SASE) at sea, being the main actor substantially contributing to the security of the area.

b. Current situation

Operation ENFM IRINI's current intent is to continue to develop the capacity building and training secondary task, expanding upon broader Capacity Building aspects in light of the newly established European Peace Facility (EPF) instrument. IRINI is developing a Capacity Building Concept and Plan to submit for the MSs and Libyan approval. This plan has been developed in the framework of the EU integrated approach which also comprises other EU Civil efforts including the improvement of organizational, sustainability and equipment areas. With regard to the provision of equipment, the EU, through the SIBMMIL project-Phase II, is planning the delivery of three (3) patrol vessels (the first one – originally intended for August 2020 – shifted and should be delivered in early 2022, the second one before the end of 2022 and the third in 2023) and a containerized MRCC (in December 2021). Operation ENFM IRINI may effectively implement the EU initiatives currently on-going.

The above-mentioned ENFM IRINI's intent is reinforced by the higher priority given to the LCG&N Capacity Building and Training in the last Strategic Review, as it has also been reflected in the new revised Political End State assigned to Operation ENFM IRINI: "[...] LCG&N has developed the necessary capacities to perform its functions with minimum or no support from other actors and according to the expected international standards".

Once the signature of MoU with Libyan authorities will be signed, the CB&T Concept and Plan will be approved by MSs and shared with the Libyan counterparts to put into effect. Through the implementation of the Capacity building Plan IRINI will deliver essential equipment and training that will enhance the capabilities of LCG&N to autonomously fulfil the full spectrum of related functions and responsibilities, linked with both the establishment of a SASE at sea and a Search and Rescue activity, in line with international standards.

2. LCG&N CAPACITY BUILDING

a. EUNAVFOR MED training to LCG&N:

ENFM IRINI designed a capacity building plan in favour of the LCG&N. This plan includes a set of SAR CB & T activities divided into three (3) main different areas of development: operational sector, maintenance sector, logistic and supply sector. In this regard, a political support is necessary to increase the confidence of Libyan authorities in implementing ENFM training plan, also useful in re-orienting the LCG&N towards proper behavioural standards that should be compliant with human rights, especially when dealing with irregular migrants. Given the political stalemate that is impeding the re-commencement of the training activity, IRINI included inside the Capacity Building Plan all the related training that will complement the provision of the means and equipment to the LCG&N. A Libyan approval of IRINI CB&T Plan will be essential to determine the current (and future) priority-based program and will also determine a smooth and coordinated implementation, enhancing a coherent development of the LCG&N capacities in all relevant areas (operational, technical, and logistic), ultimately enabling the midterm self-sustainability of SAR and other functions of responsibility. The plan has been elaborated in order to be gradually implemented, with an incremental posture that can be regulated based on the Libyan response.

The newly established EPF instruments will therefore enable ENFM IRINI to implement its capacity building and training secondary task, in providing means and equipment to enhance the development of the LCG&N and in attempting an additional approach to overcome Libyan political scepticism.

3. ACTIVITY MONITORING

a. Operating Areas




Figure 1 - LN&CG Area of activity (AOA)

The LCG&N area of activity (AOA) is currently limited to the western part of the Libyan Search and Rescue (SAR) (figure 1).

b. LCG&N activities:

- The performances of LCG&N vessels to conduct SAR operations are likely affected by the safety and preventive COVID-19 measures.
- (2) Only one (1) PV AL KIFAH is still in LA VALLETTA (MT) for maintenance. The PV SABRATHA, which was in maintenance in CATANIA (IT), has been operational since the 20th of August 2021. On 18th of October the corvette SHIFAK after over 14 months in BIZERTE (TN) for fixing went back operational.
- (3) During the reported time frame, one hundred thirty three (133) patrol activities by LCG&N, which departed principally from TRIPOLI (LY), then from AL KUMS (LY) and AL ZAWIYAH (LY) were recorded. The largest number of sorties were performed by PV ZAWAYAH (35 sorties) which responded to 35 SOLAS events, PV SABRATAH (27 sorties) which responded to 30 SOLAS events, PV OBARI (25 sorties) which responded to 14 SOLAS events, PV AL SADADA (15 sorties) which responded to 3 SOLAS events, PV FEZZAN (11 sorties) which responded to 6 SOLAS events, PV RAS AL JADAR (10 sorties) which responded to 13 SOLAS events, PV ZUWARAH (5 sorties) which responded to 2 SOLAS events, PV SIDI BILAL (3 sorties) which performed none SOLAS event, PV TALIL (1 sortie) which responded to 1 SOLAS event and finally PV IBN HARITA (1 sortie) without any response to SOLAS event. The longest sortie was performed by LCG PV ZAWIYAH between the 10th and 13th of August, with more than 62 hrs at sea. (Annex B).
- (4) According to ENFM IRINI database, during the reported period a total amount of 17612 migrants departed from Libyan territory: a slight decrease of about 3% compared to the previous four monthly (when the figure was 18196) with a further important increase of 95% compared to Aug-Nov 2020 (9030).

- (5) According to ENFM IRINI database, LCG&N demonstrated to be constantly active, taking part in 108 SOLAS events departing from Libyan coasts. Four activities were conducted by them without any further indications on the name of vessels by which they were performed.
 - The LCG&N has thus continued to show an acquired operational capability to respond to SOLAS events in their territorial waters and Search and Rescue Area, rescuing 5265 migrants that amounts to 30% of all migrants departed from Libya.
- (6) Besides its different role and functions, in the last period, ENFM IRINI registered some SAR activities carried out by the General Administration for Coastal Security (GACS) of the Ministry of Interior: according to ENFM IRINI database in the referred period, the GACS conducted fourteen (14) SOLAS events rescuing 667 migrants.
- (7) The amount of people rescued combined by LCG&N and GACS (5942) represents 34% of all migrants departed from LIBYA (17612) from August to November 2021.
- (8) According to OHQ JOC database, on 24th of August, Libyan MRCC coordinated the operation for rescuing a Libyan fishing vessel crew with fire on board by Libyan PV FEZZAN. In this operation 11 fishermen were saved and disembarked in TRIPOLI (LY).
- (9) According to ITA MRCC database, on 6th and 25th of September, two (2) SOLAS event were performed in the GULF OF SIRTE with boats provided by the port authority of BENGHAZI (LY). ITA MRCC directly coordinated both operation for rescuing migrants on a wooden boat and a total of 77 people disembarked in BENGHAZI (LY).
- (10) According to FRONTEX report, on 15th of September, LCG&N asset (PV ZAWYAH) performed a SOLAS event inside their SAR area. Analysing the photos provided inside their mission report, it is evident that during this activity the PV intercepted a blue WB with approximately 20 migrants on board, using TTPs never observed before and not in compliance with the training provided by ENFM OP. SOPHIA as well as international regulation.
- (11) On 18th of October, LCG&N performed three (3) SOLAS events (two made by PV FEZZAN and one by PV AL SADADA) in which the first spotter was the NGO vessel SEA WATCH 3.

c. LCG&N responsiveness to EUNAVFOR MED engagement (Annex D):

- (1) KLE: No engagements have been possible during the reported period.
- (2) Communication flow: the scheduled regular communication engagements (141 in total) resulted in 64 exchanges of information via phone and social media (45% of total).

4. ASSESSMENT AND CONCLUSION

- a. It is confirmed that the LCG&N rescue activity in this reported period showed its achieved level of capability to perform SOLAS in the Libyan Territorial Water and SAR Area of responsibility rescuing a total of 5265 migrants in 108 SOLAS events.
- The number of SOLAS events performed by LCG&N in the period August November 2021 compared to the same period last year has greatly increased (+93%):
 - Aug Nov 2021: 108 SOLAS events;
 - Aug Nov 2020: 56 SOLAS events.
- According to ENFM IRINI database, ten (10) different LCG&N units have been operative.
 During the reported period, an average of six (6) LCG&N naval assets were recorded as

operational, with a peak of nine (9) in August 2021. These numbers display a clear enhancement in terms of performance and effectiveness. However, during the last three months (from September to November 2021), a decreased number of vessels at sea has been observed compared to previous months of the same period. It's likely that the decreased number of patrol vessels used in patrolling was determined by technical issues not better specified.

- d. During the reported time frame, several NGO vessels (OCEAN VIKING, GEO BARENTS, SEA WATCH 3, SEA WATCH 4, SEA EYE 4. AITA MARI and RISE ABOVE) have operated search and rescue activities principally nearby the limit of Libyan territorial waters.
- e. Regarding the four SOLAS events performed by unknown LCG&N assets, the lack of Liaison Officers inside the Libyan MRCC and ongoing training reduced the capacity of ENFM IRINI OHQ to monitor directly their activities and provide a more adherent assessment on their own capabilities achieved. Despite continuous contacts between ENFM IRINI and MRCC LY aimed at strengthening information exchanges on their activities, it was impossible to receive the name of LCG&N assets that were involved in these four SOLAS events (three in August and one in October).
- f. During the SOLAS events observed by FRONTEX air assets on 15th of September, the behaviour shown by LCG&N PV's crew, when the migrant boat was engaged, indicates that the training received during ENFM OP. SOPHIA is still visible but no longer fully followed. The excessive use of physical force by LCG&N against migrants for example may be seen as a consequence of the political stalemate on the start of IRINI Capacity Building and training activities.
- g. The SOLAS events performed by port authority of BENGHAZI (LY) assets in the East side of gulf of SIRTE and coordinated directly by IT MRCC in ROME (IT), showed a probable lack of contact and coordination between the Libyan MRCC and the maritime authorities in the Eastern part of LIBYA. The elections planned in December could result in a LY MRCC able to coordinate all SOLAS events in the entire Libyan SAR Area of responsibility.


