On January 21, 2022 at around 2000 hours, APD responded to a call for a N. Bliss Street. When officers arrived they found victim S.P. had suffered a gunshot wound to the head. She was transported to Providence hospital. Witnesses on scene stated that they had observed a grey truck approach a Jeep (AK ) and that they heard one or two gunshots. Officers observed that the back window of the Jeep had been mostly shattered.

Detectives interviewed multiple witnesses and victims. They were told that one of the passengers in the truck, minor M.P. had been arranging for his girlfriend and S.P. to meet and fight or argue. The passengers in the truck were S.P. his brother SAMMY PHANLY, the driver MICHAEL PATRICK, and a man identified as "Sauce." Earlier in the day and the day prior, SAMMY PHANLEY, MICHAEL PATRICK, M.P., and others had picked Sauce up. Sauce was in possession of an AR-style rifle, which both M.P. and MICHAEL PATRICK had wanted to see.

Later in the evening, SAMMY PHANLY, MICHAEL PATRICK, M.P., and Sauce went to meet up with S.P. and the passengers of the Jeep. M.P. called a passenger in the Jeep to ascertain their location. Just a few moments after that, the passengers in the Jeep observed the grey pickup drive by. As it did, Sauce, who was sitting in the rear passenger seat, fired his gun out the window at the Jeep, shooting S.P. in the head and placing the other passengers of the vehicle in fear.

At that point, the grey pickup drove away. No one in the vehicle stopped to offer assistance. No one in the vehicle called 911 or reported the incident.
