The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Aggravated Robbery-1st Degree

Minnesota Statute: 609.245.1, with reference to: 609.245.1, 609.05.1, 609.05.2

Maximum Sentence: 20 YEARS AND/OR \$35,000

Offense Level: Felony

Offense Date (on or about): 12/24/2021

Control #(ICR#): 21293308

Charge Description: That on or about December 24, 2021, in Hennepin County, Minnesota, Isaiah Jamal Foster, acting alone or intentionally aiding, advising, hiring, counseling or conspiring with another or otherwise procuring the other to commit the crime, took personal property from the person or in the presence of Victim G.M.L.D., knowing that he was not entitled to the property and used and/or threatened the imminent use of force against Victim G.M.L.D. to overcome her resistance or powers of resistance to or to compel acquiescence in the taking or carrying away of the property, while using an article used or fashioned in a manner to lead the victim to reasonably believe it to be a dangerous weapon.

Charge Description: That on or about December 24, 2021, in Hennepin County, Minnesota, Isaiah Jamal Foster acting alone or intentionally aiding, advising, hiring, counseling or conspiring with another or otherwise procuring the other to commit the crime, used or attempted to use a financial transaction card to obtain property of another or a public assistance benefit issued for the use of another, without the consent of the cardholder, knowing that the cardholder had not given consent, and the property had a total value of less than Two Hundred and Fifty Dollars (\$250.00).



STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On December 24, 2021, Minneapolis Police received phone calls about two incidents that occurred near each other on the 3400 block of Columbus Avenue South in Minneapolis, Hennepin County, Minnesota.

At approximately 11:00 a.m., adult female Victim G.M.L.D. was walking from her garage to her house on the 3400 block of Columbus Avenue South. Two Black males and one Black female in their late teens pushed Victim G.M.L.D. to her stomach in her front yard. The male suspect on Victim G.M.L.D.'s right side pulled a knife and put it against her neck and cheek. The three suspects punched, kicked, and pulled Victim G.M.L.D.'s hair. Victim G.M.L.D.'s saw her neighbor across the street and yelled for help. The suspects pulled Victim G.M.L.D.'s purse from her body. Victim G.M.L.D.'s purse contained her cell phone, identification card, and credit and debit cards.

Adult female Victim B.C.G. was walking to her Nissan Altima car parked on the 3400 block of Columbus Avenue South when she heard Victim G.M.L.D. screaming for help and calling for 911. The male on Victim G.M.L.D.'s right side who held a knife to Victim G.M.L.D.'s face ran across the street toward Victim B.C.G., who was frozen in a state of shock. That Black male took Victim B.C.G.'s car keys from her hand. The suspect who stole Victim B.C.G.'s car keys drove away while another male and a female ran through yards toward the Nissan Altima.

Victim G.M.L.D. went to the emergency room for treatment after the robbery and learned that she suffered injuries to the tendons in the fingers on her right hand (a Boutonniere deformity). Victim G.M.L.D.'s fingers remain fractured as of a January 3, 2022 follow-up appointment and she was advised to continue wearing a splint on her right hand.

Victim G.M.L.D. learned that there was activity on her two stolen U.S. Bank cards at 11:28 and 11:32 a.m. on December 24, 2021 at the Holiday Station Store located at 1624 Washington Avenue North. Google Maps shows the 3400-block of Columbus Avenue to that Holiday Station Store is a nine-minute drive.

The MPD Investigator watched surveillance video from that Holiday Station Store at the time of the purchases on Victim G.M.L.D.'s U.S. Bank cards. Those videos show the stolen Nissan Altima arriving at a gas pump at 11:26 a.m. with two male occupants in the car. The MPD Investigator recognized the males as ISAIAH JAMAL FOSTER, Defendant herein, and E.J.E., Co-Respondent herein. Defendant walked inside the Holiday Station Store and used Victim C.M.L.D.'s U.S. Bank credit card to buy \$125 in Apple and Sony PlayStation gift cards. Co-Respondent E.J.E. remained with the Nissan Altima and used Victim G.M.L.D.'s U.S. Bank debit card to purchase \$44.26 in fuel. Both Defendant and Co-Respondent then drove away in the Nissan Altima.

At approximately 4:21 p.m. on December 24, 2021, Defendant and Co-Respondent used the stolen Nissan Altima to jump out at a single adult female in a parking lot in Columbia Heights, Anoka County, Minnesota. A high-definition surveillance video from the building clearly shows the perpetrators accosting the victim. The MPD Investigator watched that video and recognized the driver of the Nissan Altima as Co-Respondent E.J.E. and recognized the passenger as Defendant. The MPD Investigator later showed Victim B.C.G. a video of the Columbia Heights robbery, and Victim B.C.G. explained that Defendant was the person who took the keys from her hand and stole her Nissan Altima.

On December 28, 2021, Ramsey County Sheriff's Office arrested Defendant in Minneapolis following

another carjacking and robbery spree. Defendant's jacket found near the site of his arrest matched the/31/2022 jacket worn by Defendant on December 24, 2021 at the Holiday Station Store and worn by Defendant later on December 24, 2021 during the attempted robbery in Columbia Heights.

Defendant is currently incarcerated. This warrant is to issue via warrant due to Defendant's immense threat to public safety and inability to appear at an out-of-custody summons.
