On Friday, October 9th, 2015 at approximately 9:30pm at Couch Field, I saw several of my former students. The students had come to Couch Field to watch the North Dallas High School Football team. One of the students that I saw was [REDACTED].

[REDACTED] student ID number was [REDACTED] [REDACTED] [REDACTED]

I was in the stands after halftime when I heard [REDACTED] and [REDACTED] call my name. I walked over to speak with them and asked them how they were doing [REDACTED]. During this conversation, [REDACTED] said, "[REDACTED], something weird happened." I asked [REDACTED] what had happened and [REDACTED] said that [REDACTED] had gotten a Facebook message from Bardia Namdarkhan, former NDHS teacher and soccer coach. The Facebook message, while I didn't see it, said something to the effect of, "Hey! How are you doing."

However, the real concern came a few moments later as [REDACTED] recounted two instances of inappropriate conduct on the part of Bardia Namdarkhan. She stated that this was not the first time Bardia Namdarkhan had made [REDACTED] uncomfortable.

[REDACTED] stated that [REDACTED] was once a [REDACTED], and on a Sunday evening during soccer season (she didn't give an exact date), Coach Namdarkhan asked [REDACTED] to come to the locker room to discuss the soccer team. She stated that she told him it could wait until Monday, but he became irritated and insisted she come. He pressured [REDACTED] by saying [REDACTED] wasn't being a good [REDACTED]. [REDACTED] did not go to North Dallas that evening.

█ then leaned over to me with █ hand over █ mouth and whispered another story in my ear. It was difficult to understand:

There was an instance last year when Bardia Namdarkhan sexually harassed █ by touching █ bottom. █ stated that █ reacted to the inappropriate advance by snapping at Bardia Namdarkhan and told him, “[he] had better not do that ever again!” After that, █

The events surrounding the sexual harassment were difficult to understand given that █ was whispering. █ did not want █ friends around █ to hear what █ was saying. I picked up on the word “cheerleader” and it seemed like this might have taken place at an event sponsored by the cheerleaders, but as I said, it was very difficult to understand, and the setting of this incident was unclear.

I told █ that █ should have reported these incidents to a teacher or principal. As the football game concluded, █ asked me not to say anything, or to use █ name, but since the sexual harassment was done by an educator to a student, who was 17 at the time, I feel compelled by my ethical standards, as well as state and federal law to report this to the proper authorities.
