Before Me, the undersigned authority personally appeared Russ Howard who being duly sworn, alleges, on information and belief, that on the 15 day of MAY, 2019 in Citrus County, Florida the defendant did:

DID UNLAWFULLY, ACTUALLY, AND INTENTIONALLY TOUCH OR STRIKE VICTIM TOMPKINS, THE DEFENDANT'S STEP-GRANDFATHER WHO IS 65 YEARS OF AGE OR OLDER, AGAINST HIS WILL OR INTENTIONALLY CAUSE BODILY HARM TO SAID PERSON, AND IN THE COMMISSION OF SAID BATTERY DID INTENTIONALLY OR KNOWINGLY CAUSE GREAT BODILY HARM, PERMANENT DISABILITY, OR PERMANENT DISFIGUREMENT TO SAID PERSON, TO WIT: PUNCHED VICTIM TOMPKINS IN THE FACE, TRIPPED HIM, AND THEN KICKED HIM IN THE FACE, IN VIOLATION OF FLORIDA STATE STATUTE 84.045(1)(A)(1).

DID UNLAWFULLY COMMIT BATTERY UPON VICTIM TOMES, THE DEFENDANT'S GRANDMOTHER, WHO IS 65 YEARS OF AGE OR OLDER, BY ACTUALLY AND INTENTIONALLY TOUCHING OR STRIKING SAID PERSON AGAINST SAID PERSON'S WILL, OR BY INTENTIONALLY CAUSING BODILY HARM, TO WIT: PUSHED VICTIM TOMES AGAINST THE WALL, IN VIOLATION OF FLORIDA STATE STATUTE 84.08(2)(C).

DID UNLAWFULLY COMMIT BATTERY UPON VICTIM REDMAN, THE DEFENDANT'S BROTHER, BY ACTUALLY AND INTENTIONALLY TOUCHING OR STRIKING SAID PERSON AGAINST SAID PERSON'S WILL, OR BY INTENTIONALLY CAUSING BODILY HARM, TO WIT: PUSHED VICTIM REDMAN IN THE FACE, IN VIOLATION OF FLORIDA STATE STATUTE 84.03(1)(A)(1).

DID KNOWINGLY USE INTIMIDATION OR PHYSICAL FORCE, OR THREATEN ANOTHER PERSON OR ATTEMPT TO DO SO, OR ENGAGE IN MISLEADING CONDUCT TOWARDS ANOTHER PERSON, WITH THE INTENT TO CAUSE OR INDUCE ANY PERSON TO HINDER, DELAY, OR PREVENT THE COMMUNICATION TO A LAW ENFORCEMENT OFFICER RELATING TO THE COMMISSION OR POSSIBLE COMMISSION OF AN OFFENSE TO WIT: PHYSICALLY TOOK VICTIM TOMES CELLULAR TELEPHONE FROM HER BY FORCE, IN VIOLATION OF FLORIDA STATE STATUTE 914.22(1)(E).

DID KNOWINGLY USE INTIMIDATION OR PHYSICAL FORCE, OR THREATEN ANOTHER PERSON OR ATTEMPT TO DO SO, OR ENGAGE IN MISLEADING CONDUCT TOWARDS ANOTHER PERSON, WITH THE INTENT TO CAUSE OR INDUCE ANY PERSON TO HINDER, DELAY, OR PREVENT THE COMMUNICATION TO A LAW ENFORCEMENT OFFICER RELATING TO THE COMMISSION OR POSSIBLE COMMISSION OF AN OFFENSE TO WIT: PHYSICALLY TOOK VICTIM REDMAN'S CELLULAR TELEPHONE FROM HIM BY FORCE, IN VIOLATION OF FLORIDA STATE STATUTE 914.22(1)(E).

TO [REDACTED] IN INVERNESS, IN REFERENCE TO A DOMESTIC ALTERCATION.

UPON ARRIVAL, WE WERE ADVISED THAT THE DEFENDANT, LATER IDENTIFIED AS MR DANIEL REDMAN, HAD ALREADY FLED THE SCENE ON FOOT.

A SHORT TIME LATER, WHILE CONDUCTING THE PRELIMINARY INVESTIGATION, I MADE CONTACT WITH THE VICTIM, MR FRED TOMPKINS IV. VICTIM TOMPKINS HAD SWOLLEN EYES, WAS BLEEDING PROFUSELY FROM THE FACE, AND HAD A LARGE GASH OVER HIS LEFT EYE. I THEN OBTAINED A SWORN AUDIO RECORDED STATEMENT FROM VICTIM TOMPKINS. VICTIM TOMPKINS ADVISED THAT THE DEFENDANT LIVES WITH HIM AT THE RESIDENCE, ALONG WITH THE DEFENDANT'S GRANDMOTHER AND BROTHER. HE STATED THE DEFENDANT CAME INTO THE HOUSE CLAIMING SOMEONE WAS SHOOTING IN THE BACK OF THE HOUSE. VICTIM TOMPKINS ADVISED THE DEFENDANT THAT THEY HEAR GUNSHOTS BEHIND THE HOUSE ALL THE TIME AND FOR HIM NOT TO WORRY ABOUT IT. HE STATED THE DEFENDANT THEN "WENT BALLISTIC." VICTIM TOMPKINS FURTHER EXPLAINED THAT THE DEFENDANT PUNCHED HIM IN THE FACE, TRIPPED HIM, AND THEN KICKED HIM IN THE FACE WHILE HE WAS DOWN ON THE FLOOR IN THE HALLWAY OF THE RESIDENCE, CAUSING THE OBSERVED INJURIES TO HIS FACE. IT SHOULD BE NOTED THAT VICTIM TOMPKINS IS A 68-YEAR-OLD DOUBLE AMPUTEE AND DISABLED. VICTIM TOMPKINS IS THE HUSBAND OF THE DEFENDANT'S GRANDMOTHER, WITH WHOM THEY BOTH RESIDE.

I THEN MADE CONTACT WITH VICTIM TOMPKINS'S WIFE, MS JANET TOMES, LATER IDENTIFIED AS THE VICTIM. VICTIM TOMES PROVIDED A SWORN AUDIO RECORDED STATEMENT THAT CORROBORATED VICTIM TOMPKINS'S SEQUENCE OF EVENTS. SHE ALSO ADVISED THAT, DURING THE ALTERCATION, THE DEFENDANT TOOK CELLULAR TELEPHONES AWAY FROM HER AND THE DEFENDANT'S BROTHER WHILE THEY WERE TRYING TO CALL LAW ENFORCEMENT TO RESPOND TO THE HOUSE. IT SHOULD BE NOTED THAT VICTIM TOMES IS THE DEFENDANT'S GRANDMOTHER AND IS 68 YEARS OF AGE.

I THEN OBTAINED A SWORN AUDIO RECORDED STATEMENT FROM THE DEFENDANT'S JUVENILE BROTHER, BRENDEN REDMAN, WHO CORROBORATED VICTIM TOMPKINS'S SEQUENCE OF EVENTS. VICTIM REDMAN ADVISED THAT, WHEN HE WENT INTO HIS BEDROOM TO CALL THE POLICE, THE DEFENDANT CAME INTO THE BEDROOM, GRABBED HIM, PUSHED HIM IN THE FACE, AND TOOK HIS CELLULAR TELEPHONE AWAY FROM HIM. VICTIM REDMAN FURTHER ADVISED THAT, WHEN VICTIM TOMES ATTEMPTED TO CALL LAW ENFORCEMENT FROM HER CELLULAR TELEPHONE, THE DEFENDANT PUSHED HER AGAINST THE WALL AND TOOK HER CELLULAR TELEPHONE AWAY FROM HER TO ALSO PREVENT HER FROM CALLING FOR LAW ENFORCEMENT ASSISTANCE. VICTIM REDMAN STATED THE DEFENDANT LEFT THE SCENE ON FOOT.

THE DEFENDANT WAS LATER LOCATED AT THE CORNER OF NORTH ROOKS AVENUE AND EAST JOHN LANE, IN INVERNESS, BY LIEUTENANT NOVY (0221). THE DEFENDANT WAS THEN TRANSPORTED BACK TO THE SCENE.

I TOOK PHOTOGRAPHS OF VICTIM TOMPKINS'S INJURIES, WHICH WERE LATER UPLOADED TO QUETEL; SEE MY CRIME SCENE TECHNICIAN REPORT FOR FURTHER. ALL SWORN AUDIO RECORDED STATEMENTS WERE LATER UPLOADED TO QUETEL.

CONTACT WAS THEN MADE WITH THE DEFENDANT, AT WHICH TIME HE WAS READ HIS MIRANDA RIGHTS VIA PREPRINTED AGENCY CARD. THE DEFENDANT THEN STATED HE NEEDED TO CALL A LAWYER. THERE WAS NO FURTHER QUESTIONING AT THAT TIME.

THE DEFENDANT WAS THEN PLACED UNDER ARREST, HANDCUFFED (DOUBLE LOCKED), BEHIND THE BACK, SECURED IN THE REAR OF MY PATROL VEHICLE, AND TRANSPORTED TO THE CITRUS COUNTY DETENTION FACILITY FOR BOOKING AND PROCESSING. THE DEFENDANT'S CLOTHES WERE OBTAINED AS EVIDENCE AND LATER TURNED IN TO CITRUS COUNTY SHERIFF'S OFFICE EVIDENCE BY DEPUTY SAAYMAN (1340).

THE VICTIMS WERE PROVIDED WITH DOMESTIC VIOLENCE AND CASA PAMPHLETS AND AN EXEMPTION FROM PUBLIC RECORDS FORM WAS COMPLETED BY THIS DEPUTY.

THE DEFENDANT'S BOND WAS SET AT NONE FOR ONE COUNT OF AGGRAVATED DOMESTIC BATTERY, NONE FOR ONE COUNT OF DOMESTIC BATTERY ON PERSON 65 YEARS OF AGE OR OLDER, NONE FOR ONE COUNT OF DOMESTIC BATTERY, AND \$2,000.00 FOR EACH OF TWO COUNTS OF HINDER/DELAY COMMUNICATION TO LAW ENFORCEMENT OFFICER. DUE TO THIS INCIDENT BEING DOMESTIC IN
