THE DISTRICT ATTORNEY CHARGES:

COUNT I

That in the Third Judicial District, State of Alaska, on or about February 13, 2022, at or near Anchorage, COREY LEIF AHKIVGAK recklessly caused serious

1 physical injury to [REDACTED] by means of a dangerous instrument.

2 All of which is a class A Felony offense being contrary to and in violation of
3 AS 11.41.200(a)(1) and against the peace and dignity of the State of Alaska.

5 **COUNT II**

6 That in the Third Judicial District, State of Alaska, on or about February 13,
7 2022, at or near Anchorage, COREY LEIF AHKIVGAK having no right to do so or any
8 reasonable ground to believe the defendant had such a right, with intent to damage
9 property of another, damaged property of another in an amount less than \$250.

10 All of which is a class B Misdemeanor offense being contrary to and in violation
11 of AS 11.46.486(a)(2) and against the peace and dignity of the State of Alaska.

13 **COUNT III**

14 That in the Third Judicial District, State of Alaska, on or about February 13,
15 2022, at or near Anchorage, COREY LEIF AHKIVGAK, having been charged with, or
16 convicted of a crime, violated a condition of release imposed by a judicial officer under
17 AS 12.30, other than the requirement to appear as ordered by a judicial officer; release in
18 3AN-22-01056CR.

19 All of which is a class B Misdemeanor offense contrary to and in violation of
20 AS 11.56.757(a) and against the peace and dignity of the State of Alaska.

21 The undersigned swears under oath this Information is based upon a review of
22 police report 22-4989 submitted to date, a review of court records, a review of
23 Department of Corrections records, and a telephone conversation with [REDACTED].

24 COREY AHKIVGAK found incompetent by the Superior Court on 5 January
25 2022. 3AN-21-09041CR. In that matter COREY AHKIVGAK had been charged with
26 assaulting women at random. COREY AHKIVGAK released from custody 6 January
27 2022.

1 On 10 February 2022 Anchorage Police contacted COREY AHKIVGAK, he
2 was not arrested, police forwarded charges to Municipal prosecutors, and COREY
3 AHKIVGAK was on his on recognizance with orders to obey all laws with a court date of
4 4 April 2022. 3AN-22-01056CR.

5 On 13 February 2022 at approximately 3:26pm Anchorage Police responded to
6 the Loussac Library reference a stabbing. Police located the victim, [REDACTED], with a
7 Leatherman multi-tool stabbed into her back, she was provided aid and transported to
8 Providence Alaska Medical Center for emergency treatment.

9 Police observed surveillance video of the incident. The footage shows the
10 suspect standing the cage section of the library lobby next to a table. [REDACTED] and a male
11 (identified as her boyfriend [REDACTED]) are standing at the book drop with their backs
12 to the lobby area. The suspect walks up behind them and stabs [REDACTED] in the middle of her
13 back and the suspects runs out of the south doorway. [REDACTED] immediately falls into
14 [REDACTED] arms, a security guard runs out after the suspect but soon comes back and begins
15 helping [REDACTED].

16 With this information police began searching for the suspect. Police located the
17 suspect near 36th Avenue and Cottonwood, took him into custody, and identified him
18 as COREY AHKIVGAK. COREY AHKIVGAK was transported to Anchorage Police
19 headquarters and placed in an interview room. While in the interview room COREY
20 AHKIVGAK broke the table in the room, causing damage under \$250.00. Police
21 remanded him to the Anchorage Correctional Complex.

22 Police recovered the Leatherman at the hospital, it has a 3-4 inch serrated blade.

23 Under-signed spoke with [REDACTED] on 14 February 2022. [REDACTED] reports
24 [REDACTED] is admitted to the intensive care unit, she has lost feeling in some of her
25 extremities, and the injury is to her spinal cord.
