On 10 February 2022 Anchorage Police contacted COREY AHKIVGAK, he was not arrested, police forwarded charges to Municipal prosecutors, and COREY AHKIVGAK was on his on recognizance with orders to obey all laws with a court date of 4 April 2022. 3AN-22-01056CR.

On 13 February 2022 at approximately 3:26pm Anchorage Police responded to the Loussac Library reference a stabbing. Police located the victim, , with a Leatherman multi-tool stabbed into her back, she was provided aid and transported to Providence Alaska Medical Center for emergency treatment.

Police observed surveillance video of the incident. The footage shows the suspect standing the cage section of the library lobby next to a table. and a male (identified as her boyfriend) are standing at the book drop with their backs to the lobby area. The suspect walks up behind them and stabs in the middle of her immediately falls into back and the suspects runs out of the south doorway. arms, a security guard runs out after the suspect but soon comes back and begins helping

With this information police began searching for the suspect. Police located the suspect near 36th Avenue and Cottonwood, took him into custody, and identified him as COREY AHKIVGAK. COREY AHKIVGAK was transported to Anchorage Police headquarters and placed in an interview room. While in the interview room COREY AHKIVGAK broke the table in the room, causing damage under \$250.00. Police remanded him to the Anchorage Correctional Complex.

Police recovered the Leatherman at the hospital, it has a 3-4 inch serrated blade.

Under-signed spoke with on 14 February 2022. reports is admitted to the intensive care unit, she has lost feeling in some of her extremities, and the injury is to her spinal cord.
