THE DISTRICT ATTORNEY CHARGES:

COUNT I

That in the Third Judicial District, State of Alaska, on or about December 6, 2021, at or near Anchorage, COREY LEIF AHKIVGAK , committed a crime in AS 11.41.230(a)(1) or (2) and, within the preceding 10 years, was convicted on two or more

1 separate occasions of crimes under a law or ordinance of this or another jurisdiction with
2 elements similar to AS 11.41.230(a)(1) or (2).

3 All of which is a class C Felony offense being contrary to and in violation of
4 AS11.41.220(a)(5) and against the peace and dignity of the State of Alaska.

6 **COUNT II**

7 That in the Third Judicial District, State of Alaska, on or about December 6,
8 2021, at or near Anchorage, COREY LEIF AHKIVGAK , committed a crime in AS
9 11.41.230(a)(1) or (2) and, within the preceding 10 years, was convicted on two or more
10 separate occasions of crimes under a law or ordinance of this or another jurisdiction with
11 elements similar to AS 11.41.230(a)(1) or (2).

12 All of which is a class C Felony offense being contrary to and in violation of
13 AS11.41.220(a)(5) and against the peace and dignity of the State of Alaska.

14 The undersigned swears under oath this Information is based upon a review of
15 police report 21-39529 submitted to date. On December 6, 2021, at around 1230 hours,
16 officers responded to the area of the A Street Walmart for a report of a male adult
17 assaulting random people. The male was located at Northern Lights and Gambell and was
18 identified as COREY AHKIVGAK. Further investigations revealed that AHKIVGAK
19 had assaulted two people.

20 While officers were responding to the A street Walmart, other locations were
21 calling in and describing the same male adult being aggressive and yelling at people. It
22 was reported to officers that the male adult was last seen by the Midas at Northern Lights
23 and Gambell. He was described as having long hair, wearing a black jacket, and carrying
24 a red bag. When officers made contact with AHKIVGAK, he was wearing black pants, a
25 black jacket, and had long hair in a ponytail. He also had a red bag in a shopping cart he
26 was pushing.

1 Officers made contact with [REDACTED] (A.F.). A.F. stated that she had gone
2 shopping at Walmart, and that when she was walking from Walmart to another store
3 through the north side of the Walmart parking lot, she overheard arguing and yelling. She
4 started to walk at a faster pace away from the noise. A male adult with a black jacket,
5 with something red underneath it, ran up next to her and started trying to talk to her. A.F.
6 tried to ignore him but the man ran in front of her and stopped. She then turned away
7 from him. When she turned away from him, he hit her in the back with an unknown item
8 that she thought might have been a backpack. She fell to the ground and hit her left knee,
9 arm, and the right side of her face on the ground. Several bystanders started yelling at the
10 male and he fled the area. She stated that her back hurt as well as her left arm and left
11 knee. A security camera showed AHKIVGAK sprinting Eastbound through the North
12 side parking lot behind A.F., but both individuals went out of view of the camera shortly
13 thereafter.

14 Officers made contact with victim [REDACTED] (D.S.) who reported that she
15 had been walking westbound on the south side of Benson Dr., at or near the driveway
16 between 3101 A St. and 3030 Denali St. D.S. stated that she was walking in the direction
17 of a male who was traveling the opposite direction from her on the same side of the
18 street. She stated that she did not know the male and said nothing to him. She stated the
19 male began calling her "whore," and "slut," and other derogatory terms. He then tried
20 punching her in the face, punching at her face multiple times with a closed fist. She was
21 hit on the right shoulder during this and felt pain. She was also scared that he would not
22 stop assaulting her but he stopped at one point, of his own accord, and resumed walking
23 eastbound.

24 D.S. described the suspect as a skinny to average built native male, that was
25 wearing black clothes, with a black jacket, and carrying a red bag. She said his hood was
26 on and she was protecting her face during the assault so she was not able to get a good
27 look at his facial features or hair-style. Officers conducted a show up with D.S. after she

1 filled out a private person's arrest form, and she immediately identified AHKIVGAK as
2 the subject who assaulted her. She said she was 100 percent certain about AHKIVGAK's
3 involvement.
