Mr. Mulvey:

Thank you for speaking with me this morning. As we discussed, my email includes the weblinks and addresses to obtain the records for a previous VA employee (below). I spoke with Nashville VARO AD Travis Kraft and explained what information you are requesting and your questions.

Unfortunately, I do not have much information on Dr. Turek. According to Mr. Kraft, he is unaware of anyone who worked directly with or has with first-hand knowledge of Dr. Turek's employment at the VA. He believes Dr. Turek left the VA prior to his conviction (in the early 2000's). The information as to his employment will be in his records at the Archives. Mr. Kraft is unaware of any other allegations that Dr. Turek mishandled adjudication of veteran claims. However, he acknowledged those claims would have been handled by OIG and investigated prior to Mr. Kraft's appointment as VARO-AD.

Mr. Kraft understands your concerns with Dr. Turek's involvement in your claim. Since it has been a number of years since Dr. Turek reviewed the case, there are several options available for re-evaluation of your claim. Without any additional information, Mr. Kraft believes a request for reopening your claim would be the best option. He is happy to have someone from the VARO contact you to discuss your options and how to request reevaluation.

Per OPM (OPM.gov):

The Official Personnel Folder (Standard Form 66) is a file containing records for an individual's federal employment career. Employees with OPFs are those in the Executive Branch service, as listed in Title V of the United States Code and some federal employees not under Title V. The long-term records in the file are included to protect the legal and financial rights of the government and the employee. The OPF is part of the government-wide system of records, OPM/GOVT-1.

Civilian personnel records are normally transferred to the National Personnel Records Center within 129 days after an employee's separation from Federal employment. To obtain copies of your SF-50s, send written authorization to:

Authorized Third Party Requesters, e.g., lawyers, doctors, historians, etc., may submit requests for information from individual records with the person of record's signed and dated authorization. They should state who they are in relation to the individual and the purpose of the request. All authorizations should specify exactly what the person of record is allowing to be released to a third party. Authorizations are valid one year from date of signature. A sample authorization is included for your review. The NPRC requires a court order, if the subject of the file is unable to sign. Please see Court Order Requirements for additional directions.
