NARRATIVE

1 On 11/20/2021 I was responding to a Motor Vehicle Hit N Run. While responding to the scene I was advised by dispatch the call was upgraded to a person shot.

4 Upon arrival I was able to obtain a visual on the suspect, later identified as (Derr, Andrew). It should be noted when I obtained a visual of Andrew I could only see a portion of his head. I then heard what appeared to be a slide of a handgun slide forward. I then gave Andrew verbal commands to get on the ground, at which time he placed his hands in the air and began to comply with my request. Once Andrew was on the ground he was advised to not move. Officers then observed a black handgun in the dirt just to the right of Andrew's right leg. Andrew then began to state "that girl

8 tried to kill me, she pointed a gun at me". Andrew then stated "she tried to kill me, I'm Sorry". Andrew was then secured by Officers and escorted  
 9 to my marked patrol vehicle.

10

11 I was then advised Andrews wife, O-1 (Derr, Valerie) was on scene and was requesting to speak with Officers reference the incident. I then made  
 12 contact with Valerie, at which time she advised the following; Andrew had left their residence (1070 Montrose Av, Orange City) to go for a  
 13 motorcycle ride. Valerie advised Andrew had been gone longer then she expected him to be so she texted him at approx. 1715 hours "Where the  
 14 fuck are you?" Andrew then texted her back at approx. 1718 hours and advised this girl just hit me on the bike. Andrew then advised him and three  
 15 others followed her and were waiting for the cops. Andrew then called Valerie at approx. 1719 hours and advised he had just shot someone.  
 16 Andrew then began to state a girl pointed a gun at him and he shot her. Andrew then advised Valerie to come find him, at which time he was  
 17 unsure exactly where he was and could only advised he was on a dirt road and believed the road name was Wisconsin. Andrew then hung the  
 18 phone up and sent Valerie his location off of his map on his phone. It should be noted Valerie advised when she was speaking to Andrew on the  
 19 phone he appeared very distraught. I obtained a sworn written statement from Valerie, which she was sworn to before and after she finished the  
 20 statement.

22 I then remade contact with Andrew as he advised Officers he was becoming very claustrophobic inside of my patrol vehicle. Andrew was then  
 23 taken out of my patrol vehicle so he could gather some fresh air. While Andrew was standing outside of my patrol he began a casual conversation.  
 24 During that casual conversation Andrew advised the following; he was unsure why the female, V-1 (Morales, Sara-Nicole) came outside of her  
 25 home and pointed a gun at him. Andrew then advised before Officers had arrived on scene him and two other males had pulled up on the roadway  
 26 near the female's residence. Andrew and one of the other males advised the female the cops were on the way and they were going to wait for  
 27 them to get there. Andrew advised the female then began to "yap" at him and the other males. After the female was done speaking to them she  
 28 went into her home. Andrew advised shortly after the female had went inside of her home she had come back outside and approached him and  
 29 the other males. Andrew then advised the female again the cops were on the way and he was going to wait for them to get there.

30

31 The female then began to "yap" at him and the other males some more, at which time Andrew then turned his head to speak to one of the other  
 32 males on scene. Andrew then turned his head back in the female's direction, at which time he advised the female had a handgun pointed at his  
 33 chest. Andrew advised he then drew his firearm and fired. Andrew believed the female was going to shoot him and he was going to die. Andrew  
 34 then advised the female had also hit his motorcycle that he was driving prior to him arriving at the female's residence that evening. After the  
 35 female had hit his motorcycle he advised the female continued to drive away. Andrew and the other males were then able to get the female  
 36 stopped in a turn lane on Volusia and began to advise her to stay where she was at and the cops were on the way, however the female again  
 37 drove off. Andrew and the males then followed the female again, at which time they arrived at the female's residence.

39 Andrew was then placed back into my marked patrol vehicle and transported to OCPD. Once at OCPD Andrew was placed in an interview room.  
 40 While in the interview room I gave Andrew a sworn written statement to fill out reference the incident and I read him his Miranda Rights. Post  
 41 Miranda Andrew advised he would speak to Detectives reference what happened. Andrew was then turned over to Detective Jones.

43 It should known Officer Brown was able to make contact with the other males involved on scene and obtained sworn written statements. SEE



1 ON 11-20-2021 AT APPROXIMATELY 1716 HOURS AS I WAS HEADING HOME WHEN I WAS DISPATCHED TO BACK OFC DAGLEY ON A  
 2 PERSON SHOT CALL. UPON MY ARRIVAL I WAS BEING FLAGGED DOWN BY WITNESSES WHO WERE STATING A FEMALE WAS DOWN  
 3 AND SHE WAS SHOT. I BEGAN TO JOG OVER TO THE SCENE WHERE I FOUND A WHITE FEMALE LAYING ON THE GROUND WITH  
 4 ANOTHER MALE KNEELING DOWN NEXT TO HER APPLYING PRESSURE TO WOUNDS. AS I KNEELED DOWN TO ASSIST WITH  
 5 RENDERING AID I WAS ADVISED THAT THE SUSPECT WHO SHOT THE FEMALE WAS STILL ON SCENE.  
 6  
 7 THE WITNESSES BEGAN TO POINT EAST OF MY LOCATION WHERE I COULD SEE A WHITE MALE JUST STANDING THERE. OFC  
 8 DAGLEY, OFC SOTO, AND I ORDERED THE MALE TO THE GROUND AT GUN POINT. AS WE GOT CLOSER TO THE MALE I NOTICED A  
 9 BLACK HANDGUN LAYING TO THE LEFT OF THE MALE. I SECURED MY WEAPON AND WITH THE ASSISTANCE FROM OFC SOTO WE  
 10 WERE ABLE TO SECURE THE MALE IN OUR HANDCUFFS WITHOUT INCIDENT. I WALKED THE MALE OVER TO OFC DAGLEY'S PATROL  
 11 VEHICLE WHERE HE WAS PLACED, AND LEFT IN THE CUSTODY OF OFC DAGLEY.  
 12  
 13 I BEGAN TO GATHER WITNESSES AND GOT THEM STARTED ON STATEMENTS. THREE WITNESSES WERE FOUND AND ALL  
 14 PROVIDED STATEMENTS WHICH WERE EVENTUALLY TURNED OVER TO OFC HILERIO. THIS CONCLUDES MY INVOLVEMENT WITH  
 15 THIS CASE.
