

Gruja: I speak honestly and openly. TED does not see that it is legitimate to convene a board because he doesn't have neither moral nor financial problem. The problem is his daughter. They look at it in a Western way, he didn't do anything so how can you convene a board now? His daughter did, he is a father, what now...

However, the problem is that a good number of churches now do not want Robert to come to them at all. Here, yesterday I had calls from Sombor, Sivas, Kula. They don't want Robert to go to those churches. Gospodjinci, then Novi Sad. A Pandora's box was opened inside the conference and we were left almost untouched when it comes to the outside world...

Someone: I said we were going to have a problem inside of the church and that's what we have now. For outsiders (people outside of the church) this is not a problem. It would be best for him to withdraw himself.

Gruja: I will try to have another conversation...

Marcicic: Dragan suggested it to him, but he won't.

Gruja: The worst thing is that the two conferences almost went to war because of that.

Okay, that's a strong expression, but you can feel the tension. When you go to Bosnia, Bosnia is completely on Caleb's side. Why, because they know the story that took place back in the days when she was there. They know what happened there and what it looked like. Well, Bajić Aranka and Milan are Anita's cousins. They were his mentors. They knew what was going on there. Aranka often talked to Anita. And those people sided with Caleb. It's not as black and white as it looks. Well, we wouldn't react the way we did.

MARCicic: A story is gradually being made here. If someone is a pedophile, he is a pedophile from the start. And not at the beginning, a contract is made (for divorce...), and then she will sign that he can continue working, and then she will not sign and so on.

Gruja: I didn't like talking about this. But we are pastors, I would like this to remain, because we should not talk about such details. I have been involved in this from the very beginning.

The whole process started at the moment when her then husband found out that she had committed adultery with one Dragan from Mostar.

That was the beginning. He wanted to forgive her and somehow renew his marital union.

They contacted the best marriage counselor, Mihalec. they started marriage counseling with Mihalec. I was also in contact with Mihalec. He had to end the marriage counseling after a month because Anita was not fully involved in the process properly. To find out later that she was already starting to chat with her current husband at that time.

What happens. She simply decides to leave Caleb, comes to Novi Sad and seeks a divorce.

And it is my fault, I turned out to be naive because she called me to talk to Caleb to sign a divorce, for her to have the children and she will sign a statement that he can continue his pastoral ministry.

Mind you, that's a fact. And Caleb agrees, he signed, and when I asked her to sign the paper that he is not guilty, that he has moral integrity, then Anita said that she can't do that, that she talked to people from End it Now and they enlightened her that she was emotionally and mentally abused. In the beginning, there are no stories about rape or pedophilia. In the beginning. After a while, she says, he raped her during their marriage. The FDA is not talking about how. So the story was gradually built.

You know what, you have a certain amount of pressure. This is a newcomer, a foreigner, many have said, kick him out, you know how people know how to say. Watch out, his story, he says he had a problem with pornography. But she also watched pornography. She admitted it. We watched it to do it. That's how. He says, yes, we watched. But I never raped her, I wouldn't.

And then we decided that we as a church can't do anything, they have to resolve it in court and we will accept the court's decision. Then Anita was very angry with us, she was putting pressure on us.

And they came to court, Anita had some evidence but the Court did not accept Anita's evidence so she went on TV. The judge said that the evidence was not valid, it was done in the CPS and it was done in the presence of the parents, and that is not evidence. And the judge is now asking for a special evaluation where they will have special supervision over the children with special cameras... You know Anita is a person that if you don't go on the track she determined, you are the worst. I experienced her accusing me of being the same as Caleb so that maybe I am abusing my wife as Caleb her. Just because I doubted her statement. We'll see now. The court will decide. Kaleb is strongly protected in Bosnia, some church members pay him everything, he no longer works in the church at all, people have accepted him.

Caleb was told that pedophiles are being treated here in prison, but he says "I'm not guilty, if I have to die, I'm ready but I won't leave the children."

Marcikic: The problem is that when we here have received the trust of the people and someone thinks that we are all stupid.

MARCikic: You see an attitude in him. Only God knows what is true, and we are now waiting for the court to make a decision

Gruje: I presented this and I was given half an hour in the division to talk about this in front of all the presidents. TED has known about this from the beginning, and they said that the smartest thing to do is to leave it to the court to make a decision.

Who among us is an expert to determine whether there was rape or pedophilia?

Gruje: TED says we treated Caleb unfairly because he can sue us now. Because we fired him before the process was over. There is a problem now, I told Bozidar that, and he says no, he won't.

Marcikic: Watch out for something else. I'm leaving for Kisač, and I have 28 non Adventists in front of me. Robert takes care of that Kisač. And I know he's going there while he is under pressure. He has problems and sometimes he has to do a sermon instead of me, and the Holy Spirit should lead the sermon, he came most probably out of respect for those people, and the question is whether he has the strength to speak to those people. And watch out 28 people came to church. And I can't hang out in Kisač every Friday.
