Dear Mary Kincaid:

You appealed from the action of the Federal Bureau of Investigation on your Freedom of Information Act request for access to records concerning various named third parties as well as details contained in a Drug Enforcement Administration (DEA) Report of Investigation. I note that your appeal concerns the FBI's refusal to confirm or deny the existence of responsive records pursuant to Exemptions 6 and 7(C).

After carefully considering your appeal, I am affirming the FBI's action on the portions of your request seeking records concerning various named third parties. The FOIA provides for disclosure of many agency records. At the same time, Congress included in the FOIA nine exemptions from disclosure that provide protection for important interests such as personal privacy, privileged communications, and certain law enforcement activities. The FBI properly refused to confirm or deny the existence of records responsive to your request. Confirming or denying the existence of such records, including law enforcement records, concerning a thirdparty individual would constitute a clearly unwarranted invasion of personal privacy, and could reasonably be expected to constitute an unwarranted invasion of personal privacy. See 5 U.S.C. § 552(b)(6), (7)(C). Additionally, it is reasonably foreseeable that confirming or denying the existence of such records would harm the interests protected by these exemptions. See, e.g., People for the Ethical Treatment of Animals v. NIH, 745 F.3d 535, 544 (D.C. Cir. 2014) (upholding agency's refusal to confirm or deny existence of records that would confirm whether investigation of third party had occurred); see also Antonelli v. FBI, 721 F.2d 615, 618 (7th Cir. 1983) (finding that confirming whether third party has been the subject of investigation would likely "constitute an invasion of that person's privacy that implicates the protections of Exemptions 6 and 7").

Finally, in your request you indicated that certain portions are seeking records concerning a DEA Report of Investigation. Accordingly, if you have not done so already, you may wish to submit a request to DEA for those portions of your request concerning the Report

of Investigation at the following address:
