FOR INFORMATION OF INDIANAPOLIS, A REVIEW OF SAN JUAN FILE

On 7/17/85, a handwritten letter was received at the United States Clerk's Office, Terre Haute, Indiana, which contained threats to kill President RONALD REAGAN, Vice President GEORGE BUSH, and nine other government officials. Investigation determined the writer of this letter to be Inmate [Redacted] Registry Number [Redacted] Inmate [Redacted] was serving an eight-year sentence for Writing Threatening Letters to the President; he was released on 8/23/85.

On 7/18/85, an interview was conducted with Inmate [Redacted] also present during this interview were [Redacted] Special Agent, United States Secret Service, and [Redacted] Psychiatry Department, United States Penitentiary, Terre Haute. Inmate [Redacted] has a long history of writing threatening letters, none of which have been known to have been carried out.

[Redacted] SA [Redacted] assesses Inmate [Redacted] as being non-threatening to the President and Vice President. [Redacted] believes Inmate [Redacted] has a low propensity for violence.
