"MARGARET HECKLER, THIS LETTER IS TO YOU, AND HARRY N. WALTERS OF THE VETERANS ADMINISTRATION, IF EITHER ONE OF YOU, TRY TO COME NEAR, TO ME AND MY FRIENDS, AND TO ASK US TO SIGN UP, WITH YOUSES, WE'LL BLOW YOUR FUCKING HEADS, OFF OF YOUR SHOULDERS WITH BAZOOKAS, YOU BUNCH OF LYING, CROOKED, CROOK, BASTARDS, WE KNOW ALL ABOUT YOUSES FROM THE PEOPLE, TRY, EVER TO COME NEAR US, AND SEE IF IT DOESN'T HAPPEN TO YOU, WHEREBY IT WILL, AND IT WILL BE JUSTIFYABLE HOMICIDE, IF WE CALL, FOR ROBBING PEOPLE, IS JUST LIKE MURDER, WHILE YOUSES DO JUST EVER TRY TO COME NEAR US, SEE WHAT HAPPENS TO YOUSES. FROM ME A GIRL AND FREAKS."
