**Affidavit**

The undersigned affiant, being duly sworn, deposes and says:

1. The Affiant, Detective Frank A. Cuoco II #500, is a sworn member of the Connecticut Department of Emergency Services and Public Protection, Division of State Police, having been so employed since June, 1, 2012. This Affiant presently holds the rank of Detective and is assigned to Eastern District Major Crime - Troop K, located in Colchester, CT. That the Affiant has responsibilities to include, but not limited to, addressing complaints regarding criminal activity in accordance with Connecticut General Statutes. At all pertinent times mentioned herein, the Affiant was acting as an official member of said department. That, during the course of Affiant Cuoco's career, he has conducted numerous investigations that have ultimately resulted in the arrest and conviction of the involved offender(s). The Affiant has received formal training regarding the laws of arrest and laws pertaining to Search and Seizure from The Connecticut State Police Academy and has received specialized training in various areas of investigations and how to process the scenes of such crimes. This Affiant attests that the following facts and circumstances are from personal knowledge, observations, and investigation as well as the information received from other Troopers and law enforcement officers acting in their official capacity and official police reports.

2. That on Saturday, September 11, 2021 at approximately 2057 hours, the Berlin Police Department began receiving numerous 911 calls from the area of 187 Hummingbird Drive stating that a female party was located in the street with visible wounds, yelling that she was car jacked and assaulted. Simultaneously, the Berlin Police Department received emergency 911 calls stating there was a car on fire located behind Wine Merchant liquor store on Berlin Turnpike in their town.

3. That upon arrival of Berlin Police Officers, a female party, later identified as Victim #1 (W/F DOB:4/2/57) of Marlborough, CT, was located between the residences of 187 and 197 Hummingbird Drive in the center of the roadway, bloodied with visible injuries to her head. The portion of Hummingbird Drive where Victim #1 was located is a dead end and is adjacent to the rear of the Wine Merchant building. Victim #1 was later transported to Hartford Hospital for treatment of her serious

injuries to include a broken right femur, head trauma consisting of a laceration above the left eyebrow and puncture wound to left forehead area, and an acute kidney injury.

4. That upon arrival of Berlin Police Officers, a vehicle fire was located behind Wine Merchant. The vehicle was identified as a 2014 Infiniti Qx50, color gray, bearing Connecticut registration AH77098, VIN JN1BJ0HR2EM190816. Victim #1 and the vehicle fire were located approximately less than 200 feet apart. The 2014 Infiniti Qx50 was later valued by Victim #1's insurance company at \$18,000.00.

5. That while at Hartford Hospital, Victim #1 provided a verbal statement to Officer Clark of the Berlin Police Department. Victim #1 explained she arrived at Big Y in Marlborough, CT and parked her vehicle along the east side of the building. When she returned to her vehicle, two unknown males approached her from behind, took hold of her and demanded money. Victim #1 described them as young black males, who were wearing dark clothing and black cloth face coverings. One of the males had dark, curly hair. Victim #1 fought back and during the altercation sustained an injury to her right leg. During this time, Victim #1 asked the males, "Why are you doing this to me?" when one of them responded, "Because you're white and my mother is very ill." Victim #1 explained a bag was placed over her head and she was forced into the rear driver's side of her vehicle at gun point. She stated the curly-haired male got into the driver's seat of Victim #1's vehicle and the other male, who had possession of the firearm, sat in the passenger seat. Victim #1 said the males took her purse and after locating her Bank of America ATM card, traveled to multiple ATMs and demanded she withdraw money from her account. Victim #1 said she was struck in the face and head with the firearm five or six times. The suspects demanded money and jewelry multiple times and one stated he was going to kill her approximately ten times. The two suspects told Victim #1 they were going to set fire to her car to destroy evidence. When they stopped the vehicle for the final time, Victim #1 heard one of the males on the phone saying, "Gas gas gas, bring gas." Victim #1 was then instructed to exit the vehicle, which she was unable to do due to the injuries sustained to her leg during the altercation at Big Y. The suspect in the driver's seat exited the vehicle, opened the rear driver's side door, grabbed Victim #1 from behind, pulled her out of the vehicle and onto the road. The suspect then re-entered the driver's seat and drove the vehicle through the trees, where the Victim's vehicle was set on fire in the adjacent parking lot. Victim #1 then began screaming for help. Detectives from Eastern District Major Crime later obtained a signed and sworn statement from Victim #1 which was consistent with her verbal statements made to Officer Clark while at the hospital.

6. That on Sunday, September 12, 2021 at approximately 0300 hours, a detective from Eastern District Major Crime obtained surveillance footage from the Twin Spruce Motel, located on Berlin Turnpike, next door to the Wine Merchant. The video showed on September 11, 2021 at approximately 2052 hours, the Victim's vehicle and a dark colored sedan turn into the Twin Spruce Motel parking lot behind one another. The video shows the dark colored sedan has peeling and faded paint around the

sun roof, the windows are darkly tinted, and has five spoke rims. A front license plate is also visible on the vehicle and it appears to be a newly issued Connecticut passenger registration with the format of two letters followed by five numbers; the letters are unidentifiable but there appears to be multiple number 1's in the numeric portion. The dark colored sedan then drove to the back lot of the motel, before returning to the front parking lot area and parking. The victim's vehicle is seen driving through the Wine Merchant parking lot, before returning to the Twin Spruce Motel parking lot and parking within close proximity of the dark colored sedan. A suspect gets out of the Victim's vehicle and walks up to the parked dark colored sedan. After approximately thirty seconds, the suspect returns to the Victim's vehicle. At approximately 2055 hours, the Victim's vehicle travels to the back parking lot of the motel and out of camera view, which is in the direction of Hummingbird Drive and the back side of Wine Merchant liquor store. At approximately 2056 hours, a suspect ran from the back of the Twin Spruce Motel parking lot towards the front parking lot, where the dark colored sedan was still parked. The dark colored sedan then exits the Twin Spruce Motel parking lot onto Berlin Turnpike traveling the wrong direction.

7. That, on September 12, 2021 at approximately 1320 hours, a detective from Eastern District Major Crime contacted an Asset Protection associate of Big Y and later obtained a copy of the store's video surveillance footage. Detectives later reviewed Big Y's video surveillance and observed the Victim's vehicle enter the Big Y parking lot at 1910 hours from Route 66. The Victim's vehicle parks along the east side of the building out of CCTV coverage. The surveillance video shows an Acura TL enter the Big Y parking lot at approximately 1838 hours and can be observed driving around the area. The Acura TL travels east around the parking lot at 1911 hours towards the area where Victim #1 parked her vehicle. The Acura TL exits the Big Y parking lot at 1917 hours with the Victim's vehicle immediately behind it. The video shows the Acura TL is affixed with a front and rear registration plate bearing CT passenger BA21117.

8. That, on September 12, 2021 at approximately 1330 hours, Affiant Cuoco and Det. Rei #793 went to DND Food Mart, located at 298 Main Street in the Town of East Hartford, to obtain surveillance video of when Victim #1's credit and bank card were used at the store. Affiant Cuoco was previously informed by Victim #1's husband that on September 11, 2021 at approximately 2005 hours, Victim #1's debit card was used to make an unauthorized ATM withdrawal at the store for \$200.99 and her credit card was also used there to make a \$3.50 purchase. Affiant Cuoco and Det. Rei seized surveillance video and upon reviewing it, observed that on September 11, 2021 at approximately 1955 hours, the Victim's vehicle, a gray 2014 Infiniti Qx50, pulled into the DND Food Mart parking lot from Brewer Street. A suspect gets out from the passenger's side of the vehicle and goes into the store. The suspect is a black male, approximately six feet tall, and has a black mask covering most of his face. The suspect is wearing a black sweatshirt with a Champion logo on the left chest, black pants with white piping down the outside of the leg, and black sneakers. At approximately 2000 hours, the

suspect walks over to the beverage refrigerator along the back wall of the store. At approximately 2002 hours, the suspect walks to the register holding two blue Powerade bottles and is seen using the Victim's credit card to purchase the two Powerade drinks, totaling \$3.50. The suspect can then be seen exiting the store, Victim #1's vehicle returns to the parking lot, and the suspect gets back into the Victim's vehicle which then leaves the parking lot.

9. That on Monday, September 13, 2021, Affiant Cuoco submitted a Connecticut Intelligence Center (CTIC) flyer providing a summary of information gathered during the investigation to include a screen shot of the suspect using the Victim's credit card at the DND Food Mart on 9/11/21. Affiant Cuoco received an influx of phone calls from various Connecticut police departments personnel, to include Wethersfield Police Department Detective Christopher Morris #223. Detective Morris explained that on September 8, 2021, an Acura TL sedan, later identified via video surveillance as a gray 2002 Acura TL VIN19UUA56662A014314 bearing CT passenger registration BA21117, had been involved in a motor vehicle theft in the Town of Middletown. Detective Morris explained that he contacted the registered owner of the 2002 Acura TL previously described, who said her daughter sold the vehicle to Kenneth Gordon (B/M DOB: 09/09/2001). Her daughter told Detective Morris she sold the vehicle to Gordon on August 31, 2021 with the registration plates still on it. Gordon was supposed to return the registration plates, which he never did.

10. That, on Monday, September 13, 2021, officers of the East Hartford Police Department contacted Affiant Cuoco and provided the identity of the black male from the DND Food Mart surveillance still image included in the CTIC bulletin. Officer's Santiago and Cortes identified the male as Juvenile/Co-conspirator #1 (B/M, currently 16 years of age). This identification was based upon photographs and videos officers had seen of Juvenile/Co-conspirator #1 on social media websites and surveillance footage, as well as first-hand information developed during numerous recent criminal investigations in which Juvenile/Co-conspirator #1 was arrested. Furthermore, the DND Food Mart is located in the Hockanum section of East Hartford, which is an area that Juvenile/Co-conspirator #1 is known to frequent.

11. That on Monday, September 13, 2021 at approximately 2015 hours, Affiant Cuoco received an email from Victim #1's husband that included a screenshot of an email he received regarding an attempted use of Victim #1's debit card. The email detailed the attempted transaction was on September 13, 2021 in Hartford, CT. With this information, Affiant Cuoco contacted Bank of America and learned the attempted ATM withdrawal using Victim #1's debit card on September 13, 2021 was at Bueno Grocery, located at 100 Park Street in the City of Hartford.

12. That on Tuesday, September 14, 2021 at approximately 1200 hours, Affiant Cuoco and Det. Rei went to Bueno Grocery to obtain surveillance footage from the attempted ATM withdrawal using Victim

#1's debit card. While pulling into the parking lot located on the side of the building, Affiant Cuoco observed an older model gray Acura TL with several identifying features consistent with the Acura TL observed on surveillance video at Big Y and the Twin Spruce Motel. The Acura TL was observed to be the same color, have peeling and faded paint around the sun roof, all the windows were darkly tinted, and it had five spoke rims. Affiant Cuoco, accompanied by members of Hartford Police Department as well as Det. Rei, approached and Acura TL and discovered that the VIN number on the vehicle matched the VIN number of C I passenger registration BA21117. The located Acura TL had CT passenger registration 0ALED7, which was last found to be registered in 2015 to a Ford Explorer, affixed to the rear bumper of the vehicle. The vehicle was seized and towed from the scene to Connecticut State Police - Troop K in the Town of Colchester, where it was secured pending issuance of a Search and Seizure warrant.

13. That on Friday, September 17, 2021 at approximately 1310 hours, a Search and Seizure warrant was completed by Affiant Cuoco and Det. Rei and granted by the Honorable Judge Gold, for the 2002 Acura TL, VIN VIN19UUA56662A014314. On Saturday, September 18, 2021, detectives from Eastern District Major Crime executed the search warrant on the aforementioned 2002 Acura TL in the Troop K - Colchester garage. During the search, detectives located and seized various items, including but not limited to, numerous DNA swabs, a bottle of Arizona Pineapple Fruit Juice Cocktail, a black sweatshirt, and a blue surgical mask. Additionally, some of these items were subsequently submitted to the DESPP Forensic Lab for testing.

14. That on Tuesday, September 21, 2021, Homeland Security (HSI) and Federal Bureau of Investigation (FBI) agents conducted a follow up interview with the previous owner of the Acura TL, Witness #1 (B/F DOB: 3/11/01). Witness #1 confirmed statements with Federal Agents that she previously made to Det. Morris. After the interview with Witness #1, HSI agents began conducting open source monitoring of social media accounts of Kenneth Gordon and known associates. These accounts include the Facebook and Instagram profiles of Gordon, a family member of Gordon, and an unidentified black male by the name "Sitchy". During the open source searches, a series of photographs appearing to be taken in hotel bathroom were found on the accounts of said family member and "Sitchy". One of the images shows Juvenile/Co-conspirator #1 wearing clothing, a Champion brand sweatshirt and full facemask, consistent with the surveillance video from the DND Food Mart from 9/11/21. Multiple other images show Gordon holding a black handgun with a silver slide.

15. That on Wednesday, October 6, 2021, Affiant Cuoco was made aware by law enforcement personnel that Gordon and Juvenile/Co-conspirator #1 were located together in a vehicle in a Dollar General parking lot in Deerfield Beach, Florida. They were detained and subsequently taken into custody on the strength of an active Arrest Warrant and active Order to Incarcerate, respectively.

Manchester Police Officer Sargolini later contacted Affiant Cuoco and informed him that he would be extraditing Gordon back to Manchester Police Department on October 29, 2021.

16. That on Thursday, October 14, 2021, HSI agents received Facebook records via a Search and Seizure warrant for the account of Gordon; Kenneth.Gordon.562. On October 27, 2021, Gordon's Facebook records were shared with Affiant Cuoco and reviewed. There were numerous messages between Gordon and other users significant to this investigation. Observed were the following messages, amongst others (Note: The records are provided in UTC time, 5 hours ahead of EST):

That HSI agents reviewed the Facebook records and noted that during the time of the kidnapping, Gordon's account made phone calls and/or sent messages to Facebook accounts Zay Fazzo (Facebook.com/zayfazzo00), Steve Harvey (Facebook.com/jailen.brown.50), and Book em or Book SG (Facebook.com/(Juvenile/Co-conspirator #1's name)547yahocom), which they believe to be owned and operated by Juvenile/Co-conspirator #1. Juvenile/Co-conspirator #1 is known by law enforcement personnel as "(Juvenile/Co-conspirator #1's initials)" and through open source images on his Facebook account, HSI agents believe them to depict Juvenile/Co-conspirator #1. Also while reviewing the Facebook results, HSI agents observed various messages between Gordon and the (Juvenile/Co-conspirator #1's name)yahocom account which show the user of the (Juvenile/Co-conspirator #1's name)547yahocom account refer to himself as "(Juvenile/Co-conspirator #1's initials)".

18. That on Friday, October 29, 2021 at approximately 1800 hours, Officer Sargolini arrived back at Manchester Police Department with Gordon from Florida to process him on the Arrest warrant. Upon their arrival, Officer Sargolini turned over Gordon's cell phone, Evidence Item #80, to HSI agent Geoffrey Goodwin. Affiant Cuoco and Det. Rei then attempted to interview Gordon pertaining to this investigation at which time he requested an attorney.

19. That on Wednesday, November 17, 2021, HSI agents sent a subpoena to Wyndham Hotels & Resorts, Inc. for the Hawthorn Suites in Manchester, CT. This request included the date of 9/9/21, Room 6101, which was the information provided by Gordon to his grandmother in Facebook messages. On 11/23/21, Wyndham Hotels & Resorts, Inc. responds to the subpoena and provided the folio for the room rental showing that it was rented by a resident of an address on Love Lane, Hartford, CT, for the night of 9/9/21 using a credit card. This information is consistent with Gordon's address on Love Lane, a family members name and address, and the Instagram images of Gordon and Juvenile/ Co-conspirator #1 in a hotel bathroom.

Notification Form from the DESPP Forensic Lab. The Forensic Hit Notification Form indicated that the DNA from the surgical mask, #008-001, Swabbing of mask, seized from the 2002 Acura TL (Evidence Item #64) had been linked to DNA profiles from three other items associated with stolen motor vehicle investigations. The police agencies identified with matching DNA profiles are as follows: Glastonbury Police Department - Stolen Motor Vehicle (8/14/21) - #002-001 Swabs from "AZ IT W/ peach can", Simsbury Police Department - Stolen Motor Vehicle (8/31/20) - #001-001 Portion of "burnt tobacco paper", Windsor Police Department - Stolen Motor Vehicle (10/1/20) - #003-001 Swab "knob shifter".

21. That on Monday, November 29, 2021 at approximately 1215 hours, Affiant Cuoco took possession of Gordon's cellphone, Evidence Item #80, from HSI agents in Hartford, CT. Affiant Cuoco transported the cellphone back to Troop K in Colchester and secured it into evidence.

22. That on Friday, December 10, 2021 at approximately 0933 hours, a Search and Seizure warrant was completed by Affiant Cuoco and Det. Rei and granted by the Honorable Judge D'Addabbo Jr., for Gordon's pink and white iPhone 7 Plus (Evidence Item #80). On Thursday, December 16, 2021, Affiant Cuoco transported Gordon's iPhone 7 Plus, Evidence Item #80, to the FBI Office located at 600 State Street, New Haven, CT, for forensic examination. On Wednesday, December 22, 2021, Affiant Cuoco retrieved Gordon's iPhone 7 Plus as well as a DVD from FBI Examiner Hatzikostas that contained the examination results reports and File System of Gordon's iPhone.

23. That over the course of multiple dates in January and February of 2022, Affiant Cuoco reviewed the examination results of Gordon's iPhone provided by FBI Examiner Hatzikostas. Affiant Cuoco searched all reports for any videos, photographs, text messages, phone calls, and other data relevant to this investigation as well as conducted keyword searches within the reports for specific names and other identifiers. During the review, Affiant Cuoco located Gordon's social media accounts to include Facebook (ID: 100007992763675; Name: Beno Tyty) and Instagram (ID: 1343942947; Name: Beno Tyty; Username: kennyy.yy). The Facebook Messenger Chats paralleled the data of Gordons Facebook account, Kenneth.Gordon.562 (Beno Tyty), previously acquired by HSI Agents. Additionally, images were found appearing to be taken in a hotel bathroom and are the same as the photographs located by HSI Agents during open source searches of the Facebook and Instagram profiles of a family member of Gordon and "Sitchy".

24. That during the same review of Gordon's cellphone examination, Affiant Cuoco also discovered numerous deleted web searches from 9/14 and 9/15/21 in the web history which are listed below:

25. That on Wednesday, February 16, 2022, Affiant Cuoco contacted Det. Ritchie #403 of the Glastonbury Police Department to follow up on the Forensic Hit Notification Form received from the DESPP Forensic Lab. Det. Richie informed Affiant Cuoco that a known buccal sample from Gordon was sent to the DESPP lab for comparison to item - #002-001 Swabs from "AZ IT W/ peach can". Det. Ritchie provided Affiant Cuoco with the Supplemental DNA Report from the DESPP lab which states, "The results are consistent with the DNA profile from item #002-001 originating from a single male individual. Assuming one individual, the DNA profile from item #002-001 is at least 100 billion times more likely to occur if it originated from Kenneth Gordon than if it originated from an unknown individual."

That, in a separate DESPP Forensic laboratory report, it was indicated that the DNA profile from the surgical mask seized from the 2002 Acura TL is consistent with the source of the DNA profile obtained from the "AZ IT W/ peach can", which is "100 billion times more likely to occur if it originated from Kenneth Gordon than if it originated from an unknown individual."

27. That based upon the aforementioned facts and circumstances, this Affiant believes that Kenneth Gordon (DOB: 09/09/2001), a black male currently incarcerated at Manson Youth Institution located in
