Good morning Gabe •

As discussed on Friday, here is a link to download a file of 34,869 records I would like the Secretary of State's office to investigate for residency issues relating to the November General Election. Many of these voters may also have had the same residency issues when they cast votes in previous elections as well. The file is too large to email.

These are all voter records where USPS Change of Address data indicated the voter moved from the county they were registered in to a new county in Georgia more than 30 days before the election (Processing certifications attached), but the voter data, and the vote history trailer data, indicated they cast a vote in the November General Election in their former county.

Of those records, the voter file I received from your office on May 7th shows 10,372 voters have since updated their registration address to the same address they originally gave the USPS when they filed their changes of address. Since the USPS itself takes multiple steps to verify and confirm the authenticity of NCOA data, and these voters have since caused their own voter registration data to be updated to the same address they gave the USPS originally when they moved. I see no reason to doubt the accuracy of that information, or to doubt the accuracy of the • Move Effective Date• • they also provided to the USPS originally when they filed their changes of address.

The counts described above have decreased slightly for two reasons: First, out of an abundance of caution, I have eliminated any record where the change of address county assignment done by my geocoding software and the county assignment done by the USPS during CASS certification were in disagreement. Second, I eliminated any record where the voter in question no longer appears in the voter file I received from your office on Friday May 7th, I assume because they have passed away or you had some other valid reason to remove them from the file.

To make this data simpler and easier for your office to evaluate, I am giving it all to you in one file as you requested on Friday. I have also appended additional fields to help make any queries you may wish to run a bit easier, in an effort to aid you in your investigation. With that in mind, please allow me to walk you through the record layout.

All fields from •Country••on up contain the original voter file data from the file I received in November in its original record layout. All fields below that are additional • work••fields I have added for processing.

The fields •Radd•, •Rcity•, •Rstate•, •Rzip•contain a USPS CASS certified copy of the voter-s AMERoriginal registration address as it appeared in November. ERSIGHT

The fields • MayAdd•,• MayCity•,• MayState•, and • MayZip•, contain a USPS CASS certified copy of the voter•s registration address as shown in the voter file I received from your office on Friday May 7th.

The fields •COAadd•,•COAcity•,•COAstate•, and •COAzip•, contain the voter•s Change of Address data provided by the USPS NCOA processing done on the voter•s registration address on November 25th, 2020.

• Move_Type••indicates a match to either an individual or a family change of address record, and the •Dlv_code••field will show an •M••indicating a matching change of address record was returned during processing.

The •CoaMoveDt••field contains the year and month of the •Move Effective Date••the voter gave the USPS, which would have been the date they wanted their mail to begin being forwarded to them at their new address. The USPS does not provide the actual day due to privacy concerns. Since voters with a Move Effective Date in October of 2020 would have been within the 30 day grace period, and could have voted lawfully in their old county, any records with a Move Effective Date in October of 2020 have been removed.

The field •CountyName••is the name of the county the voter was registered in when I processed the file I received in November.

The field •NewCounty••contains the county name returned by geocoding and/or by the USPS during CASS certification when both were run on the change of address data, or the name of the county currently shown on the voter•s record in the voter file I received from your office on Friday May 7th wherever the change of address data and their current address on the voter file matched.

The field •Voted2020G•shows a •Y•for all the voters who have vote history trailers showing they voted in the 2020 General Election, which is all of them.

The field •VoteCounty••contains the county code the vote was cast in that was shown on the corresponding vote history trailer. Any records where those county codes and the county code shown on the November voter file did not match have been eliminated.

The fields •NewCC•, •NewHouse•, •NewSenate•, and •NewCong•show the voter•s county number, house district number, senate district number, and congressional district number as shown in the voter file I received from your office on Friday May 7th, wherever the address data in that file matches the Change of Address data from November. As you will no doubt notice, that data indicates the vast majority of these voters would have been given the opportunity to cast a vote in one or more voting districts they no longer lived in.

The field • Confirmed • • shows a • Y • • on the records where the voter file I received from your office on Friday May 7th shows an address that matches the Change of Address data from



In closing Gabe, from what I see here, these are mostly fixable issues. I know you cannot do any list maintenance within 90 days of a federal election. However, when I read OCGA 21-2-233 I see this:

•(a) The Secretary of State is authorized to cause at his or her discretion the official list of electors to be compared to the change of address information supplied by the United States Postal Service through its licensees periodically for the purpose of identifying those electors whose addresses have changed.•

That appears to indicate there is nothing to prevent the Secretary of State-s office from running National Change of Address processing, at any time, as long as you do not do any list maintenance within 90 days of a federal election. So my suggestion would be to establish a procedure where you would run NCOA before the start of early voting, and if it indicates a voter may have changed counties, I see nothing that would prevent you from sending them a notice to encourage them to immediately update their registration address before the deadline if they have moved so they can vote, vote lawfully, and vote in the correct county and voting districts. That data could also be transmitted to the counties, so they can be on the alert to help prevent voters with residency issues from casting ballots in a county they no longer live in.

Please review all this and let me know if you or any of your staff have any questions, or if there might be anything else I can do to aid you in your investigation.

As for NCOA showing people who moved out of state, we sent surveys to 7000 people who we identified as having filed out-of-state NCOA and who also voted absentee by mail in Georgia. We got a pretty decent response rate and the overwhelming majority (something like 99%), were determined to likely be legit Georgia voters. 1% appeared problematic.

I wonder if there is well-respected non-partisan group that could actually dig into this and come up with an answer that would be more trusted than our analysis? Someone like MIT Election Data Lab or CEIR? They should get the same news orgs that paid for the big study into Florida after 2000 to pay for this one. This can all be definitively researched. It would just take a ton of time and resources.

Below is a quick legal analysis of the issue Mark Davis is pushing regarding in-state moves. Thanks to Sarah for helping me find the relevant state laws.

Bottom line is that determining whether someone who moved from one county to another should have been eligible to vote in the November election requires applying a complicated array of both federal and state law (some of which are contradictory) to each individual-s specific factual scenario. A spreadsheet listing voters-names doesn-t come close to meeting that standard.

As Mark Davis himself admitted in a sworn declaration he submitted in December 2020, the list maintenance restrictions that the National Voter Registration Act (NVRA) puts on states makes it difficult to keep voter rolls up to date when people move. The NVRA was passed in 1993 and applies to all states, so this is not a new issue, and I don't think it is unique to Georgia. The NVRA's 90 day blackout period from conducting systematic list maintenance prior to a federal election precludes states taking any systematic action with NCOA data basically for the entire election year. As Mark also alludes to in his December declaration, courts in Georgia have found that inclusion on an NCOA list alone is not a sufficient reason to challenge the voter's eligibility to vote. See Majority Forward v. Ben Hill County Board of Registrations. The NVRA requires •individualized inquiry•into each voter's situation. Calling these voter's •illegal voters• without doing that individualized inquiry is a disservice.

The NVRA says that states •shall not remove the name of a registrant from the official list of eligible voters in elections for Federal office on the ground that the registrant has changed residence unless the registrant•goes through the procedures set forth by the NVRA. See 52 USC 20507(d)(1). Those procedures must take place outside of 90-days before a federal election.

Georgia law says that •all persons whose names appear on the list of electors• •shall be allowed to deposit their ballots according to law at the precinct in which they are registered.••See 21-2-224(h). The rationale for this state law seems clear• the law wants to ensure that poll workers cannot make arbitrary decisions about who gets to vote. So if a voter is on the list of eligible voters, shows up in the location where they are registered, and shows their photo ID, the county election official has to allow them to vote. I don•t think anyone would argue something different.

86% of the voters Mark Davis identified did exactly that• showed up in person at the location where they were registered, showed their photo ID, executed a voter certificate saying they resided where they are registered, and then they were allowed to vote. The other 14% voted absentee by mail, submitting an absentee ballot application saying that they still resided where they were registered.



Again, this is not a new issue. It is an issue caused by out of date federal law that Secretary Raffensperger has said needs to be fixed since he became Secretary of State. He even went to DC to tell our Congressmen it needed to be fixed before the 2020 election. They didnot take any action. We have consistently said that the issues we were seeing post 2020 election were similar to issues to that come up after any election. This is exactly one of those issues. It doesnot invalidate the 2020 election any more than it invalidates any previous election in Georgia. It does highlight that the federal law that restricts dates from keeping better voter rolls needs to be reformed, just like Mark Davis said in his sworn declaration and Secretary Raffensperger has been saying since he was elected.
