On the 20 day of MARCH, 2022, at 21:30 at (WALMART) 3200 NW 79TH ST. MIAMI, FL, 33147

ON SUNDAY, MARCH 20, 2022, THE VICTIM WAS INSIDE OF THE INCIDENT LOCATION SHOPPING. WHILE SHOPPING, THE DEFENDANT APPROACHED THE VICTIM FROM THE REAR AND PULLED HER DRESS UP WHILE GRABBING HER BUTTOCKS. 
MDDP OFFICERS RESPONDED TO THE INCIDENT AND DETAINED THE SUBJECT.
