#### AFFIDAVIT of PROBABLE CAUSE

On 08/27/2021 I, your Affiant, was dispatched to the south side steps of Old Main for a fight in progress. A protest was being conducted for Pro-Vaccine Mandating at the time. While in transit dispatch advised there was a white college aged male wearing a high visibility vest with blood all around his nose and mouth. Upon arrival I observed the male, who was later identified as Victim Avi Rachlin by his New Jersey photo driver's license, to have blood running from his nose all the way down the front of his neck. The victim was escorted away from the crowd to be assessed by University Ambulance Service. The victim advised he was there to counter protest peacefully and only sought to exercise his 1st Amendment right. Subsequent to the assessment the victim was transported to Mount Nittany Medical Center for further evaluation. Dispatch continued to view footage to try and identify suspects and while still on scene video footage was forwarded to us that had been posted to Twitter on the @CentreCountyRep page. The video showed a white skinned, brown haired, bearded, male wearing blue jeans and a white and gray vertically striped button up short sleeved shirt along with several other males and one female attempting to cordon off the victim from moving freely. While the victim moved back and forth adjacent to the southern steps at Old Main the above stated individuals continued to follow him closely while still attempting to cordon off the victim from the rest of the crowd. Several times, while walking back and forth the above stated individuals had physical contact with the male in the way of shoving or body checking. The victim can be seen going back and forth with a rectangular cardboard sign approximately two feet by three feet in size held with both hands above his head. The male with the vertically striped button up shirt at one point grabs the sign and attempts to take it by force. The victim holds on with both hands as is subsequently pulled to the ground. The struggle continues once on the ground and a few seconds later the victim can be seen back on his feet with a bloody face, and can be heard velling "get the fuck off me".

I, JESSE CLARK, BEING DULY SWORN ACCORDING TO THE LAW, DEPOSE AND SAY THAT THE FACTS SET FORTH IN THE FOREGOING AFFIDAVIT ARE TRUE AND CORRECT TO THE BEST OF MY KNOWLEDGE, INFORMATION AND BELIEF.

### AFFIDAVIT of PROBABLE CAUSE CONTINUATION

The male depicted in the video attempting to take the sign was no longer present at the protest after reviewing the video. Upon return to station I checked surveillance video for that area and was able to observe the male walk away from the scene upon our arrival. I was able to trace the male back to the Burrowes Building across several cameras, and observed him entering the south west entrance to the building at 1512 hours. I observed the male from the interior camera entering the first half of the ground floor hallway. From another camera inside Burrowes building I was able to view the male go to the men's bathroom (located between the center of the office area hallway and the open stairwell area) then go back to the first half of the ground floor office area hallway. I went to the area where the male was observed and looked up the names on the office doors. I was able to identify a physical match with the photo associated with the name of the defendant WALTER OLIVER BAKER (listed on the door as Oliver Baker), by Pennsylvania photo driver's license information ran through CLEAN/NCIC.

Victim Rachlin stated in a follow up interview that he believes he may have struck his head when pulled to the ground by defendant Baker, and that the injury to his nose he believed happened during the struggle when BAKER'S shoulder made contact with his face.
