Dear Ms. Fridfinnson:

This is to acknowledge the receipt of your request and that application fees on February 23, 2022. We note that you wish to obtain, pursuant to the Access to Information Act:

I am seeking reports related to spousal homicide in Canada between December 2020 and January 2022.

The purpose of this letter is to seek clarifications from you in order to locate records responding to your request. It is not clear, from the wording of your request, what information you are seeking. In addition, your request is not sufficiently detailed to enable an experienced employee of the Department to locate relevant records. Before conducting a search of our records, we require clarification from you concerning the information you are seeking. Please explain what you mean by reports, are you simply looking for statistics on spousal homicide in Canada? We would also ask that you provide additional information on the kind of records you believe the Department of Justice might have on this matter. We would appreciate if you could clarify or rephrase your request and specify which documents are being sought.

We also suggest, if you have done so, to make a request to the Royal Canadian Mounted Police, Public Prosecution Service of Canada and Statistics Canada who might have more interest in the record being requested. Your requests can be sent to the following addresses:

As per section 8 of the Act, Where a government institution receives a request for access to a record under this Part and the head of the institution considers that another government institution has a greater interest in the record, the head of the institution may, subject to such conditions as may be prescribed by regulation, within fifteen days after the request is received, transfer the request and, if necessary, the record to the other government institution, in which case the head of the institution transferring the request shall give written notice of the transfer to the person who made the request. Therefore, we can ask PPSC to see if they would accept the transfer of your request or continue with your request which will probably result with a response of no records. Please advise us accordingly if you wish us to transfer your request.
