INDICTMENT

The Fall 2021 Term Grand Jury, in and for VOLUSIA County, Florida, empaneled and sworn to inquire and true presentment make, hereby, in the name of and by the authority of the State of Florida, brings this prosecution and makes the following charges:

COUNT I

CHARGE: FIRST DEGREE MURDER WITH A WEAPON, in violation of sections 782.04(1)(a) and 775.087(1) of the Florida Statutes (2021)

SPECIFICATIONS OF CHARGE: JEAN ROBERT MACEAN, on or about March 6, 2022, in the County of VOLUSIA and State of Florida, did then and there unlawfully, while acting from a premeditated design to kill BRENDA AULTMAN, did kill and murder BRENDA AULTMAN, a human being, by repeatedly stabbing her with a knife; and JEAN ROBERT MACEAN during the commission of said offense did carry, display, use, threaten to use, or attempt to use a weapon (a knife). (Capital Felony)

COUNT II


CHARGE: FIRST DEGREE MURDER WITH A WEAPON, in violation of sections 782.04(1)(a) and 775.087(1) of the Florida Statutes (2021)

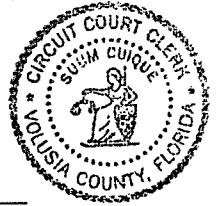


