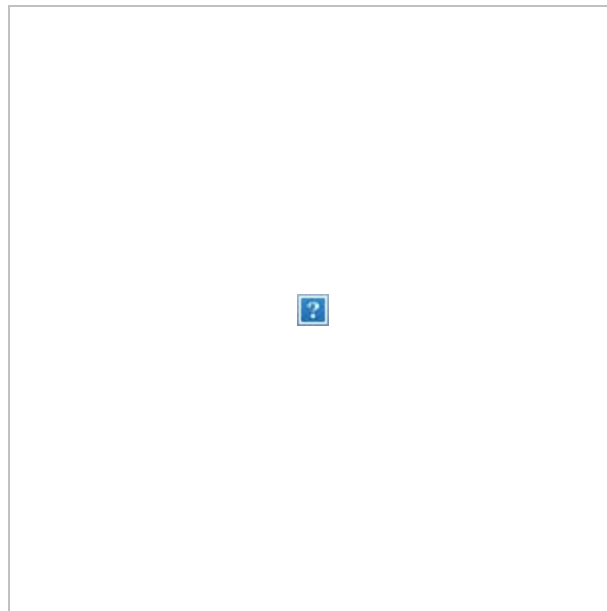

Students for Life of America, the world's largest pro-life youth organization that works with nearly 1,300 middle school, high school, college, medical and law school groups, launched Students for Life Action, a 501(c)4 organization in 2019.

Since that time, Students for Life Action has dramatically increased the Pro-Life Generation's presence in state legislatures and in state legislative election efforts. We have also pioneered a **"Vote Pro-Life First"** national and state election effort to encourage all pro-life citizens to vote and understand which candidates support their values. Our goal is to help state legislative leaders prepare for a reversal of *Roe v. Wade*.

THE FUTURE IS ANTI-ABORTION

As we approach the end of the legislative session, we are celebrating the influence of the Pro-Life Generation and are excited about the upcoming Mississippi case headed to the Supreme Court.

Our President Kristan Hawkin's tweet "Hey, hey, ho ho. Roe v Wade is going to go!" was shared by the Washington Post [in an analysis of the upcoming SCOTUS hearing](#).

Now is the time to build a Post-Roe America. We are working to create a pro-life future by training pro-life leaders to engage in state fights to abolish abortion, change the culture on their campuses, and pass as much pro-life, pro-family legislation as we can! ABOLISHING ABORTION, STATE BY STATE

At Students for Life Action, we have been working with state legislators in numerous states to challenge *Roe v. Wade* by passing state-level **Life at Conception Acts** to ban abortions outright and laws to ban abortions when **fetal heartbeats** can be detected.

Arizona

Students for Life Action's ability to engage and mobilize within just a few hours paid dividends in Arizona this year.

During last year's Arizona state primary cycle, State Senator Nancy Barto defeated, *with the help of SFLAction*, an alleged "pro-life" Republican incumbent that blocked pro-life bills from passing. After being sworn in, Sen. Barto wasted no time introducing pro-life legislation this session. Her pro-life omnibus bill, SB 1457, combined several pro-life pieces of legislation into one, including a ban on abortions based on genetic abnormalities and a ban on mail-ordered chemical abortion pills.

When it came down to final passage in the state senate, one Republican senator became a hold up and refused to support the bill. Within hours of being notified, Students for Life Action alerted 23,794 pro-lifers in this senator's district, informing them of his refusal to support the life-saving bill. Just a few days later, he dropped his opposition. The bill proceeded to pass the senate by a vote of 16-14 and was signed into law.

[Kristan Hawkin's op-ed](#) on the front of the Washington Post details why the strategy of pursuing anti-discrimination anti-abortion laws, like SB 1457 in Arizona, is a fresh and effective strategy of pointing out the prejudice of the abortion industry and its lobby.

Texas

In Texas, we worked to support several pieces of legislation and saw victory, including the **TX Heartbeat Bill (SB 8)**, and **The Human Life Protection Act (HB1280)** which will abolish abortion as soon as *Roe* is reversed. Our student leaders have been [testifying regularly at each stage of the legislative process](#). Planned Parenthood is planning a protest at the Texas capital on May 29th in response to these amazing pro-life victories.

The abortion industry giant is furious that the Pro-Life Generation is making strides in Texas! Their anger will not intimidate us, in fact, we will be there to counter protest and remind the Texas legislature of their duty to protect innocent human life. Please pray for the safety of all this Saturday! Protesting at hostile events is nothing new for us at Students for Life, in fact [we have crashed the Women's March](#) in DC since 2016!

Arkansas

We were heavily involved in Arkansas to [pass Sen. Jason Rapert's abortion ban](#). After extensive advocacy from Students for Life, the Arkansas Governor signed the bill into law!!

South Carolina

In South Carolina, **we supported the Heartbeat Bill (SC0001)** with our programming efforts. In addition, the Students for Life Regional Coordinator involved student leaders and [brought them to testify in favor of the bill](#).

Oklahoma

In Oklahoma, we helped draft SB 612 and worked with Senator Nathan Dahm to introduce it. **If passed, this legislation will completely ban abortions in Oklahoma.** Read about our student lobby day [here](#). The bill has not received a final vote in the House yet because legislation in Oklahoma carries over to the next year, so, when they reconvene in February, **we will be ready!**

Idaho

After months of advocacy, Idaho passed the Heartbeat Bill HB366 and the Governor signed it into law. We mobilized pro-life students and voters to stop an amendment to another version of the bill that would have weakened penalties for abortionists.

Students for Life Action worked closely with legislative champions in every state, and it has been a wonderful opportunity to get pro-life student leaders involved and mobilize the Pro-Life Generation Army to support life-saving legislation. **We have seen legislative victory after legislative victory, and we need YOUR help to keep up the momentum.** If you are interested in partnering with us, please reach out to me at Lbranham@studentsforlife.org.

STOPPING CHEMICAL ABORTION

Throughout the COVID-19 pandemic, abortion perpetrators like Planned Parenthood have pushed for a new business model that targets young women where they are at –in dorms, and online. This business model allows chemical abortion pills to be sent to women, *without an examination, confirmation of pregnancy, ultrasound, or blood test*, through the mail or through a pharmacy. Without these important safeguards, women are at risk of injury, infection, infertility, and even death.

Although there is no medical reason to recklessly distribute these pills, the abortion lobby has pushed the Biden Administration to deregulate them and HHS Director Becerra recently concurred, setting the table for the FDA to gut the safety regulations. Groups like Planned Parenthood want reckless, deadly, sterilizing distribution because the distribution of these pills is better for their bottom line.

We have successfully **filed bills to ban chemical abortion in Wyoming, West Virginia, Alabama, and Iowa** and will continue to mobilize to pass these bills and file more across the nation next legislative session.

Students for Life Action has also advocated for legislation to stop the online distribution of chemical abortion and inform women of the dangers of the pills and the possibility of chemical abortion reversal in **Montana, Texas, Oklahoma, Arizona, Indiana, Arkansas, Kentucky, Massachusetts, and Maryland.**

We saw victories in Arizona, Arkansas, Indiana, Ohio, Montana, and Texas to stop online distribution or create further restrictions and are working to pass chemical abortion bans next.

Federal Court Temporarily Blocks Texas SB 8

Law is Designed to Protect Unborn Children Whose Hearts

Have Begun to Beat

WASHINGTON – On Wednesday night, Federal Judge Robert Pitman, an appointee of President Barack Obama, agreed to an “emergency” request from the Biden administration seeking to block the enforcement of a Texas law (SB

8) designed to protect unborn children whose hearts have begun to beat.

“Abortion stops the beating heart of a unique and irreplaceable human being,” said Carol Tobias, president of National Right to Life. **“National Right to Life is grateful that SB 8 has likely saved over 3,000 lives since it went into effect.”**

The state of Texas filed a statement with the court in response to the Department of Justice request in which it noted the “inflammatory rhetoric” the U.S. Department of Justice used in its filing. Judge Pitman’s ruling used similar language to that of the Biden administration’s appeal to block the law.

“Abortion is the greatest violation of human rights today,” said Tobias. **“We are hopeful that, on appeal, the courts will recognize that unborn children have a right to life—which is our most fundamental right.”**

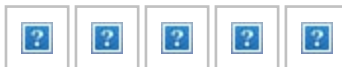
The request to block the law that was filed by the Department of Justice is in line with President Joe Biden’s demand for whole-of-government action in response to the U.S. Supreme Court’s decision on September 1 not to block implementation of SB 8. The High Court’s decision was designed to allow the lower courts to examine the unique legal questions presented by the law—a decision consistent with proper legal procedures involving issues presented to the Supreme Court.

“Joe Biden’s whole-of-government action on SB 8 shows just how deeply this administration is in league with the abortion industry,” said Carol Tobias, president of National Right to Life. **“In no other area, from Kabul to crime prevention, has Joe Biden shown such dedication.”**

The House is in recess and the Senate is scheduled to go on recess next week (subject to change pending the outcome of legislation addressing the debt limit).

Continuing Resolution -- Annual Government Funding

On September 30th, Congress passed, and President Biden signed, a continuing resolution to fund the government. This temporary measure maintaining current spending levels and abortion funding restrictions will run until December 3 and will need to be readdressed then. A continuing resolution means that last year's appropriations, which contain the Hyde Amendment as well as other abortion funding restrictions, would remain in place for the time being.

So-Called “Women’s Health Protection Act” / “Abortion Without Limits Act”

In response to Texas SB 8 which permits civil remedies against performing abortions after a heartbeat can be detected, the House voted on the radical Women’s Health Protection Act (WHPA). The WHPA is designed to remove essentially all legal protections for unborn children on both the federal and state level.



Sen. Schumer (D-NY) has used Rule XIV to place the bill directly on the Senate calendar, meaning that it could be called up for a vote at the time of Sen. Schumer’s choosing.

On this vote, Roll Call No. 295, 218 Democrats voted in favor of H.R. 3755. 210 Republicans and one Democrat (Cuellar - TX) voted against the measure. Three members did not vote (Cheney R-Wy., Lesko R-Az., and Lawson D-Fl.)

Among the protective laws that the bill would nullify:

*Requirements to provide women seeking abortion with specific information on their unborn child and on alternatives to abortion;

*Laws providing reflection periods (waiting periods);

*Laws allowing medical professionals to opt-out of providing abortions;

*Laws limiting the performance of abortions to licensed physicians;

*Bans on elective abortion after 20 weeks when an unborn child is capable of feeling pain;

*Laws that require parental involvement in the case of a minor’s abortion;

*Bans on the use of abortion as a method of sex selection and on abortion done upon a diagnosis of Down Syndrome.

The bill would also invalidate nearly every previously enacted federal limits on abortion. That would include federal conscience protection laws and most, if not all, limits on government funding of abortion. National Right to Life strongly opposes this sweeping legislation.

In addition, Congresswoman Julia Letlow (R-La.) offered a motion to recommit (MTR) the bill following debate over the Women's Health Protection Act. The MTR would have amended the Women's Health Protection Act to include the language of Rep. Ann Wagner's (R-Mo.) Born-Alive Abortion Survivors Protection Act (H.R. 619). This vote, Roll Call No. 294, failed by a vote of 210-219 along party lines.

Ongoing work on the 3.5 trillion + social spending package (votes possible)

Congress is also working on a massive \$3.5 trillion social spending plan using the reconciliation process. The threshold under this process is 51 votes and thus is not subject to a filibuster.

While several Senate Democrats have expressed concern over the size of the package, the House has moved ahead crafting language. The House Democrats' \$3.5 trillion reconciliation bill creates radical expansions of taxpayer funding for abortion and the abortion industry. This includes several schemes to use reconciliation to bypass the Hyde Amendment to provide abortion on demand to the Medicaid coverage gap population in the 12 states that have not expanded Medicaid. Sen. Manchin has voiced opposition to abortion funding, while many members of the House remain committed to funding abortion in the package. President Biden, when asked about abortion funding on Monday October 4th, told reporters "I'd sign it either way."

Below is an overview of some of the pro-life problems in the House committees' reconciliation bill text.

*The legislation would mandate abortion funding in Affordable Care Act (Obamacare) plans in states that did not expand Medicaid in 2024.

* In the states that did not expand Medicaid, the legislation creates a Medicaid look-a-like program which does not run through regular appropriations and would fund abortion.

* The legislation would fund abortions using reinsurance payments and cost-sharing funding to states.

* The legislation would make the Obamacare expansion from the Covid-19 American Rescue Plan Act permanent. This would further subsidize Obamacare exchange plans that cover abortion, and subsidize millions of individuals taxpayer-funded plans that cover abortion on demand.

* The legislation directs billions of dollars to various public health grants without Hyde Amendment protections.

Title X family planning rule finalized

On October 4, 2021, the Biden administration announced the official reversal of a President Trump era policy that prevented taxpayer funds from going to health facilities that performed or promoted abortion as family planning. The Title X program directs millions of dollars to states for family planning services.

Under President Trump's Title X rule, abortion facilities could not be in the same location where family planning services were delivered. The rule also stated that Title X grantees could not refer for elective abortion. The rule did not cut funding for family planning but ensured that funding went to health facilities that did not perform or promote abortion as family planning.

Like all Title X providers, Planned Parenthood had the option to comply with the Trump Administration 2019 Title X Final Rule which faithfully implements the statutes, but chose to drop out of the program. Under the Biden rule, they and other abortion providers are expected to again receive millions of dollars. States who prioritize funds away from abortion providers will continue to be able to do so.

Voting Legislation - the so-called "Freedom to Vote Act"

S. 2747, the so-called "Freedom to Vote Act" is substantially similar to previous election bills seen earlier this congress including H.R. 1/S.1. S. 2747 is likely to be voted on in the Senate this week. This legislation would need 60 votes to advance, and at this time, no Republican has voiced support for the measure.



S. 2747 is intended to make it as difficult as possible for corporations (including nonprofit, issue-oriented corporations such as NRLC) to spend money to communicate with the public about the actions of federal officeholders, by applying an array of restrictions on ads, as well as requirements that violate the privacy rights of donors.

NRLC expressed its strong opposition and intention to score a vote on the bill in a letter on the substantially similar S.1/S.2093 to the Senate and will again express opposition to this newest version.

Chair Grall,

Thank you for having Sarah Butters from the Real Property, Probate and Trust Law (RPPTL) Section of the Florida Bar present to the Civil Justice Subcommittee on Trust Law in Florida. I hope that it was helpful information. I know that I definitely learned a few things!

This e-mail is to advise you about an issue that was mentioned by the Elder Law Section (ELS) at the Civil Justice Subcommittee meeting that is of serious concern to the RPPTL Section. In response to a question, the ELS representative presented information regarding the ELS support of the Uniform Guardianship Jurisdiction Act.

The RPPTL Section has a position in opposition to the adoption of the Uniform Act as described in the attached white paper. In short, the Proposed Florida Guardianship Jurisdiction Act as supported by the ELS would weaken Florida guardianship law protections by requiring Florida Courts to accept the evidentiary findings and determinations of a foreign court with regard to the incapacity and guardianship of an individual.

It is the RPPTL Section position that this would significantly reduce Florida's power and authority to protect all people within Florida's borders. Further, the adoption of the proposed act would do nothing to change the applicable Florida "home state" law from being applied in a "granny snatching" case where a Florida granny is taken to a Uniform Act state and Florida has exercised jurisdiction. Adoption of the Uniform Act by Florida does not solve the problem that it is represented to solve and would instead create additional problems by weakening Florida's guardianship laws.

I wanted to alert you to this concern and to the fact that the RPPTL Section and the ELS have opposing positions on this issue.

I am attaching 2 documents that address questions from our previous conversation on the HELP Act.
HELP Act Responses provides reasoning for the inclusion of “fundamental right” in the findings, and the inclusion of payers within the scope of the bill.
HELP Act House Revisions is a markup of the bill itself, with comments from several ADF staff on several issues.
There is one major change to the document. ADF Legal has added specific “opt-in” conscience protection around the issue of abortion. This represents their new model language, and was included for the sponsor’s consideration.
Florida law currently protects the conscience rights of healthcare workers in regard to abortion as an “opt-out” (F.S. 390).
Christa is certainly more qualified to opine on this issue than I am, and the decision rests with Representative Snyder as to whether he wants to add this language.

Hi Mark,

Per your conversations with Sabatini's people, attached is the 2019 Florida Heartbeat bill. This is a good place to start. There's nothing in here we would object to.

There's also a lot of additional provisions --- this is kind of an omni-bus bill, with updated informed consent language, and clinic regulatory and reporting provisions. All of it's good, but it makes the bill more complicated to explain. We may want to keep it simple.

There's two approaches here:

1. He can submit the whole thing – basically pick up the fight where it was left off, with Students for Life's support. Groups that were behind it before would have a tough time opposing it.
2. We can just keep the heartbeat provisions, making it a very simple and short bill, easy to promote to supporters/legislators.

Either way, I'd like to set up a call with him/them to talk about what we want included and what we don't. For what it's worth, I would also make violations of the section a Second Degree Felony rather than Third Degree. Third degree felonies carry no minimum sentence. So a pro-abortion judge could simply find the abortionist guilty and let him go.

Felonies of the second degree do require punishment. From what I read (and this may be out of date), conviction for selling pot to a minor is a second degree felony in Florida. So if anyone jumps down his throat on that, there's a pretty readily available response.

They'll certainly have questions as well. So getting on the phone soon after the holiday would be my preference to iron out details and talk about a roll out.

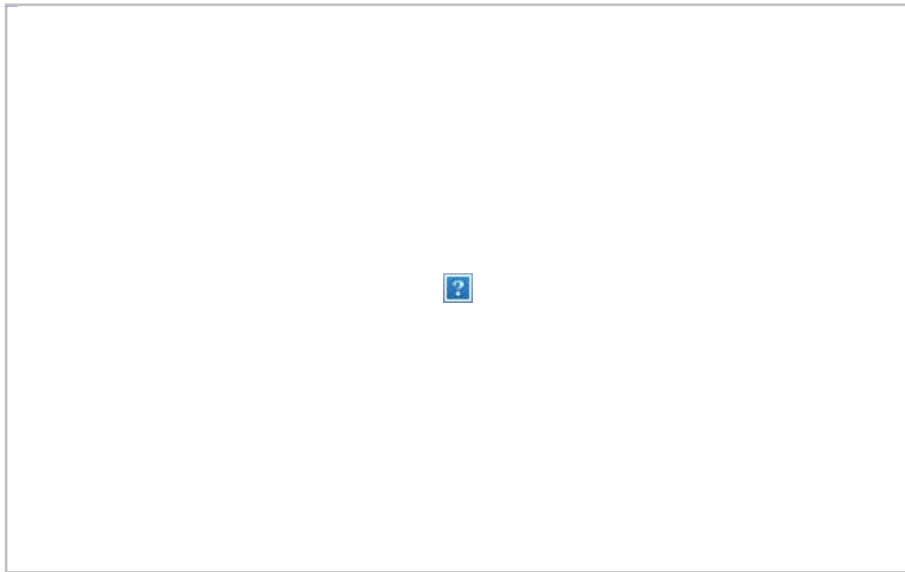

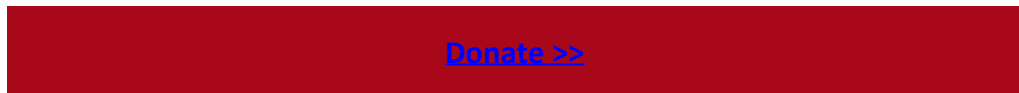

Hi Mark,

Per your conversations with Sabatini's people, attached is the 2019 Florida Heartbeat bill. This is a good place to start. There's nothing in here we would object to.

There's also a lot of additional provisions --- this is kind of an omni-bus bill, with updated informed consent language, and clinic regulatory and reporting provisions. All of it's good, but it makes the bill more complicated to explain. We may want to keep it simple.

There's two approaches here:

1. He can submit the whole thing -- basically pick up the fight where it was left off, with Students for Life's support. Groups that were behind it before would have a tough time opposing it.
2. We can just keep the heartbeat provisions, making it a very simple and short bill, easy to promote to supporters/legislators.

Either way, I'd like to set up a call with him/them to talk about what we want included and what we don't. For what it's worth, I would also make violations of the section a Second Degree Felony rather than Third Degree. Third degree felonies carry no minimum sentence. So a pro-abortion judge could simply find the abortionist guilty and let him go.

Felonies of the second degree do require punishment. From what I read (and this may be out of date), conviction for selling pot to a minor is a second degree felony in Florida. So if anyone jumps down his throat on that, there's a pretty readily available response.

They'll certainly have questions as well. So getting on the phone soon after the holiday would be my preference to iron out details and talk about a roll out.

Thank you for getting back to me. I have reached out to many politicians and offices this past week and I was beginning to lose hope. My daughter is 11 and she joined the Dive N2 Life program in June. <http://diven2life.org/> They are a non profit organization with Federal Tax ID 82-3092883. Operations continued until the end of August when they suspended face to face meetings, training and all recreational dive activities. In a private text conversation, the DSO told me they were hoping to start back up but would require covid vaccinations. As my daughter is 11 she is not currently old enough to receive the vaccination and I suspect this is why they have suspended the program until the Fall of 2022. She currently has a religious exemption for school. There is a Junior scientific dive program that she would be eligible for in February when she turns 12 but they are now requiring proof of all vaccinations. The text below is copied from their DSM which I have attached. I have also attached a couple of screenshots of messages saying it will be required.

All candidates must present copies of tests, lab reports, and a complete vaccination/immunization record with all WHO and/or CDC recommended vaccinations, including the COVID-19 vaccination/immunization. There are no waivers or exemptions for vaccination requirements except in the rare case of an allergy to vaccine ingredients, in which case an alternative vaccination is required.

I am heartbroken for my daughter, she has put everything into this program and will now be discriminated against due to her vaccine status. I was told the program was a STEM enrichment program for gifted children who often do not get the support and challenges they need at school. All of the instructors commented on how she is a natural, picks things up quick, bright, smart, just gets it. She has sailed through the program so far. She was given special permission at 11 years old to take both Diver Stress and Rescue and React Right. The minimum age is 12 years old. She was on track to become a Master Diver at 12 years old. My daughter was just accepted into the school gifted program earlier this month.

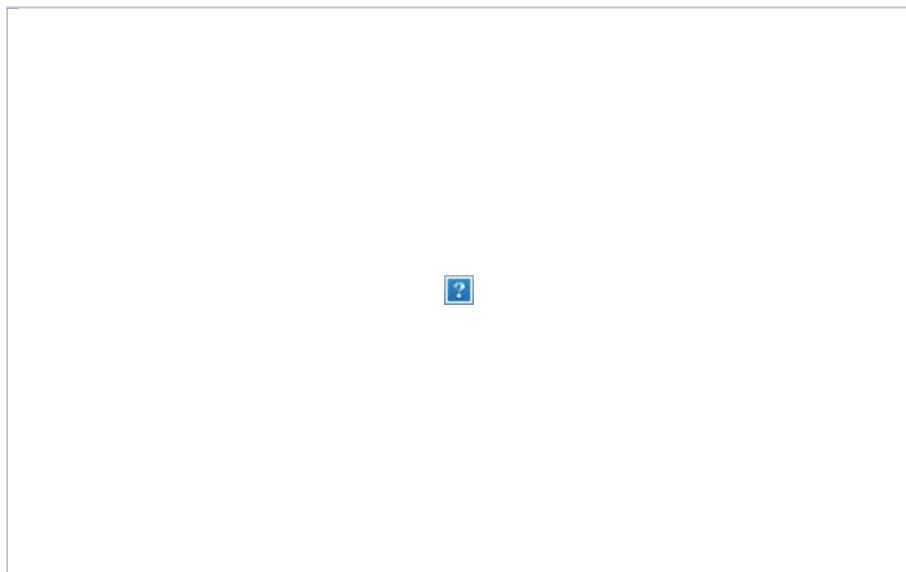

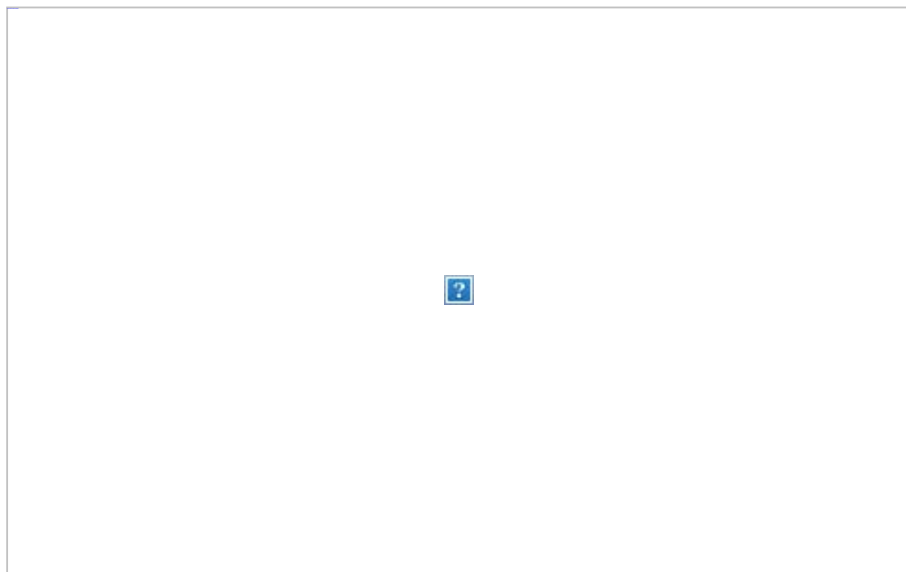
