



This is what Betsy and I pulled together regarding the change in data. & why.

1. HR360 Data that wasn't fully entered:

- a. We texted Gary again to confirm hr360 submitted all their data. They did not, but Gary updated it this morning & We have all their data now.
- b. **HR360 agreed to use the new data reporting form –** this will put an end to the messiness regarding the HR360 data
- c. Rob went over the definitions of the encounters with Gary & Paul because I have concerns about the hr360 metrics.
 - i. I think they are reporting interactions as meaningful engagements cannot confirm this but this is a likely symptom of them not engaging with our form and definitions.
 - ii. I observed the HR360 staff and did not see anything that can account for

the high numbers of meaning engagements

- iii. I think Gary is just making up random #s
- d. Follow up with HR360 staff onsite needed to support them with the use of the form Rob H. will follow up with Ops team & delegate training HR360 staff on Form and tracking metrics
- 1. Health staff Pulled to monitor elevators, etc. may have resulted in less referrals

Here's a brief summary of what happened with HR360 data for us to explain to the public-please feel free to edit. Krista/Hillary, where should this go next?

Part-way through the most recent reporting period (OP10), the TLC metrics team discovered that one of the CBOs was inaccurately recording data on engagements. The staff mistakenly counted all guests to the privacy area as "meaningful engagements to drug user health (I.e Syringe Programs)," which resulted in inflated engagement numbers. This mistake has since been resolved and staff are recording engagements more accurately. As a result, the reported numbers for engagements will significantly decrease this week and next week, though the services themselves have not actually decreased and, based on overall

utilization of the TLC, are likely to grow from this baseline moving forward.

Here's the full version of what Rob just sent me in case there are any additional details you think are important to share:

When we launched the first version of the form "interactions" was a metric. It was cumbersome and eventually everyone agreed that all guests who visit the site have interactions. In that first week Gary from healthright was given permission to report data directly to me outside of the form. I was not the person who approved that.

After the second & third week there were concerns with HR360's data, but Gary from HR360 insisted it was valid. Rob Hoffman reviewed the encounter definitions and asked HR360 to make sure they reported data within those definitions.

• HR reported high numbers of referrals and meaningful engagements to HR360 dental & primary care.

Starting OP8 we changed forms and made the definitions static.

• Health right staff started reporting high numbers of meaningful engagements to Drug User Health.

Start of OP9- HR360 started using the online form. They still reported extremely high numbers of meaningful engagements

OP10

I also observed hr360 staff using the form. I spoke with the hr360 frontline staff and instructed them how to use the form. Reviewed the definitions and gave examples.

This resulted in the drop in OP10. Part way through the week the frontline hr360 staff learned they were collecting data outside of the definitions and self corrcted.

I escalated this and met with HR360 leadership.

They explained their staff misunderstood and counted everyone they handed a flyer to about dental & primary care was counted in the original numbers (so everyone that visited the area got a flyer) as an encounter. Meaningful engagement or referral.

When we changed the form, they started counting guests as meaningful engagements to drug

user health (I.e Syringe Programs). The staff on the ground thought that was how they were instructed to collect the data. People visiting the space who they offered supplies to and they talked got counted.

Tracey Lee & Paul Harkin from HR360 came up with a plan to retrain all staff and have ensured that all staff will be collecting data and trained this week.

We may see another drop in hr360 data. HR360 is doing important work and connecting with guests which is all part of the continuum of care but they were collecting data incorrectly. They were associating the meaningful work they do with meaningful enagements.

Subject: Need for DSW extensions

Hi Roland and Susan-

As you guys heard earlier today, we are in the process of transitioning to our "Phase 2" of the TL work. We are transitioning the leadership of the response to Krista Gaeta and Matt Goldman (cc'd here). They have been working with Greg and Luenna on securing contracts to run the front-line staffing of the site, as well as on hiring for the leadership of the site. We anticipate having some new hires starting as early as this week, and the contracts are in process, but we know that there may be delays, and we also want a bit of overlap time for the previous staff to handover to the new. To that end, we would like to ask to extend the DSWs indicated for one more month (to March 15th). The extensions come with the acknowledgement that departments need their staff back ASAP, and we are working to get the new hires/contracted positions in place as quickly as possible, and will release people early whenever possible. But we also recognize that there may be unforeseen delays and want to make sure we have continuity of operations.

Susan, the PHD staff who are being asked to extend are CHEP staff, and the team is working with Tracey on this, but we wanted you to be aware.

Roland, the majority of the deployed staff are in the SFHN. We did not include staff here who are working overtime, etc to support the site but that will also likely need that program to continue until the CBO is contracted and onboarded. In the attached spreadsheet I have put where the staff came from (I did it from memory so hopefully it is correct) and what the replacement plan is for them. We were hoping you could socialize this need with ambulatory care, ZSFG, and LHH.

Please feel free to reach out to Matt, Krista and I with any questions and, as always, we appreciate your support. Hiring is moving a lightning speed and contracting is also moving quickly so we are hopeful that we can have these DSWs back to their home departments before their end dates.
