

Freedom of Information Act (FOIA) request 2022-03645

Dear Mr. Leopold:

This letter is in response to your request under FOIA, 5 U.S.C. 552. You are requesting a copy of the following documents (or documents containing the following information) be provided to you:

Records constituting formal investigations, substantiated hotline complaints, after action reports, emails, memos, relating or referring to incidents on commercial aircrafts involving passengers who were not in compliance with Covid-19 protocols.

A search was conducted of the Office of Audit and Evaluation (AAE) FAA Hotline Information System (FHIS) files. The search revealed one hundred and forty-eight (148) pages that pertain to your specific request which will be released to you. Your request has been partially denied because portions of the enclosed documents containing names, telephone numbers, titles and identifying information about private individuals have been redacted and are being withheld from disclosure. One hundred and thirty-three (133) of the 148 pages have been redacted under Exemption 6 of the FOIA. Exemption 6 of the FOIA protects information in personnel, media, or similar files, the disclosure of which would "constitute a clearly unwarranted invasion of privacy. There is no discernible public interest in this information.

The FAA's Office of General Counsel has also been assigned to your FOIA request and will respond to your request separately.

The undersigned is responsible for this partial denial. You may request reconsideration of this determination by writing the Assistant Administrator for Finance and Management (AFN-1), Federal Aviation Administration, 800 Independence Avenue, SW, Washington, DC 20591 or through electronic mail at: FOIA-Appeals@faa.gov. Your request for reconsideration must be made in writing within 90 days from the date that the initial determination was made, and must include all information and arguments relied upon. Your appeal must also state that it is an "appeal" from the above-described partial denial of a request made under the FOIA and include your assigned FOIA control number. The envelope containing the appeal should be marked "FOIA."

You also have the right to seek dispute resolution services from the FAA FOIA Public Liaison via phone (202-267-7799) or email (7-AWA-ARC-FOIA@faa.gov) noting FOIA Public Liaison in the Subject or the Office of Government Information Services (https://ogis.archives.gov) via phone (202-741-5770/toll-free--1-877-684-6448; fax--202-741-5769); or email (ogis@nara.gov).

Processing your request by this office cost less than \$20; therefore, no fees will be assessed.

On August 25, 2020, the Teterboro FSDO was assigned to investigate Safety Hotline Complaint #20200427002. In the narrative description of the complaint, the complainant states the following:

"Several news reports (see links below) state that the Elizabeth Police Department [EPD] in New Jersey is using a fleet of DJI drones citywide to enforce social distancing/gathering orders from the governor in response to the COVID-19 pandemic.

The mayor publicly stated on Tuesday (4-21-20) the police will be flying a fleet of drones "around the City." It appears dozens of flights have already been conducted and numerous summons issued to civilians based upon drone video surveillance.

There are several complaints/issues:

1.) The entire city of Elizabeth is located within Class B airspace down to the surface (Newark airport — KEWR); the city boundary even overlaps Newark airport (KEWR) itself. The entire city is located within 5 nautical miles of KEWR and the center of the city is underneath the departure and arrival paths of the main parallel runways (22L/R and 4L/R/) — including short final for 4L/R.

not know whether the police or city has a COA from FAA or approval from Newark Tower to conduct these UAS operations.

- 2.) (unverified by complainant) the drone(s) likely flew over densely populated areas of the city since the entire city would be considered densely populated under FAA definitions.
- 3.) Since the township profits on each \$1,000 fine, the drone operations serve a commercial purpose for the municipal corporation of Elizabeth and should be subject to Part 107 regulations.

Allowing Elizabeth Police to operate drones in Class B airspace down to the surface would essentially establish a precedent that allows for thousands of drones nationwide to fly for commercial purposes within Class B airspace down to the surface near every major international airport. This would appear to undermine the entire safety purpose behind Part 107 regulations.

The police are not even arresting alleged violators. They are issuing \$1,000 summons, thus calling into question the issue of imminent public safety compared to, say, using a drone to search for a lost child in the woods during the winter or trying to gain intelligence during an active shooter/hostage negotiation situation.

The city of Elizabeth is flying hundreds of drone missions in Class B-to-the-surface airspace for commercial purposes: to enforce what is a misdemeanor offense that will be adjudicated in municipal court. And the incorporated township receives a portion of every \$1,000 fine collected, making it a commercial operation subject to Part 107 regulations.

The investigating office received multiple complaints of the same nature regarding EPD small Unmanned Aircraft System (sUAS) operations, between 04/28/2020 and 05/05/2020. Associated internal complaint control numbers are: CEA2520200038, CEA2520200039, CEA2520200040, and CEA2520200041. Each of these complaints were closed and found to be unsubstantiated.

The subject complaint reports apparent violations of Title 14 of the Code of Federal Regulations (14 CFR) and operations contrary to Title 49 United States Code (49 USC).

Specifically deviations related to 14 CFR sections: 1) 107.41 Operation in certain airspace, 107.43 Operation in the vicinity of airports; 2) 91.119 (b) Minimum safe altitude operations; and 49 USC section: 3) 40125(b) Qualifications for public aircraft status.

In relation to subject complaints numbered one (1) and two (2), EPD sUAS are defined as public aircraft per 49 USC 40102 (a)(41)(C). Per Advisory Circular (AC) 00-1.1B(12) Public Aircraft Operations (PAO) are not bound to 14 CFR part 107. Additionally, PAO may request Certificate of Authorizations (CoA) to operate in certain airspace (including Class B), in the vicinity of airports and at certain low altitudes.

EPD has two active CoAs for sUAS operations authorizing activities as described by subject complaints 1 and 2. Operations authorized by each CoA are listed below, respectively.

- a. 2018-ESA-2930-COA is effective from December 19, 2018 to December 19 2020;
 - Operation of sUAS weighing less than 55 lbs., in Class B and G airspace at or below 200 feet Above Ground Level (AGL) in the vicinity of ELIZABETH, New Jersey under the jurisdiction of Newark Air Traffic Control Tower (EWR ATCT) and New York Terminal Radar Approach Control Facility (N90 TRACON).
- b. 2018-ESA-2843-COA is effective from November 26, 2018 to November 26, 2020.
 - i. Operation of sUAS weighing less than 55 pounds and operating at speeds of less than 87 kts (100 mph) in Class G airspace at or below 400 feet AGL for the purpose of public aircraft operations.

The third (3) complaint questions if EPD sUAS activities where fines may be imposed meet Qualifications for PAO status, 49 USC 40125(b). This matter was reinforced as the main concern by the reporting individual when contacted during the course of the investigation. EPD was also contacted for additional information regarding their sUAS operations. They described the operations as law enforcement activities in accordance with New Jersey Statutes Appendix A. Emergency and Temporary Acts § 9-49 (h) and (i), which provides EPD the authority to enforce Governor Executive Orders. EPD further explained the sUAS flights are performed over public spaces (parks, waterways, etc) where crowds have been observed/identified thru surveillance or complaints. The sUAS are equipped with speakers for public announcements/warnings, in this case to enforce Governor Executive Orders 104 thru 115.

In conclusion, the subject complaint allegations were unsubstantiated. This investigation is considered closed and was documented in PTRS EA25202001937.

Complaint: The Complainant stated: "AA Flight 686 was supposed to depart Miami at 9:53pm. Due to navigation issues, the takeoff was delayed until after 11:00pm. During this delay in Miami, a passenger sitting in (b) (6) refused repeated requests by the flight attendants to don a mask. After this passenger continually removed mask, (6) the flight attendants, and the passenger was not wearing mask. At this point, the flight attendants should have informed the flight deck so that this passenger could be removed while the plane was still in Miami. Instead, the flight attendants on this flight ignored the situation, and the plane departed Miami. During the entire one-hour flight to Jacksonville, this passenger was allowed to defy the mask rules, placing the other passengers at risk. (6) this defiance because (6) (6) sitting in row To make matters worse, the flight attendants failed to notify ground security in Jacksonville so that this passenger could be taken into custody. On this flight, the flight attendants failed in (6) (6) responsibility to ensure the safety of other passengers on this flight. The following information reflects the results of the subject investigation by the American Airlines CMO, provided in this Investigative Results Report.

Summary of Investigative Process: An Aviation Safety Inspector (ASI) assigned to this office has investigated concern in the operation of American Airlines Flight 686, operating from Miami International Airport, FL (MIA) to Jacksonville International Airport, FL (JAX) on March 20, 2021. The ASI reviewed the policies and procedures currently in effect at American Airlines. Our investigation revealed there were instances where the flight attendant had to remind the passenger to wear mask properly, but it did not rise to the level of needing to remove the passenger from the flight or the need of law enforcement. Although, the passenger complied with instructions to wear a mask when asked by flight attendants, we were unable to determine if lowered mask at any time afterwards.

In accordance with FAA Order 8900.1 Volume 7, Chapter 5, Section 1, Paragraph 7-141-F-(3)(4) the complainant was contacted to obtain any additional information and has been notified by the inspector of the results of the investigation.

Investigation Summary/Conclusion: After investigating the concerns detailed in the complaint, we were unable to substantiate a violation of the Federal Mask Mandate and Title 14 CFR Part 121.580, Prohibition on Interference with Crewmember while onboard American Airlines Flight 686 operating between MIA and JAX on March 20, 2021. The ASI determined the crew followed all Federal Aviation Regulations and company policies and procedures regarding safety. The American Airlines CMO considers this matter closed with no further action. The Activity number associated with this event is SW21202105536.

Allegation 1:

The Hotline complaint describes an event on that occurred June 21, 2021. The complainant, (b) flight 985 from Rochester, NY (ROC) to Baltimore, MD (BWI). On June 29, 2021, this inspector was contacted at 1513 CDT by the complainant. We spoke for 13 minutes. (b) (6) was calm and pleasant. reiterated to me the event reported in the hotline report.

the passenger would wear the mask after being told to and then once the crewmembers had left sight of (b) (6) would remove the mask. I asked if the passenger was threatening to or any other crewmember or passenger, (b) (6) the passenger was not. I asked if the passenger interfered in any way with the crewmember's duties.

I gave some examples of conduct by passengers that are prohibited by these rules and statute.

Overview:

The complainant (b) (6) (b) (6) (b) (6) SWA. Thought the FAA was responsible for the mask mandate. This inspector educated the complainant on the SEEP. The complainant was satisfied and now understands how to handle an event of this kind in the future (b) (6)

Finding:

No violation of 14 CFR were substantiated to date.

The information presented here is based on facts derived from the interview and other data collected during the investigation including SWA Inflight employee communications, the flight attendant manual and the request for information regarding the reported flight.

This is in response to Hotline Complaint S20210714001. The investigation and result are as follows:

Allegation 1:

The Hotline Complaint describes an event that occurred on June 29, 2021, on Southwest Airlines flight 2359 from Houston, Texas (HOU) to Orlando, Florida (MCO). The complainant, a passenger, reported passengers on this flight were noncompliant with the mask mandate. The passenger felt it was the flight attendant's responsibilities to enforce the mask requirement more firmly.

Allegation 2:

The complainant alleged that passengers were allowed to congregate near the forward lavatory during the flight. Flight attendants were unsystematic in the handling of these passengers.

On June 29, 2021 Aviation Safety Hotline No. S20210714001 was assigned to the Southwest Airlines Certificate Management Office and subsequently to this inspector. On August 3, 2021 at 1523 CDT, using the phone number provided, this inspector reached out to the complainant. A voicemail was left. A few minutes later on August 3, 2021 this inspector was contacted at 1530 CDT by the complainant. We spoke for 14 minutes.

(b) (6) was calm and articulate.

(b) (6) the passengers (b) (6) did not wear (b) (6) masks for the majority of the flight. (b) (6) went to a flight attendant for assistance. The flight attendant (b) (6) would "just politely ask." Another flight attendant came to (b) (6) row and addressed the noncompliance. The passengers complied.

On August 5, 2021, this inspector called (b) (6) again to ensure I had addressed all concerns. (b) (6) and I also revisited what observed during the flight about passengers congregating near the forward lavatory. (b) (6) the announcement was made in the required phase of flight, but passengers were handled indiscriminately. Some passengers were sent back to sit while others were allowed to stand. The flight deck door was never opened or breached.

This inspector discussed with (b) (6) the TSA mask mandate. We discussed the airlines policy about the flight attendants capability to force passengers to wear the masks. Additionally, we discussed the inconsistencies in handling of passengers at the forward lavatory area. We discussed the FAA's Special Emphasis Enforcement Program and how the FAA is supporting the TSA mandate by holding passengers responsible for violations of Title 14 Code of Federal Regulations § 121.580 and 91.11 or Title 49 United States Code § 46318. (b) (6) witnessed no interference of crewmember duties.

Overview:

The complainant thought the mask mandate was handled poorly by Southwest Airlines.

(b) (6) thought the FAA was responsible for the mask mandate. This inspector informed the complainant regarding the inconsistencies observed. The complainant was satisfied with the handling of report and now understands the airline's policy to not have the flight attendants police masking requirements.

Finding:

No violation of any Code of Federal Regulations were substantiated to date.

Evidence:

This inspector from the Southwest Airlines Certificate Management Office investigated this safety hotline complaint. The information presented here is based on facts derived from the interviews and other data collected during the investigation including Southwest

Airlines Inflight employee communications, the flight attendant manual and the information regarding the reported flight. No crew reports were submitted.

Conclusion:

With the complainant's permission, the narrative of the report with (b) (6) contact information was shared with (b) (6) Inflight Regulatory and Compliance for information and tracking. The investigation determined there was no evidence of a violation of Title 14 Code of Federal Regulations. The complainant was satisfied with the outcome of the investigation.

This complaint investigation is closed with no further action.
