Request made under the Official Information Act 1982

Thank you for your email of 23 February 2022 requesting the following information under the Official Information Act 1982 (the Act):

documents and communications around NZ bitumen supply, including:

- 1. A copy of the plan or proposed plan for bitumen supply from 2022
- 2. A copy of the results and report of Project Kopapapango [or similar if I got that spelling wrong] investigation into bitumen supply 2021/21. Pls include any paper/report arising from the RFI
- 3. A copy of any minutes of WK committees taking recommendations to the board about the above
- 4. A copy of any minutes where the board considers these recommendations and/or makes a decision on the way ahead
- 5. A copy of the most substantive advice to the Minister about this
- 6. Any letter and/or paper sent to existing importers of bitumen about WK plans for supply
- 7. Details of any concerns raised by existing importers with WK about this
- 8. Documented details of the latest accurate cost/benefit/risk analyses re
 - a. Security of supply including how to ensure there is enough storage
 - b. Price movements and WK risks in relation to them

- 9. Has WK met with bitumen importers about its plan?
- 10. Has WK made any suggestions around accessing their storage tanks
- 11. Has WK advised which company/ies will be bitumen importers under its plan?
- 12. Will or has WK tendered for a party/ies to do the importing?
- 13. Have any concerns or risks been raised with WK about it?
- 14. Has WK talked to the Commerce Commission about it, and with what result?

I will answer each of your questions in turn.

1. A copy of the plan or proposed plan for bitumen supply from 2022

Following the November 2022 Waka Kotahi Board meeting, Waka Kotahi provided an oral update to the Minister of Transport in December 2021 on the bitumen supply chain board paper and the recommendations approved by the Waka Kotahi Board. There is no copy of the content of this oral update.

11. Has WK advised which company/ies will be bitumen importers under its plan?

This is commercially sensitive information which was discussed under non-disclosure agreements.

12. Will or has WK tendered for a party/ies to do the importing?

Waka Kotahi has not tendered for any parties to import bitumen. Any future procurement will be publicly advertised on the GETS website.

13. Have any concerns or risks been raised with WK about it?

This is commercially sensitive information which was discussed under non-disclosure agreements.

14. Has WK talked to the Commerce Commission about it, and with what result?

Waka Kotahi has engaged the Commerce Commission and it supports the ongoing work to ensure a reliable supply chain for bitumen.

With respect to the information that has been withheld and refused, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.

Under section 28 of the Act, you have the right to ask the Ombudsman to review my decision to withhold this information and refuse parts of your request. The contact details for the Ombudsman can be located at www.ombudsman.parliament.nz.
