Re: Freedom of Information Act (FOIA) Request

Dear Sir/Madam:

We represent the National Rifle Association Political Victory Fund (NRA-PVF) and the National Rifle Association Institute for Legislative Action (NRA-ILA) (collectively "the NRA entities") in this matter. This is a request for records under the Freedom of Information Act (hereinafter "FOIA"). We are requesting records created or dated between the dates of July 1, 2018 and November 24, 2021 relating to the following Matters Under Review (MURS): 7427, 7497, 7524, and 7553.

As the Commission is aware, the Requestors, as well as all named Respondents in the above-referenced MURs, have waived all rights to confidentiality under 52 U.S.C. § 30109(a)(12). Given that such confidentiality rights have been waived, we request the following documents:

- 1. Any and all communications between Commissioners Weintraub, Broussard, Walther, Dickerson, Trainor, and Cooksey, as well as any of their staff, regarding the above-referenced MURs and/or the NRA entities.
- 2. Any and all communications between Commissioners Weintraub, Walther, Broussard, and former Commissioners Petersen, Hunter, and Goodman as well as any of their staff, regarding the above-referenced MURs and/or the NRA entities.
- 3. Any and all communications between any Commissioner and the Office of General Counsel's Office, including but not limited to Lisa Stevenson, Charles Kitchner, and/or any other attorney of the Office of General Counsel assigned to the above-referenced MURs, regarding the above-referenced MURs and/or the NRA entities.
- 4. Any and all legal documents, including but not limited to General Counsel Reports, Statements of Reason, Factual and Legal Analysis, or other supporting legal document associated with the above-referenced MURs and/or the NRA entities.

- 5. Any and all administrative documents, including but not limited to agendas, associated with the above-referenced MURs and/or the NRA entities.
- 6. Any and all vote certifications or other votes on record regarding the above-referenced MURs and/or the NRA entities.
- 7. Any and all communications between Commissioners Weintraub, Broussard and/or Walther with any outside organization, including but not limited to Campaign Legal Center and/or Giffords, regarding the above-referenced MURs and/or the NRA entities.
- 8. Any and all communications between Commissioner Weintraub, Broussard and/or Walther with any reporter or representative of a media organization regarding the above-referenced MURs and/or the NRA entities.

There has been ongoing press coverage regarding the intentions of certain Commissioners to assist certain politically aligned organizations with their efforts to materially alter FECA and Commission regulations. Specifically, three Commissioners, led by Commissioner Ellen Weintraub, apparently refuse to close case files in certain matters after the Commission has voted on their merits and failed to garner four votes to resolve them. ¹ These matters, known by some Commissioners as "zombie matters," have left Respondents in limbo regarding the outcome of their cases. We are under the belief that the above-referenced MURs are part of those "zombie matters."

Worse yet, in certain cases, including in *Giffords v. FEC*, No. 1:19-cv-1192 (D.D.C. 2019), these three Commissioners appear to be defying clear Court order to decide these MURs, with what appears to be the intent to create a pathway for these aligned organizations to sue Respondents via private action under 52 U.S.C,. § 30109(a)(8)(c).³

Then the Democrats are blocking the F.E.C. from defending itself in court when advocates sue the commission for failing to do its job."); Paul Bedard, FEC GOP Targets Democrat's 'Zombie' Blockade, THE WASHINGTON EXAMINER (June 11, 2021) ("The effort targets a power play by Democratic Commissioner Ellen Weintraub, whose six-year term ended in 2008 but was never replaced. She is behind a new trend at the agency to keep open enforcement cases that Republicans vote against in 3-3 ties and then block the FEC from defending itself when the cases go to court for resolution.")

These efforts by these three Commissioners directly impact the Requestors, as they are subject to private litigation as a result of these Commissioners' actions. Therefore, we also request the following information:

- 1. All documents concerning or reflecting the efforts of the Commission to conform with the district court's Order in *Giffords v. FEC*, No. 1:19-cv-1192 (D.D.C. Sept. 30, 2021).
- 2. The FEC's Office of General Counsel memorandum in this matter setting forth its recommendation whether to appeal the September 30, 2021 decision of the district court.
- 3. Any and all communications by Commissioner Weintraub, Broussard, and/or Walter with any outside entity, including but not limited to any and all staff at Campaign Legal Center, Citizens for Responsibility and Ethics in Washington (CREW), Giffords, and Democracy 21, regarding litigation by the Commission.
- 4. Any and all communications by Commissioner Weintraub, Broussard, and/or Walter with any news entity, including but not limited to Campaign Legal Center, Citizens for Responsibility and Ethics in Washington (CREW), Giffords, and Democracy 21, regarding litigation by the Commission.
- 5. Any and all communications by Commissioner Weintraub, Broussard, and/or Walter with Adav Noti, Brendan Fischer, Sandhya Bathija, J. Adam Skaggs, David Pucino, Molly Danahy, Mark Gaber, Kevin Hancock, Megan McAllen, David Kolker, Catherine Hinckley Kelley, and Trevor Potter regarding litigation by the Commission.
- 6. Any and all communications between Commissioner Weintraub and/or her staff and Shane Goldmacher regarding litigation by the Commission.

I am requesting the records as part of ongoing litigation, specifically *Giffords v. National Rifle Association Political Victory Fund, et. al*, No.1:21-cv-02887 (D.D.C. 2021) and *Giffords v. FEC*, No. 1:19-cv-1192 (D.D.C. 2019). Requestors will pay any and all fees associated with obtaining the above requested records.

Please search for responsive records regardless of format, medium, or physical characteristics. We seek records of any kind, including paper records, electronic records, audiotapes, videotapes, photographs, data, and graphical material. Our request includes without limitation all correspondence, letters, emails, text messages, facsimiles, telephone messages, voice mail messages, and transcripts, notes, or minutes or any meetings, telephone conversations, or discussions. Our request includes any attachments to emails and other records, as well as those who were cc'ed or bcc'ed on any emails.

If some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. See 5 U.S.C. § 552(b). If it is your position that a document contains non-exempt segments, but that those non-exempt segments are so dispersed throughout the document as to make segregation impossible, please state what portion of the document is non-exempt, and how the material is dispersed throughout the document. *See Mead Data Central v. U.S. Dept. of the Air Force, et al.*, 566 F2d 242, 261 (D.C. Cir. 1977).
