Terroristic threatening in the second degree AS 11.56.810 (a) (1) (B)

That on April 15, 2022 at or near Anchorage, in the Third Judicial District, State of Alaska; JOHN HOLMAN, having no right to do so or any reasonable ground to believe the persons has such a right, makes a threat that a circumstance dangerous to human life or property exists or is about to exist with reckless disregard that the threat may cause the evacuation of or he initiation of an emergency protocol for a building, public place or area, business premises.

To wit: JOHN HOLMAN did cause the initiation of emergency protocol and disruption of the business Captain Cook Hotel with no right to do so on 04/15/2022 in Anchorage, Alaska.

All of which is a Class C Felony offense being contrary to and in violation of AS 11.56.810 (a) (1) (B) and against the peace and dignity of the State of Alaska.

AFFIDAVIT OF OFFICER ROSS HENIKMAN

1. I am a Police Officer employed by the Anchorage Police Department (APD). I have been a Police Officer for 19 years. I am presently assigned to the Patrol Division. During my tenure as a police officer, I have investigated such cases as sexual assaults, assaults, burglaries, child abuse, death, drug and alcohol, fraud, robbery, scheme to defraud, and theft. These assignments include complaints as well as investigations of felony and misdemeanor crimes. I am currently the assigned investigating detective on case

- 2. I am familiar with the facts and circumstances surrounding this investigation, from my own investigation, witnesses and from information obtained by other law enforcement officers who I believe to be reliable and truthful.
- 3. On 04-15-2022 at approx. 1444 Hours Anchorage Police Department received a 911 call from JOHN HOLMAN (12/27/1969) saying he had 25 guns and wants to shoot "drunk Natives" and wants APD to kill him. HOLMAN indicated he was at the Captain Cook Hotel (939 W 5th Ave, Anchorage, Alaska).
- APD Officers arrived at Captain Cook Hotel and determined JOHN HOLMAN was registered in room CD04.
- Officers were able to contact JOHN HOLMAN in the hotel room verbally from the hallway.

- 6. JOHN HOLMAN began yelling profanities at the Officers and also began yelling for help. JOHN HOLMAN eventually ceased contact with the Officers and barricaded himself in the room.
- 7. Guests had to be evacuated from the Captain Cook and the hotel's normal course of business was interrupted.
- 8. On 04-15-2022 I applied for (telephonically) and was granted a search warrant (3AN-22-01544SW) for the body of JOHN HOLMAN by Judge O'Brien.
- 9. Officers contacted JOHN HOLMAN'S sister, K.H. who arrived on scene near Captain Cook and was concerned about HOLMAN'S mental status. K.H. told Officers JOHN HOLMAN did have firearms with him and in his vehicle. K.H. noted was driving a blue Chevy Silverado (AK plate). Officers had contact with JOHN HOLMAN in this vehicle earlier in the day and found it at present parked near the Captain Cook Hotel.
- 10. I believe JOHN HOLMAN committed the crime of Terroristic threatening in the first degree by causing the evacuation and business disruption of the Captain Cook Hotel.
