**JURISDICTION**

6 This is a case dealing with the Freedom Of Information Act and The Right To  
Know Act 5 U S C § 552 2

**FACTS**

7 On May 19, 2011, I sent Special Agent Michael Rodriguez of the Pittsburgh FBI  
Office, a letter requesting to know whether I was ever investigated, monitored or was  
under surveillance at any time I also want to know whether I'm still under investigation  
I'm making this request under the **FREEDOM OF INFORMATION ACT and the  
RIGHT TO KNOW ACT.**

8 Special Agent Rodriguez has not answered my letter I also included Director of  
the FBI, Robert Muller, in my lawsuit because he's in charge of all other FBI agents

9 On June 6, 2011, I requested from Robert Butelli, Chief of Police for Brentwood  
Police Department, a background check be done on myself

10 I was told by Chief Robert Butelli that the police only investigate those who have  
applied to be police officers


11 I explained to Chief Butelli that I wanted to know whether I was ever under  
surveillance or whether I am still being investigated

12 I also explained to the Chief that I had investigations already done by the United  
States Attorney General Eric Holder, Pennsylvania Attorney General Robert Mulle and  
also the Pennsylvania State Police I paid for these background checks and would also be  
willing to pay the Brentwood Police Department for these background checks

I'm also requesting the Brentwood Police to provide me with any and all  
information -- through the **FREEDOM OF INFORMATION ACT AND THE  
RIGHT TO KNOW ACT**, as to whether I was ever investigated by the police or  
whether I was ever under surveillance for an reason or perhaps I may still be under  
surveillance

I'm asking the court to grant me the right to know whether the FBI or the  
Brentwood Police had ever conducted any type of surveillance and/or investigation of  
me An if such a surveillance is still going on

I'm also requesting a jury trial
