AFFIDAVIT FOR ARREST WARRANT

State of Florida County of Seminole

BEFORE ME, **CALLERY OF CONTRACT** a sworn law enforcement officer, personally came Detective Daniel Anderson, of the Seminole County Sheriff Office, who being duly sworn deposes and says: that your Affiant has reason to believe and does believe that probable cause exists for the arrest of **Joycelyn Montrinice Bryant**, **Florida driver's license number LKA Orlando, Florida 6'02, 170 pounds, Black Female, Brown Hair, Brown Eyes** for a violation of the laws of the State of Florida, to wit: **FLORIDA ANTI-TAMPERING ACT** contrary to 501.001(2)(a) Florida Statutes, **DELIVERY OF MARIJUANA** contrary to 893.13(1)(a)(2) Florida Statutes and **CULPABLE NEGLIGENCE** contrary to 784.05(2), Florida Statutes.

THE FACTS tending to establish the grounds for this application and the probable cause of Affiant believing that such facts exist are as follows:

Your Affiant, Detective Daniel Anderson (hereinafter referred to as Your Affiant) is a sworn Law Enforcement Officer employed by the Seminole County Sheriff's Office. Your Affiant has been a sworn law enforcement officer since October 1987. Your Affiant is currently assigned to the Major Crimes Unit of the Seminole County Sheriff Office. Your Affiant has served as a training deputy, school resource deputy and as a Task Force Agent with the Drug Enforcement Administration. Your Affiant has investigated numerous major crimes, including homicide, aggravated battery, sexual battery, lewd and lascivious battery, money laundering and multinational drug cases that have led to arrest and successful prosecution of responsible subjects.

On February 19, 2022, at approximately 2129 hours, Seminole County deputies responded to 400 Woodbridge Road, Seminole County, Florida in reference to an assist other agency call for service. Upon arrival Deputy Donald Schwarzman contacted Deputy Randy Payette who was attempting to gather information from individuals who were being treated by Seminole County Fire Rescue.

Deputies learned that a wedding had taken place and approximately 50 guests were in and around the clubhouse. Deputy Donald Schwarzman was told that several of the guests had possibly ingested cannabis via the food that was being served at the wedding. Deputy Donald Schwarzman attempted to locate the bride, groom, and the manager of the catering service. Deputy Schwarzman was able to locate Andrew Svoboda, the groom, and Danya Glenny, the bride. Deputy Schwarzman told both Andrew Svoboda and Danya Glenny Seminole County Fire Rescue and the Seminole County Sheriff's Office were on scene. Deputy Donald Schwarzman asked Andrew Svoboda and Danya Shea Svoboda if they had consented to, or requested, any of the food to contain cannabis products. Upon asking that question, Andrew Svoboda stared at Deputy Donald Schwarzman with a blank expression for a few moments before stuttering through a "no". Deputy Donald Schwarzman then attempted to locate the manager of the catering service; however, all of the catering staff were entering their vehicles and leaving the area. The owner of the catering service was subsequently identified as **Joycelyn Montrinice Bryant**.

Deputy Donald Schwarzman began collecting several pieces of glassware that was utilized during the wedding to serve guests. Deputy Donald Schwarzman collected three (3) glasses in an IKEA box. The box was collected from one of the staff members as the box was being carted away from one of the serving tables. The tables were located on the outside at the rear of the event. A large beer glass and a glass were also collected from that table as well. Catering staff who were still present told Deputy Donald Schwarzman the glasses had been utilized during the event.

Deputy Donald Schwarzman collected multiple food items that were discarded from the wedding reception and meal. A bowl and plate were located inside the clubhouse by the sink. They were located with numerous other bowls and plates that had been utilized during the event but had not been cleaned. A handful of lasagna was taken directly from a large container of lasagna that was placed out during the event. Dessert items were located on a dessert table located outside at the front of the event close to the clubhouse entrance and

were later collected by Deputy Schwarzman. Deputy Schwarzman submitted the items into evidence for testing.

Deputy Payette contacted a security guard identified as Joseph Monteleone who identified the catering service as Joycelyn's Southern Kitchen, phone number 407-504-1632 and email address <u>info@jskcatering.com</u>.

Seminole County Fire Rescue treated numerous guests at the reception for symptoms consistent with that of someone who had used illegal drugs. A guest identified as Douglas Postma complained of feeling high when speaking to Deputy Payette. Douglas Postma requested fire rescue check Jennifer Belmonte who told deputies she had been at the reception and had consumed food laced with "marijuana." Jennifer Belmonte requested fire rescue transport her to South Seminole hospital for treatment. Douglas Postma said he was taking an Uber to the hospital as he was feeling "ill and high" and suspected it could be related to an unknown food being laced with cannabis. Douglas Postma told deputies he would prosecute anyone responsible for lacing his food and making him ill.

Deputy Payette spoke to Jeffrey Belmonte who said he did not feel well, adding he felt "high/stoned." Jeffrey Belmonte was in a rush to see family at South Seminole Hospital and was riding with Douglas Postma so he wasn't able to give a sworn statement. Jeffrey Belmonte said he would prosecute anyone involved in lacing the food with whatever the unknown substance was determined to be.

On February 20, 2022, your Affiant and Detective Sergeant Jarritt Negri conducted interviews with some of the guests at the wedding and reception that had become ill. Your Affiant and Detective Sergeant Jarritt Negri interviewed Douglas Postma at an AirBNB the family was staying at located at 309 White Oaks Drive, Altamonte Springs, Florida.

Douglas Postma stated that he was in town from Michigan to attend the wedding of his Nephew Andrew Svoboda. The wedding and reception had taken place at The Springs Clubhouse, 400 Woodbridge Road, Longwood, Florida on February 19, 2022. He arrived at the wedding at approximately 1630 hours with family members. He stated that he had drank about 3 glasses of a white wine. He also ate two meatballs, the Caesar salad, tortellini, and the bread with an olive oil and herb dip. After eating, Douglas Postma stated that he felt tingly, his heart started to race, and was having crazy thoughts. He stated that he had used marijuana many years ago, but this felt different to him.

Douglas Postma stated that he texted the groom Andrew Svoboda about what had happened. Andrew Svoboda told that he didn't know what had happened and that he would look into it. Douglas Postma stated that his wife Nancy Postma had a worse reaction and was transported to South Seminole Hospital in Longwood, Florida. According to Douglas Postma, Nancy Postma had tested positive for THC while at the hospital, it should be noted that your Affiant later obtained the medical records pertaining to Nancy Postma from South Seminole hospital and the urine test results were positive for cannabis.

Douglas Postma stated that Nancy Postma still wasn't feeling good and wasn't available to speak with law enforcement at the time.

Your Affiant and Detective Sergeant Jarritt Negri interviewed Jeffery Belmonte who stated that he was in town from Michigan to attend the wedding of his wife's cousin Andrew Svoboda. The wedding and reception had taken place at The Springs Clubhouse, 400 Woodbridge Road, Longwood, Florida on February 19, 2022.

Prior to going to the wedding, Jeffrey Belmonte said he had one Coors Light beer around 1300 hours prior to going to the wedding. Jeffery Belmonte stated that he had drank 1/2 glass of a red blend wine, a beer, and lemonade. He also ate three meatballs, the Caesar salad, and the bread with an olive oil and herb dip. Jeffery Belmonte stated that cannabis could have been in the Olive Oil and herb dip that he had eaten. He also stated that the serving staff mentioned that the oil was serving slowly. After eating, around 2030 hours, he stated that he felt weird, tingly, fidgety, and had extreme dry mouth. Jeffery Belmonte stated that he felt stoned.

Jeffery Belmonte stated that he went to speak with the best man, Matthew Svoboda to find out what was going on. He told Matthew Svoboda that he felt like he had been drugged. Jeffery Belmonte stated that Matthew Svoboda works for DOJ and the family would naturally go to him with concerns. When he went to talk with Matthew Svoboda, he was incoherent and could not answer a question.

Jeffery Belmonte stated that he spoke with Andrew Svoboda at the wedding. He asked him what he put in the food. Andrew Svoboda stated, "let me check what`s going on" then walked away and never obtained a response.

Jeffery Belmonte stated that he went to South Seminole Hospital for treatment and he tested positive for THC. Your Affiant later obtained the medical records pertaining to Jeffrey Belmonte from South Seminole Hospital and the urine test results were positive for cannabis. Jeffery Belmonte stated that he was so drugged that he was having difficulty operating his cellphone to order an Uber.

Your Affiant and Detective Sergeant Jarritt Negri interviewed Jennifer Belmonte stated that she was in town from Michigan to attend the wedding of her cousin Andrew Svoboda. The wedding and reception had taken place at The Springs Clubhouse, 400 Woodbridge Road, Longwood, Florida on February 19, 2022.

Jennifer Belmonte stated that while at the wedding and reception, that she had one (1) glass of red wine. She said she ate the Caesar salad, tortellini, and the bread with an olive oil and herb dip. Jennifer Belmonte said her sister, Melissa Stout told her that she wasn`t feeling well and that she felt dizzy and nauseas. Melissa Stout told Jennifer Belmonte that she thought it was the alcohol. Jennifer Belmonte stated that, Melissa Stout didn't have more then she drank. They walked Melissa Stout outside and she started to vomit.

Jennifer Belmonte and her mother Nancy Postma went back inside the clubhouse to the kitchen and asked for a glass of water. The staff stated that they didn't have any water but asked if it was her stomach. Jennifer Belmonte stated that it was her stomach. One of the kitchen staff, commented" well there's cannabis in the food." Jennifer Belmont stated that it was a black female, but not **Joycelyn Montrinice Bryant** who was the caterer of the reception. Jennifer Belmonte did not require medical treatment and did not have a urine test. Jennifer Belmonte later informed your Affiant that she would prosecute anyone involved in tampering with the food

Your Affiant and Detective Sergeant Jarritt Negri interviewed Melissa Stout who stated that she was in town from Michigan to attend the wedding of her cousin Andrew Svoboda. The wedding and reception had taken place at The Springs Clubhouse, 400 Woodbridge Rd, Longwood, Florida on February 19, 2022.

Melissa Stout stated that she had no alcoholic beverages before the wedding. Melissa Stout stated approximately three weeks ago she consumed marijuana in an edible form while in Michigan. At the wedding, Melissa Stout stated that she had a glass of Champaign and a beer. According to Melissa Stout she felt the effects of the alcohol and started to consume some of the bread with the oil dip. She also had some Caesar Salad and a pasta with white sauce. Not long after eating the food, Melissa Stout stated that she felt dizzy and spinning. After eating the food, she felt much worse. Melissa Stout stated that she then walked away and started to vomit.

Melissa Stout stated that she exchanged text with Andrew Svoboda who stated he was going to try and figure out what happened. Melissa Stout stated that she didn't notice anyone else getting sick as she was on her hands and knees throwing up. She stated that she did not go to the hospital. Melissa Stout later told your Affiant that she would prosecute anyone involved in tampering with the food.

Your Affiant and Detective Sergeant Jarritt Negri interviewed Jared Stout who stated that he was in town from Michigan to attend the wedding of his wife's cousin, Andrew Svoboda. The wedding and reception had taken place at The Springs Clubhouse, 400 Woodbridge Road, Longwood, Florida on February 19, 2022. He arrived at the wedding at approximately 1630 hours.

Jared Stout said that while in Michigan and prior to travelling to Florida, he consumed some gummies that contained marijuana. He stated that on the day of the wedding, he drank a glass of champagne, some beer, and half a glass of wine. Jared Stout stated that the amount of alcohol that he consumed would not have affected him to the point he was feeling that night. He said that while at the wedding and reception, he ate one meatball, the Caesar salad, baked ziti, and the bread with an olive oil and herb dip. After eating, he stated that he was "shocked that his beer buzz hadn`t wore off." He was asked how he was feeling, he stated that he "knew he was high."

Jared Stout said that he didn't see Andrew Svoboda, after everyone was getting sick. He stated that he did not seek treatment from the paramedics. He later told your Affiant that he would prosecute anyone involved with tampering with the food he had eaten.

On February 22, 2022, your Affiant learned that a guest at the wedding, Miranda Cady, had become ill from the cannabis that was placed in the food at the reception. Your Affiant contacted Miranda Cady and she agreed to meet to discuss the incident. Your Affiant met with Miranda Cady and obtained a sworn statement regarding the incident.

Miranda Cady said she had known Danya Shea Svoboda for a couple of years and had met her through friends. She stated that she had met Danya Shea Svoboda at events she had attended with friends and had last been with her at an event where they had wine with a group of friends. She said that the two had never hung out together in the past. Your Affiant asked if she had ever used drugs with Danya Shea Svoboda and she stated that she had never used drugs with her.

Miranda Cady said that she had been invited to the wedding by Danya Shea Svoboda via text message. She said there had been a social media type invite sent but she hadn`t responded to it, so Danya Shea Svoboda texted her directly inviting her.

Miranda Cady said on the day of the wedding she went to the wedding alone but later met friends who had also been invited. She stated she had not been drinking prior to the wedding but once there, a Champaign wall had been set up and she drank one glass that contained approximately 6-7 ounces of Champaign. She said after the wedding, the reception began and she said she had two glasses of wine that was available to the guests.

Miranda Cady said that hors d`oeuvres were served prior the dinner which she described as an Italian baguette along with olive oil. She said that the catering company placed all the food on the table for the guests including the bread. Your Affiant asked Miranda Cady how many people attended the wedding and she said there were probably between 60-70 attendees. Miranda Cady said the caterer, later identified as "Joycelyn" was known to her as they both had attended a company event that Danya Shea Svoboda had hosted earlier this year. Miranda Cady looked at her calendar and said she believes the event was on or about January 15, 2022. It should be noted that "Joycelyn" is known to your Affiant as **Joycelyn Montrinice Bryant**. She went on to say that **Joycelyn Montrinice Bryant** was in charge of the catering, and she saw her serving and putting food out for guests. Miranda Cady said she saw **Joycelyn Montrinice Bryant** holding a large punch with two hands. She said **Joycelyn Montrinice Bryant** was reaching into the punch bowl and removing a green substance and placing it into small dishes prior to the olive oil being added to the dish. Miranda Cady described the substance as being green and she could detect a strong odor of marijuana. She described the substance as green and fuzzy looking similar to the herbs Carrabba's uses but there was no vinegar or balsamic glaze in it. Miranda Cady said that she had seen and used marijuana when she was approximately 20 years old, but this looked different but smelled like marijuana. Your Affiant showed her a picture of marijuana buds and she said what she saw **Joycelyn Montrinice Bryant** putting in the dishes looked different but smelled like marijuana. You Affiant showed Miranda Cady a picture of marijuana crumbles and she said the crumbles of the marijuana in the picture she was shown looked more like what she had seen **Joycelyn Montrinice Bryant** handling. It should be noted what Miranda Cady was referring to what is commonly referred to as marijuana "shake" which is the small scraps that fall off of larger amounts of marijuana.

Miranda Cady said the marijuana could have been mixed with the herbs but at the time she didn't know. She said she asked **Joycelyn Montrinice Bryant** if there was marijuana in the food and **Joycelyn Montrinice Bryant** giggled and shook her head yes. Miranda Cady asked if this was for real, and **Joycelyn Montrinice Bryant** said "yes." Miranda Cady said this occurred prior to her eating any of the bread or oil. She said that if she had believed that there had been marijuana in the food, she would not have eaten it. Miranda Cady said that at that point she had not eaten any other food at the wedding and nothing, but the bread and oil were being served so she ate some of the bread with the oil. She further described the oil dish as being 6-7 inches long containing 3-4 ounces of olive oil and a tablespoon of the green substance. She said once the oil was placed into the dish with the green substance, she could no longer smell the marijuana. She said it didn't taste like marijuana and she could taste black pepper in the mixture. She stated it may have looked like Italian herbs. Your Affiant asked if she could be specific about the amount of bread she ate and she said she ate two pieces of bread with the oil. After eating the bread and oil, Cady said she felt stoned.

Miranda Cady told your Affiant that after realizing she was stoned, she went to the dance floor and spoke to Danya Shea Svoboda and asked if she had put marijuana in the olive oil and Danya Shea Glenny said "yes" and acted like Miranda Cady should be excited as if she were given a gift. Miranda Cady said Danya Shea Svoboda told her she had put the marijuana in the oil, smiled and shook her head yes and acted excited

Miranda Cady said that on the night of the incident, she had never felt like she did after using marijuana when she was younger. She said she felt like her heart was going to stop so she went to her car and went to sleep. Miranda Cady said she was "terrified" so she sent a text to herself in case she died in her car so that someone would know what happened to her.

Miranda Cady mentioned that she was supposed to go to Lake Eola after the reception but was unable to do so do to being stoned and sick.

Miranda Cady said she did not eat any other food at the reception before she became ill. She said her friend Darren Warren uses marijuana recreationally and told her that everyone was high. Miranda Cady said that the next day, Darren Warren had sent her a text telling her that the marijuana had hit him hard. Your Affiant asked Miranda Cady if she remembered who was sitting with her and she said Darren Warren, Puja Madan, Amanda Lewis, Jason Millhouse, Jenny Killingsworth, Melissa and Tryan Kock, Diane Court and Sura Al-Naimi. Miranda Cady said that based on the group text that Sunday, all were affected by the marijuana in the food. Miranda Cady said that she understood that three to five people went to the hospital after the incident. She was angry, but scared to go to the doctor as nothing like this has ever happened to her before. Miranda Cady said that she felt violated by the incident and didn't want to partake in eating the marijuana in the food.

At the conclusion of the interview, Miranda Cady said she would prosecute anyone involved in placing the marijuana in the food.

Miranda Cady subsequently provided your Affiant with a copy of her drug test she took on February 23, 2022 at Any Lab Test Now, 501 North Orlando Avenue, Suite 151 Winter Park, Florida. The urine test showed positive results for marijuana in her system.

On February 23, 2022, your Affiant and Detective Sergeant Jarritt Negri interviewed Rachel Penn who said she lives in the Springs and attended the wedding of her neighbors, Andrew Svoboda and Danya Shea Svoboda. The wedding and reception had taken place at The Springs Clubhouse, 400 Woodbridge Road, Longwood, Florida on February 19, 2022. Rachel Penn stated that she has known the Svoboda's for approximately a year.

She stated that she had no alcoholic beverages before the wedding and later had two glasses of Champaign. She stated that the catering staff brought around the meatballs and she consumed one of them. She also had some Caesar Salad, the bread with a dish of herbs and oil, and the baked ziti. Approximately 30-45 minutes after eating the bread, she said that she "felt weird and felt buzzed." Rachel Penn said she had some red wine from an unopened bottle at the reception and said the way she felt was not normal for the amount of alcohol she consumed.

Rachel Penn stated that around 2030-2100 hours, the wedding stopped. The band stopped playing and she saw bright lights. She said Danya Shea Svoboda's son, Maliki Glenny was walking oddly around and appeared to be under the influence. She said she observed Andrew Svoboda leave with the younger daughter, Lyric Glenny, but Andrew Svoboda returned a short time later.

Rachael Penn stated that the security guard, later identified as Joe Monteleone approached her and asked if she was ok. Joe Monteleone mentioned that other guests weren't feeling well and believe that they were being drugged. At that moment Rachael Penn stated that she realized that she had been drugged. realizing that after not drinking for a bit, the feelings were still getting more and more intense and her husband took her home. After a short time, they decide to call the paramedics who responded and told her to sleep it off.

The next morning Racheal Penn said she was still heavily drugged and wanted to know what she was on. Rachael Penn stated that she then went to South Seminole Hospital where she tested positive for THC. Your Affiant later obtained the medical records which confirmed the presence of cannabis in her urine.

While sitting in the hospital, Rachael Penn texted Danya Shea Svoboda. She asked Danya Shea Svoboda, what is happening, what was I given? Danya Shea Svoboda replied, are you sick. Then later texted, "Uggg, we have no idea, let us know if you need help with anything."

On Monday February 21, 2022, Danya Shea Svoboda called Rachael Penn. She told Rachael Penn that she was facing felony charges and was really sorry, but she had retained an attorney, and couldn't talk about what happened.

According to Rachael Penn, there was never an announcement made that any of the food contained marijuana. When asked about prior drug use, Rachel Penn stated that she had an edible approximately 2 years ago. Rachel Penn stated she would prosecute anyone involved in the tampering of the food she had eaten.

On February 23, 2022, your Affiant and Detective Sergeant Negri along with Crime Scene Supervisor Christine Craig and Crime Scene Analyst Eric Brothers went to 112 Bridgeway Circle Longwood, Florida. This address is in the Springs near the location where the wedding and reception had taken place. The resident, Candice Baumann had contacted your Affiant and said on the evening of February 19, 2022, her security camera had recorded what appeared to be one of the catering staff dumping garbage bags in the grass in front of her house. She made the video available and your Affiant watched the video and saw the following. At approximately 2205 hours, a small blue passenger vehicle pulled up by her driveway and a white female dressed in dark pants, a dark tank top exited the driver's side of the vehicle and walked to the passenger's front door. The unidentified female removed several plastic bags from the vehicle and dumped them in the yard south of the southern most edge of the driveway. The unidentified white female scattered the contents of the bags around the yard of the residence. The unidentified female appeared to be in a hurry to dump the contents of the bags in the yard. The unidentified female closed the passenger's front door then moved to the rear of the vehicle where she opened the back hatch and removed what appeared to be a white colored cloth, possibly a catering shirt and wipes her hands before continuing back to the driver's door where she enters the vehicle and departs the area in a hurry at 2207 hours.

Crimes Scene analyst Eric Brothers collected several items of food from the plastic bags that had been thrown in the yard by the unidentified white female. It should be noted that the resident had cleaned up the dumped garbage the morning of February 20, 2022 but had saved it in the garage when she learned of the incident at the wedding reception. Crime Scene Analyst Eric Brothers collected a piece of bread, with some green leafy material and what was described as a lasagna sample from the bags discarded by the unknown white female. These items along with the food items Deputy Donald Schwarzman collected and placed into evidence and later sent to ACS Laboratory in Sun City Center, Florida for testing. ACS Laboratory tested the items and found positive results for THC in the lasagna collected by Deputy Donald Schwarzman on February 19, 2022 and a piece of bread collected by Crime Scene Analyst Eric Brothers on February 23, 2022.

On March 24, 2022, your Affiant conducted a video interview of Nancy Postma who was in Michigan at the time of the interview. Nancy Postma said she and her family had traveled to Florida for the wedding of her nephew Andrew Svoboda and his now wife Danya Shea Svoboda.

On the March 19, 2022, the day of the wedding Nancy Postma said she had not consumed any alcohol prior to the wedding and the reception that followed. She said she had eaten breakfast that morning but nothing at the wedding. She said once at the reception she drank a glass of Champaign that she believes to have contained approximately three (3) ounces of Champaign. She said the glass of Champaign came from a Champaign wall at the reception. She said she ate one piece of bread, Cesar salad and a white pasta dish. Nancy Postma told your Affiant that she had smelled marijuana when she was in high school but didn't detect that smell in the food.

Nancy Postma said that at the reception she sat with her family and the caterer, **Joycelyn Montrinice Bryant** sat at the same table approximately three (3) feet away from her. She said **Joycelyn Montrinice Bryant** had told those at the table that she was the caterer and she had prepared the food.

Nancy Postma said her daughter, Melissa Stout had become very sick at the reception. Nancy Postma said she and her daughter, Jennifer Belmonte went to kitchen to get Melissa Stout some water. The kitchen staff were told people were sick and needed water. A server told them it was probably the cannabis. She said another server said "I know what to do, cut a lime in half and have them chew on it. Nancy Postma said she believes that both servers were African American but doesn't know who they area. Nancy Postma said she turned to the girl who told them about the cannabis in the foods and she told them they thought it was common knowledge that cannabis was in the food. Nancy Postma said that after eating she became ill but didn't have much of a memory of the event. Your Affiant asked Nancy Postma about her experiences when drinking and she said she has never been "drunk" but understands the feelings. She said she didn't have the same feeling she has when she is drinking. She said she felt like she had no control of her mind and body. She said she felt numb, helpless and her mind was playing strange things in her head. She described seeing the "side of a house."

Nancy Postma said that while at the hospital, she felt very paranoid and believed her husband, Douglas Postma wasn't telling her the truth about other family members. She said she thought her son-in-law Jared Stout had died and her family hadn't told her. She said while in the emergency room she became loud and unruly and had to be given something to calm her down.

Nancy Postma told your Affiant that she didn't know how she got to the hospital but later learned she was transported by ambulance. She said tests at the hospital showed positive results for THC. Your Affiant later obtained the hospital urine test results which were positive for cannabis.

Nancy Postma told your Affiant that she has never used marijuana and she never gave anyone permission to give her marijuana.

Nancy Postma told your Affiant that she would prosecute anyone involved with the tampering of the food she ate at the reception.

Joycelyn Montrinice Bryant did, with reckless disregard for the risk that another person(s) would be placed in danger of death or bodily injury, when she tampered with, or conspired or attempted to tamper with, any consumer product, herein being food or drink for humans, or any article intended for use as a component of a food or dink for humans, when she laced the food she served, as the caterer, for the wedding of Andrew Svoboda and his now wife Danya Shea Svoboda, with cannabis unbeknownst to the attendees, many of whom became very ill and required medical attention after ingesting these tampered food items. Thus, violating the Florida Anti-Tampering Act 501.001(2)(a) Florida Statutes.

Joycelyn Montrinice Bryant did, deliver cannabis (an enumerated controlled substance under 893.03(1)(c)), when she laced the food she served, as the caterer, for the wedding of Andrew Svoboda and his now wife Danya Shea Svoboda, with cannabis unbeknownst to the attendees, many of whom became very ill and required medical attention after ingesting these tampered food items. Thus, delivering the controlled substance of cannabis and violating 893.13(1)(a)2 Florida Statutes.

Joycelyn Montrinice Bryant did, through culpable negligence inflict personal injury upon the above identified wedding attendees, when she laced the food she served, as the caterer, for the wedding of Andrew Svoboda and his now wife Danya Shea Svoboda, with cannabis unbeknownst to the attendees, many of whom became very ill and required medical attention after ingesting these tampered food items. Thus, committing a violation of 784.05(2) Florida Statutes.

Based on the above facts, statements and physical evidence provided, your Affiant has probable cause to believe and does believe that **Joycelyn Montrinice Bryant**, has committed a violation of the laws of the State of Florida, to wit: **FLORIDA ANTI-TAMPERING ACT** contrary to 501.001(2)(a) Florida Statutes, **DELIVERY OF MARIJUANA** contrary to 893.13(1)(a)(2) Florida Statutes and **CULPABLE NEGLIGENCE** contrary to 784.05(2), Florida Statutes.

WHEREAS, your Affiant makes this affidavit and prays the issuance of an Arrest Warrant with authority to enter any premises to effect said arrest, in due form for the arrest of **Joycelyn Montrinice Bryant**, for the violation of the laws of the State of Florida, to wit **FLORIDA ANTI-TAMPERING ACT** contrary to 501.001 Florida Statutes, **DELIVERY OF MARIJUANA** contrary to 893.13(1)(a)(2) Florida Statutes and **CULPABLE NEGLIGENCE** contrary to 784.05(1), Florida Statutes.
