INTRODUCTION

- 1. Plaintiff Mounir Nafkha (Mr. Nafkha) brings this action against Defendant U.S. Immigration and Customs Enforcement (ICE) under the Freedom of Information Act (FOIA), 5 U.S.C. § 552 *et seq.*, to compel the disclosure of records related to Mr. Nafkha while he was detained at Krome North, an immigration detention center in Miami, Florida. The FOIA requests, which Mr. Nafkha filed on February 11, 2022, and which ICE lodged as received on March 3, 2022, have been pending for over 2 months. The statutory deadline for the agency to respond to Mr. Nafkha's FOIA requests has expired, yet ICE has failed to make a determination on the requests in violation of FOIA.
- 2. Mr. Nafkha filed the FOIA requests as a result of serious injuries he suffered at the hands of federal immigration officers on January 22, 2022, for which he did not receive adequate medical treatment, and which subsequently resulted in his hospitalization.

3. Mr. Nafkha requires the requested records to support his claim for damages under the Federal Tort Claims Act for the injuries he suffered at the hands of federal immigration officers.

JURISDICTION AND VENUE

- 4. This Court has jurisdiction under 5 U.S.C. § 552, *et seq.* (FOIA statute), 28 U.S.C. § 1331 (federal question), and 28 U.S.C. §§ 2201–2202 (Declaratory Judgment Act).
- 5. Venue is proper under 5 U.S.C. § 552(a)(4)(B) and 28 U.S.C. § 1391(e)(1) because this is a civil action in which Defendant is a federal agency headquartered in the District of Columbia and no real property is involved.
- 6. Because Defendant has failed to comply with the applicable statutory time limitations in responding to Mr. Nafkha's FOIA requests, Mr. Nafkha is deemed to have exhausted his administrative remedies in connection with the requests. 5 U.S.C. § 552(a)(6)(C)(i).

PARTIES

- 7. Plaintiff Mounir Nafkha is a citizen of Morocco who resides in Brookhaven, Georgia. Mr. Nafkha currently has FOIA requests filed with ICE that have been pending beyond the 20- or 30-business days permitted by statute.
- 8. Defendant U.S. Immigration and Customs Enforcement is a component agency of the Department of Homeland Security (DHS) and is an agency within the meaning of 5 U.S.C. § 552(f)(1). Among other duties, ICE is responsible for operating federal immigration detention facilities, including Krome North SPC, and maintaining a safe environment for individuals in its custody. ICE has in its possession, custody, and control the records Mr. Nafkha seeks.

LEGAL BACKGROUND

- 9. FOIA requires each agency, upon a request for records: (a) to conduct a search reasonably calculated to uncover all responsive documents, (b) to make the records available in the form or format requested if they are readily reproducible in that format, and (c) to promptly make available responsive records. 5 U.S.C. § 552(a)(3)(A)-(C).
- 10. If a FOIA request "was misdirected within DHS, the receiving component's FOIA office shall route the request to the FOIA office of the proper component(s)." 6 C.F.R. § 5.4(c).
- 11. FOIA also requires the agency to make a determination of whether it will comply with the request within 20 business days. 5 U.S.C. § 552(a)(6)(A)(i); 6 C.F.R. § 5.6(c).
- 12. If the agency finds that unusual circumstances apply, it must request, by written notice, no more than an additional 10 business days to issue its determination. 5 U.S.C. § 552(a)(6)(B)(i).
- 13. "In determining which records are responsive to a request, [an agency] ordinarily will include only records in its possession as of the date that it begins its search. If any other date is used, the component shall inform the requester of that date." 6 C.F.R. § 5.4(a).
- 14. If an agency fails to comply with the time periods set forth in the statute, the requester is "deemed to have exhausted his administrative remedies" and may seek judicial review. 5 U.S.C. § 552(a)(6)(C)(i). The agency will not be permitted to assess search fees if it fails to comply with the applicable time limits. 5 U.S.C. § 552(a)(4)(A)(viii)(I); 6 C.F.R. § 5.11(d)(2).

FACTUAL ALLEGATIONS

Mistreatment of Mr. Nafkha at Krome North

15. The incident giving rise to the FOIA requests at issue in this case occurred on the

afternoon of January 22, 2022. Mr. Nafkha had just begun recreation time outside. Immigration officer M. Roque told Mr. Nafkha that he only had 30 minutes of recreation time. Knowing this was incorrect, and that he was entitled to an hour of recreation time, Mr. Nafkha responded that he was entitled to an hour of recreation time. He then proceeded to a call box to call the desk officers so that they could summon a supervisory officer. At that point, Roque attacked him. The attack consisted of punches to his face, grabbing the back of his neck, placing him in a choke hold, and shoving him against a fence. On information and belief, the incident was captured on video.

- 16. After the incident, Mr. Nafkha was taken back to his cell where officers left him lying on his back unable to move. Later that day, a nurse and several officers came to his cell. One officer stated that they needed to call an ambulance. The nurse refused, stating that the doctors said just to give him Tylenol. On information and belief, this incident, or part of it, was captured on video.
- 17. Mr. Nafkha remained in his cell in pain for approximately two days (Saturday afternoon through Monday morning). On the morning of Monday, January 24, 2022, he was transported to Kendall Regional Medical Center in Miami, Florida.
- 18. Mr. Nafkha remained at Kendall Regional Medical Center for two days, until he was discharged on Wednesday, January 26, 2022.
- 19. Mr. Nafkha intends to seek recovery for the assault, battery, and other tortious conduct he suffered at the hands of federal officers under the Federal Tort Claims Act. *See* 28 U.S.C. §§ 1346(b), 2671 *et seq.*; 28 C.F.R. §§ 14.1-14.11.

ICE FOIA Requests

20. On February 11, 2022, through counsel, Mr. Nafkha submitted two FOIA requests via electronic mail to ICE at ice-foia@ice.dhs.gov as well as to Bryan Hudson and Jennifer

Whitsitt, two ICE attorneys with ICE's Office of the Principal Legal Advisor with whom counsel had been communicating about the incident. Exhibit A.

21. The first request seeks:

All video of the January 22, 2022 assault by Officer Roque against Mounir Nafkha in the Krome North recreation yard.

Exhibit B. Mr. Nafkha indicated that expedited processing of the request was warranted by ticking the boxes indicating the request involved "[c]ircumstances in which the lack of expedited treatment could reasonably be expected to pose an imminent threat to the life or physical safety of the individual," "[t]he loss of substantial due process rights," and "[a] matter of widespread and exceptional media interest in which there exists [sic] possible questions about the government's integrity which affects [sic] public confidence." *Id*.

22. The second request seeks:

- All video, pictures, documentary, or written documentation of the January 22, 2022 assault and its aftermath (including how Mr. Nafkha was taken to his room and any aid given to him)
- All video footage of Mr. Nafkha in his cell (Cell #1282 the MHU) from January 22, 2022 to January 25, 2022, including but not limited to: footage from the camera installed in his cell, to handheld camera footage used by officers
- All video taken of Mr. Nafkha on a camcorder in any location during the time period of January 22 to January 25, 2022
- All video, pictures, documentary, or written documentation of the response to the assault by responding officers
- All video, pictures, documentary, written, or medical reports about Mr. Nafkha's injuries
- All video, pictures, documentary, written, or medical reports about Officer Roque's injuries
- All complaints or grievances filed against or referencing Officer Roque (regardless of the source)

- All contents of Officer Roque's personnel file, including any disciplinary actions
- All evidence (including video, pictures, documentary, or written documentation)
 related to other uses of force by Officer Roque, including any internal reviews and
 conclusions
- All evidence related to the prior incident where Officer Roque had to be physically detained by a supervisor for threatening Mr. Nafkha
- All of Mr. Nafkha's grievances filed against Officer Roque for the January 22, 2022 incident and any prior incidents
- All communications, documentation, or reports regarding why Officer Roque was allowed to have continued contact with Mr. Nafkha
- All communications, documentation, or reports regarding why Mr. Nafkha received a notice of possible administrative action (or a charge of administrative action) for assaulting an officer
- All communications, documentation, or reports regarding ICE's decision to refer the incident to DHS OPR and DHS OIG
- All duty logs for January 22, 2022
- All relevant internal training on use of force
- All relevant internal procedures on use of force
- All training logs and/[sic] certifications for Officer Roque
- All video footage from all cameras in Cell #1270 from December 7, 2021 to January 1, 2022

Exhibit C. Mr. Nafkha indicated that expedited processing of the request was warranted by ticking the boxes indicating the request involved "[c]ircumstances in which the lack of expedited treatment could reasonably be expected to pose an imminent threat to the life or physical safety of the individual," "[t]he loss of substantial due process rights," and "[a] matter of widespread and exceptional media interest in which there exists possible questions about the government's integrity which affects public confidence." *Id*.

23. On March 2, 2022, Mr. Nafkha's counsel sent a follow up email to Attorneys

Hudson and Whitsitt about the two items they previously discussed, one of which was "the status of [the] FOIA requests." Exhibit A. Attorneys Hudson and Whitsitt did not respond.

- 24. On March 8, 2022, counsel sent another follow up email. *Id*.
- 25. Two days later, on March 10, 2022, Attorney Whitsitt responded. She confirmed that the FOIA requests were "currently under review," provided tracking numbers for both requests, and indicated that they "were unable to provide a timeline for their completion" because another office processed FOIA requests. *Id*.
- 26. According to ICE's online web portal, which allows requesters to check the status of a pending FOIA request, Mr. Nafkha's requests (FOIA numbers 2022-ICFO-08656 and 2022-ICFO-08657) were received by ICE on March 3, 2022. Exhibit D.
- 27. On March 29, 2022, ICE issued an acknowledgment letter for the first FOIA request for video of the attack and granted Mr. Nafkha's request for expedited processing. Exhibit E. In that letter, ICE refers to the request as dated February 11, 2022, and indicates that it was received by the ICE FOIA office on March 3, 2022. *Id*.
- 28. Also on March 29, 2022, ICE emailed an acknowledgment of the second FOIA request for all records related to the attack and stated that this second request "has been administratively closed" because it "is a duplicate of your previous request." Exhibit F. The email refers to the request as dated February 11, 2022, and indicates it was received by the ICE FOIA office on March 3, 2022. *Id*.
- 29. Counsel for Mr. Nafhka responded to that email later that same day and indicated that two separate FOIA requests had been submitted and that they "were not duplicative of each other." Exhibit F. Accordingly, counsel requested the agency reinstate the request for all records related to the attack for processing. *Id*.

30. As of the date of this complaint, after the expiration of the statutory time period for a response, ICE has failed to notify Mr. Nafkha (a) whether it has reinstated the FOIA request for all records related to the attack for processing; (b) of any determination regarding the scope of any responsive records ICE intends to produce or withhold; and (c) whether ICE will produce the requested records or demonstrate that the requested records are lawfully exempt from production.

CAUSES OF ACTION

COUNT ONE

Violation of FOIA, 5 U.S.C. § 552 et seq.
Failure to Conduct an Adequate Search for Responsive Records

- 31. Mr. Nafkha incorporates the allegations in the paragraphs above as though fully set forth here.
- 32. ICE is obligated under 5 U.S.C. § 552(a)(3)(C) to conduct a reasonable search for records responsive to Mr. Nafkha's FOIA requests.
- 33. Mr. Nafkha has a legal right to obtain such records, and no legal basis exists for ICE's failure to search for them.
- 34. At a minimum, ICE is obligated to search for records "in its possession as of the date that it begins its search." 6 C.F.R. § 5.4(a).
- 35. Defendant ICE's failure to conduct a reasonable search for records responsive to Mr. Nafkha's FOIA requests violates, at a minimum, 5 U.S.C. § 552(a)(3)(C), as well as the regulations promulgated thereunder.

<u>COUNT TWO</u> Violation of FOIA, 5 U.S.C. § 552 *et seq*.

Failure to Disclose Responsive Records

36. Mr. Nafkha incorporates the allegations in the paragraphs above as though fully set forth here.

- 37. ICE is obligated under 5 U.S.C. § 552(a)(3)(A) to promptly produce records responsive to Mr. Nafkha's FOIA requests. ICE has failed to produce any records responsive to Mr. Nafkha's FOIA requests.
- 38. Mr. Nafkha has a legal right to obtain such records, and no legal basis exists for ICE's failure to disclose them.
- 39. Defendant ICE's failure to disclose all responsive records violates, at a minimum, 5 U.S.C. § 552(a)(3)(A), as well as the regulations promulgated thereunder.

COUNT THREE Violation of FOIA, 5 U.S.C. § 552 et seq. Failure to Timely Respond

- 40. Mr. Nafkha incorporates the allegations in the paragraphs above as though fully set forth here.
- 41. ICE is obligated under 5 U.S.C. § 552(a)(6)(A)(i) to promptly make a determination about whether it will produce records responsive to Mr. Nafkha's FOIA requests within 20 business days of receipt or, if the agency invokes unusual circumstances through written notice, within 30 business days of receipt.
- 42. ICE has not made a determination on Mr. Nafkha's FOIA requests within the statutory time period under FOIA. According to ICE's own online FOIA tracker, Mr. Nafkha requested the records on February 11, 2022, and, therefore, ICE was required to produce the records within 20 business days, i.e., by March 14, 2022, or if ICE invoked the 10-business-day extension, within 30 business days, i.e., by March 28, 2022. ICE has failed to produce the requested records.
- 43. ICE's online FOIA tracker indicates that ICE did not lodge Mr. Nafkha's FOIA requests until March 3, 2022, which is contradicted by Mr. Nafkha's attorney's submission of the

FOIAs by email on February 11, 2022. Even assuming that March 3 is the correct receipt date, ICE was required to produce the records by March 31, 2022. ICE has failed to produce the requested records. Even if ICE invoked the 10-business day extension, ICE was required to produce the records by April 14, 2022. ICE has failed to produce the requested records.

- 44. Mr. Nafkha has a legal right to obtain such records, and no legal basis exists for ICE's failure to disclose them.
- 45. Defendant ICE's failure to disclose all responsive records within the statutory time period violates, at a minimum, 5 U.S.C. §§ 552(a)(3)(A) and (a)(6)(A) & (B), as well as the regulations promulgated thereunder.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff prays that this Court grant the following relief:

- (1) Assume jurisdiction over this action;
- (2) Declare that Defendant's failure to conduct a reasonable search for records responsive to Mr. Nafkha's FOIA requests violates the FOIA;
- (3) Declare that Defendant's failure to make determinations on Plaintiff's FOIA requests within the statutory time frame violates the FOIA and the regulations promulgated thereunder;
- (4) Declare that Defendant's failure to promptly produce records responsive to

 Plaintiff's requests violates FOIA and the regulations promulgated thereunder;
- (5) Order Defendant to expeditiously process and disclose all responsive, nonexempt records, and enjoin Defendant from improperly withholding records;
- (6) Award costs and reasonable attorney fees incurred under 5 U.S.C. § 552(a)(4)(E), and any other applicable law; and

(7) Grant such further relief as the Court deems just and proper.

Freedom of Information Act Request for Incident with Mounir Nafkha (A# 029 674 814)

Dear all:

I am a partner at the King & Spalding LLP law firm and am filing this request on behalf of my client, Mounir Nafkha. Mounir is also my brother-in-law, and my firm is representing him in his immigration proceedings.

We are asking for expedited processing for the attached FOIA request under 6 C.F.R. § 5.5. Because Mounir has been the subject of a violent beating by an Immigrations & Customs Enforcement ("ICE") officer, as well as retaliatory disciplinary proceedings for speaking out about that beating, we believe he is at increased risk at Krome. The retaliatory disciplinary proceeding has already deprived Mounir of "substantial due process rights." 6 C.F.R. § 5.5(e)(1)(i)(iii). Additionally, without the requested information to hold ICE officers accountable, we fear that there is an imminent threat to his physical safety. 6 C.F.R. § 5.5(e)(1)(i).

Mr. Nafkha is currently detained by ICE at Krome North Processing Center in Miami, Florida. He has been detained by ICE for over one year. He is on temporary "room and board" status at Krome, and but he remains in the custody of the Pike, Pennsylvania and Philadelphia, Pennsylvania ICE offices.

On January 22, 2022. Office Roque attacked Mounir, unprovoked. I understand the incident was captured on video.

Mounir relayed the following events to me: On January 22, he was escorted to his "recreation time" by Officer Roque. Mounir noted to me that there were some tensions between them due to a series of verbal exchanges that transpired they had about one month earlier. During that incident, a more senior officer had to restrain and remove Officer Roque from Mounir's cell.

The incident was captured on at least one camera, and the Krome officials informed us that they were "pulling the tape" for review. Mounir's injuries were also captured by photographs taken on two different occasions (one right after the incident and another at around 9:30 PM on the evening of January 22).

Officer Roque's unprovoked beatings are especially worrisome because of Mounir's fragile health. He was recently in the hospital with rhabdomyolysis. He was also diagnosed with spinal arthritis and a herniated disc. He has lost around 40 to 50 pounds because of a hunger strike. After Officer Roque's beating, he received only minimal medical care from ICE (essentially, just Tylenol and Ibuprofen) until he was sent to an outside hospital two days later.

On January 23, 2022, the Krome Assistant Field Office Director informed us that he was referring the matter to the Office of Professional Responsibility. Later that same day, however, ICE issued administrative charges against Mounir, claiming he was the aggressor in the assault. We believe these charges were issued as retaliation against him for reporting violations of his legal and constitutional rights. We also believe he was denied medical care in retaliation for complaints about the assault by Officer Roque.

This is a deeply disturbing matter to us. I have not seen the video of the incident, but Mounir has discussed it in detail with me. I have no reason to doubt him. I know him very well, and do not believe he would assault a corrections officer after everything he has been through. Therefore, I believe the above to be true and correct.

Obtaining these records is essential to ensuring that Mounir is not subjected to more retaliatory discipline or violent assaults. We look forward to your prompt response.

Because Mounir has been the subject of a violent beating by an Immigrations & Customs Enforcement ("ICE") officer, as well as retaliatory disciplinary proceedings for speaking out about that beating, we believe he is at increased risk at Krome. The retaliatory disciplinary proceeding has already deprived Mounir of "substantial due process rights." 6 C.F.R. § 5.5(e)(1)(i)(iii). Additionally, without the requested information to hold ICE officers accountable, we fear that there is an imminent threat to his physical safety. 6 C.F.R. § 5.5(e)(1)(i).

Mr. Nafkha is currently detained by ICE at Krome North Processing Center in Miami, Florida. He has been detained by ICE for over one year. He is on temporary "room and board" status at Krome, and but he remains in the custody of the Pike, Pennsylvania and Philadelphia, Pennsylvania ICE offices.

On January 22, 2022. Office Roque attacked Mounir, unprovoked. I understand the incident was captured on video.

Mounir relayed the following events to me: On January 22, he was escorted to his "recreation time" by Officer Roque.
